Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Teague Electric Construction, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of the Teague Electric Construction, Inc. 401(k) Profit Sharing Plan (the "Plan"), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of Teague Electric Construction, Inc. (the "Company"), who have met eligibility requirements as designed by the plan. The Plan is subject to the provisions of ERISA.

The Trustees are responsible for oversight of the Plan. The Investment Advisor determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees.

b. Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employees are eligible to make elective deferral contributions on the first day of the month after completing 60 days of service. Participants direct the investment of their contributions into various investment options offered by the Plan.

All newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company makes a discretionary matching contribution. For the year ended December 31, 2024, the Company elected to match 50% of the first 6% of base compensation that a participant contributes to the Plan. Effective July 1, 2024, employees are eligible for the company match on the first day of the month after completing 60 days of service. Prior to July 1, 2024, employees were eligible after completing a year of service and attaining 1,000 hours. During the year ended December 31, 2024, the Company made matching contributions of \$134,689. The Company may also make an annual discretionary profit-sharing contribution to the Plan in an amount, if any, determined solely by the Company. This Company contribution is made to all eligible employees of the Company who work a minimum of 1,000 hours in a plan year and remain employed by the company on the last day of the plan year. No profit-sharing contribution was made during the year ended December 31, 2024.

c. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their contributions plus the earnings thereon. Effective July 1, 2024, vesting in the Company's discretionary match and the earnings thereon, is based on years of continuous service and a participant is 100% vested after three years of credited service. Vesting in the Company's non-elective contributions is based on a 2-6 year graded schedule where the participants are 100% vested after six years of credited service.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

f. Payment of Benefits

On termination of service by: (1) death, (2) disability, or (3) retirement, a participant may receive a lump-sum amount equal to the vested interest in the participant's account. If the participant's vested benefit in the Plan does not exceed \$5,000, the participant's benefit may be distributed. Distributions after termination of employment for reasons other than death may be made under a continuous right of withdrawal in which the participant may withdraw amounts at such times as they shall elect. A participant is also entitled to receive a lump-sum distribution of his or her pretax employee contribution account after attaining age 59½ without terminating employment. Benefits are recorded when paid.

g. Forfeited Accounts

Forfeited balances are used to reduce future employer contributions and pay administrative expenses throughout the year.

g. Forfeited Accounts (Continued)

For the year ended December 31, 2024, forfeitures of \$12,474 were used to reduce matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,315 and \$250, respectively.

h. Investments

Participants may direct the investment of their contributions into various investment options offered by the Plan.

i. Administrative Expenses

The plan sponsor bears substantially all administrative costs of the Plan, including the costs of officers and employees who perform certain administrative functions. Administrative expenses that are paid by the Plan consist of fees charged by the Plan's custodians, investment advisor, and contract administrator.

2. Summary of Significant Accounting Policies

The following are the significant policies followed by the Plan:

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for benefits and the changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

c. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

e. Contributions Receivable and Allowance for Credit Losses

Contribution receivables are reduced by an estimate made for an allowance for credit losses. The Plan is exposed to credit losses resulting from the inability of the Company to make the required payments. The Plan establishes an allowance for these potential credit losses based on its review of historical loss statistics, current business conditions and macro-economic trends. The Plan applies credit loss estimates to the contribution receivables to determine expected credit losses. The allowance for credit losses is not significant at December 31, 2024 and 2023.

f. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

g. Income Taxes

The Plan's income tax filings are subject to examination by various tax authorities. The Plan's open examination periods are 2021 and forward.

h. Subsequent Events

Subsequent events have been evaluated up to October 14, 2025, the date these financial statements were available to be issued.

3. Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Collective investment trusts: Valued at the net asset value (NAV) of units of the collective investment trust. The NAV is based on the fair value of the underlying investments and is used as a practical expedient to estimate fair value.

4. Investment Contract with Insurance Company

The Key Guaranteed Portfolio Fund (“KGPF”) is a group annuity insurance contract issued by Empower Annuity Insurance Company of America (“Empower”) and is backed by the full faith and creditworthiness of the issuer. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed credit rates, less withdrawals, and fees. The KGPF is a traditional guaranteed investment contract (“GIC”) and deemed to be fully benefit-responsive. Since the KGPF is fully benefit-responsive, contract value is the relevant measurement. Contract value, as reported by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative fees. Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid with 90 days’ notice or contract value paid overtime. There are not any events that allow the issuer to terminate the contract, and which require the Plan to settle at an amount different than contract value paid either with 90 days’ notice or overtime. Interest is credited on contract balances using a single “portfolio rate” approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest credit rates are reviewed on a quarterly basis for resetting. The minimum credit rate under the contract is 0%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

5. Financial Data Certified by the Custodians

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments held at December 31, 2024 and 2023
- Notes receivable from participants at December 31, 2024 and 2023
- Net appreciation in fair value of investments for the year ended December 31, 2024
- Interest and dividends for the year ended December 31, 2024
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Plan uses a prototype plan document, which obtained its latest opinion letter on June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRS. The Plan itself has not received a determination letter from the IRS and the plan and related trust continue to be exempt. However, the Company and the plan administrators believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Exempt Party-in-Interest Transactions

Some plan investments are managed by Empower Capital Management, an affiliated entity of Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is a custodian as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.

9. Risks and Uncertainties

The Plan provides various investment options. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements.
