Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the AdHawk, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

Other Matter – Basis of Accounting

As described in Notes 1 and 6 to the financial statements, the Plan is terminating. During 2025, all assets were distributed out of the Plan. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

1. DESCRIPTION OF THE PLAN

The following description of the AdHawk, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established by AdHawk, Inc. (the Company) effective January 1, 2022. The Plan covered substantially all employees of the Company with the exception of residents of Puerto Rico and part-time/temporary/seasonal employees, as defined by the Plan. Prior to January 1, 2024, part-time, seasonal and temporary employees became eligible upon reaching 1,000 hours of service in the Plan year. Effective January 1, 2024, part-time/seasonal and temporary employees become eligible upon working 500 hours in each of the prior three consecutive years. Eligible participants, as defined by the Plan, could enter the Plan on the first day of the month following their employment date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended in March 2024 to retroactively amend the Plan as of January 1, 2022, including removing the special effective date for elective deferrals and matches, and clarifying that fringe benefits have never been included as compensation with respect to elective deferrals and Company match since the Plan's effective date.

Plan Termination

Effective December 2, 2024, in conjunction with the acquisition of the Company, the Company made the decision to terminate the Plan and began the process to distribute all assets to the respective participants (Note 6). All payrolls after December 2, 2024 and related deferrals were made to the new plan. All remaining Plan assets were distributed from the Plan during 2025.

Participant Contributions

Prior to the Plan termination, participants could elect to defer between 1% and 100% of eligible compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants could also make Roth elective contributions. Participants who have attained age 50 before the end of the Plan year could make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants were also permitted to make rollover contributions to the Plan.

Company Contributions

Prior to the Plan termination, the Company made safe harbor matching contributions to eligible participants on a per-payroll basis. Safe harbor matching contributions were equal to 100% of salary deferrals not to exceed 4% of compensation. The Company's safe harbor matching contributions totaled \$430,814 for the year ended December 31, 2024.

The Company could also make discretionary nonelective and discretionary matching contributions to the Plan. Additional discretionary matching contributions did not apply to elective deferrals exceeding 6% of the participants' compensation on an annual basis. Participants must have been employed on the last day of the Plan year in order to be eligible to receive discretionary nonelective and discretionary matching contributions. The Company did not make any discretionary nonelective or discretionary matching contributions for the year ended December 31, 2024.

1. DESCRIPTION OF THE PLAN – cont'd.

Participant Accounts

Each participant's account is participant-directed and was credited with participant contributions and Company contributions, in accordance with the investment options selected by the participant. Any earnings, losses, and administrative expenses are allocated to participant accounts based upon the balance in each account. The benefit to which a participant is entitled was the benefit that can be provided from the participant's account balance.

Notes Receivable from Participants

Prior to the Plan termination, Participants could borrow up to 50% of the value of their vested account balances within the Plan, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount was \$1,000 and a participant could not have more than one note outstanding at any time. Notes were collateralized by the participant's account balance. Note repayments were made through payroll deductions and bore interest at the Prime rate plus 1% at the time of loan issuance. Notes were to be repaid within five years.

Payment of Benefits

Upon termination of service, death, disability, retirement (age 65), or attainment of age 59 ½, a participant or his or her beneficiary, in the event of death, was entitled to a distribution of his or her account balance. If a participant's account balance upon termination was less than \$7,000 and no distribution election was made by the participant, the balance would be distributed without participant consent as a lump-sum payment to the participant. In-service hardship distributions and qualified reservist distributions were permitted if certain conditions were met. In-service withdrawals could be taken by a participant upon attainment of age 59 ½. Certain income tax penalties would apply to withdrawals or distributions prior to age 59 ½. Distributions are subject to the applicable provisions of the Plan agreement. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year end. As a result of the acquisition of the Company and the Plan termination effective December 2, 2024, participants were provided with the option to have their account balance rolled into another retirement plan or IRA or receive a lump sum distribution. All assets were distributed out of the Plan during 2025.

Vesting

Participants are immediately vested in their contributions, matching contributions, and additional discretionary contributions plus earnings thereon.

Plan Expenses

Expenses incurred in the administration of the Plan are paid with assets of the Plan, unless paid by the Company, at its discretion. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. For the year ended December 31, 2024, a portion of the expenses of the Plan were paid with Plan assets. The Plan paid direct expenses totaling \$41,235 during the year ended December 31, 2024. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in the fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As described in Notes 1 and 6, the Plan terminated effective December 2, 2024. The Plan's financial statements are presented using the liquidation basis of accounting as of and for the year ended December 31, 2024. The Plan's financial statements as of December 31, 2023 are presented using the ongoing basis of accounting. The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur in the near term and materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments, except for fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Fair Value Measurement

ASC 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Notes become due immediately upon termination of participant’s employment. Delinquent notes were treated as distributions based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Given that the Plan was terminated effective December 2, 2024, participants were unable to borrow new notes effective this date. All prior notes receivable were deemed distributed from the Plan during 2025.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through September 8, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure, except as disclosed in Notes 1 and 6.

3. INVESTMENTS

All investment information contained in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and interest and dividend income and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and was certified as complete and accurate by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (Empower), the Custodian and Trustee of the Plan.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has an investment in the Empower Investments Fixed Account - Series Class I, which is a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive guaranteed investment contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed semiannually for resetting. The contract can not be terminated by the issuer before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events could limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events included the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Despite the Plan termination described in Notes 1 and 6, the ability of the Plan and its participants has not been limited from transacting at contract value with the contract issue, nor has the ability of the Plan from transacting at contract value with its participants been limited.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in investments that are managed by Empower Retirement LLC, which is related to the Custodian and Trustee of the Plan. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

6. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective December 2, 2024, in conjunction with the acquisition of the Company, the Company terminated the Plan. Plan assets were fully liquidated during 2025.

7. INCOME TAX STATUS

The Plan is governed by a pre-approved plan sponsored by Empower Retirement LLC. The pre-approved plan received a favorable opinion letter dated November 14, 2022 from the Internal Revenue Service stating that the Plan and related trust were designed in accordance with the applicable sections of the Code. The Plan administrator believes that the Plan is designed and operates in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes* (ASC 740), prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and the Department of Labor; however, there are currently no audits in progress for any open periods in progress.

8. COMPANY CORRECTIVE CONTRIBUTIONS

During the year ended December 31, 2022, the Company inadvertently excluded certain compensation types from the definition of compensation, missed deferrals on the first five payroll periods during the year ended December 31, 2022, and incorrectly calculated the Company match for select employees during the year ended December 31, 2022. As a result, affected participants were not given the opportunity to defer in accordance with the terms of the Plan. In order to correct these operational errors, the Company was required to make qualified nonelective employer contributions (QNECs) to the affected employees in accordance with acceptable correction procedures. These QNEC contributions totaling \$5,419 are recorded as receivables as of December 31, 2023, on the accompanying statement of net assets available for benefits (ongoing). Corrections totaling \$126,450 were remitted to participants' accounts during 2023 and the remaining corrections totaling \$5,419 were remitted to participants' accounts during 2024. Participants are 100% vested in these QNEC contributions.
