## Independent Auditor's Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of AKA Enterprise Solutions, Inc. 401(k) & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following description of the AKA Enterprise Solutions, Inc. 401(k) & Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a qualified defined contribution plan with a cash deferral arrangement covering all eligible employees ("participants") of AKA Enterprise Solutions, Inc. (the "Company"). The Plan was established on January 1, 2005, and is administered on the basis of the plan year, which is the 12-month period ending on December 31. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants are offered a selection of common/collective trusts, mutual funds, pooled separate accounts, self-directed brokerage account, and a guaranteed investment contract for the placement of their contributions ("participant-directed"). The determination of the participant-directed investments made available to participants is made by the investment fiduciary or trustees.

#### *Eligibility*

Employees of the Company, as defined in the Plan, are eligible to participate in the Plan upon attaining age 21 and completion of three months of service. Participants are also eligible for employer matching and profit sharing contributions upon completion of three months of service.

#### *Contributions*

Participants may elect to defer up to 100% of their annual compensation as defined in the Plan, subject to maximum limits set by the Internal Revenue Code ("IRC"). Participants that have met requirements of age 50 may elect to defer additional amounts as catch-up contributions, subject to limits set by the IRC. Participants may also elect to defer a percentage of their after-tax compensation designated as Roth contributions, subject to maximum limits set by the IRC. Participants may make rollover contributions from other qualified retirement plans.

The Company makes a matching contribution of 100% of participant contributions that are not in excess of 4% of participant compensation. The Company may make a profit-sharing contribution as permitted by the Plan.

The Company did not make a profit-sharing contribution for the year ended December 31, 2024.

#### *Participant Accounts*

Each participant's account is credited with (a) the participant's elective deferrals and rollover contributions, (b) Company's matching and profit sharing contributions, and (c) net investment earnings and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### ***Vesting Service***

Participants are vested immediately in their elective deferral contributions, employer matching contributions, and profit sharing contributions, plus actual earnings thereon.

### ***Notes Receivable from Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account subject to certain Internal Revenue Service (“IRS”) limitations. Participants may only have one note outstanding at any given time. Notes are to be repaid within five years, unless the note is for a primary residence. Notes are secured by the remaining vested balance in the participant's account. The notes bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The interest rates on outstanding loans at December 31, 2024, ranged from 4.25% to 9.50%. Loans are repaid through payroll deductions every pay period.

### ***Payment of Benefits***

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the company makes the respective payroll deduction from the participant's compensation.

### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued, and the Plan determined there are no additional subsequent events have occurred that would require recognition or disclosure in these financial statements, except as discussed below:

Subsequent to year end, the Plan was amended to allow a Safe Harbor Matching Contribution by the Company effective January 1, 2025. The match is calculated as follows: (i) 100% of the matched employee contributions that do not exceed 3% of Plan compensation, plus (ii) 50% of the matched employee contributions that are over 3% but not more than 5% of Plan compensation.

Subsequent to year end, the Plan changed its name from AKA Enterprise Solutions, Inc. 401(k) & Profit Sharing Plan to HSO 401 (K) Plan. The financial statements reflect the name of the Plan as of December 31, 2024.

### 3. Certified Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a/ Principal Trust Company, and subsidiaries and affiliates (collectively "Principal"), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule Form 5500 - Schedule H, Part IV Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurement, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification are described as follows:

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### *Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### *Pooled Separate Accounts and Common/Collective Trusts*

Units of common/collective trusts and pooled separate accounts are reported at NAV. The NAV, as provided by the custodian, is based on the fair value of the underlying investments held by the fund, less its liabilities, and is considered readily determinable fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a common/collective trust or pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

### *Self-Directed Brokerage Account*

Valued at the daily closing value reported in the active market in which the underlying individual securities are traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Fully Benefit-Responsive Investment Contracts

In 2020 and 2024 the Plan entered into a fully benefit-responsive guaranteed investment contracts with Principal. Principal maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by further economic and regulatory developments. There are no reserves against contract value for credit risk of the contracts issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, is \$896,127 and \$624,201, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting. The guaranteed interest rate at December 31, 2024 and 2023 included a range of between 1.55% to 4.85% and 1.55% to 6.05%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Company needs to provide 12-month notice if it wants to exit the contract, otherwise it would surrender a 5% charge for early termination. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

### 6. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds, common/collective trusts, pooled separate accounts, self-directed brokerage account, and a guaranteed investment contract managed by Principal. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to the third-party administrator of \$129,375 during 2024 which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Certain employees of the Company who participate in the Plan, perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain 100% vested in their accounts.

### 8. Tax Status

The IRS has issued a favorable opinion letter dated June 30, 2020 that the adopted pre-approved plan qualifies under Section 401(a) of the IRC and is, therefore, not subject to tax under the present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the letter on the pre-approved plan, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### 10. Delinquent Contributions

During the Plan year ended December 31, 2024, contributions totaling \$250,829 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute prohibited transactions as defined by ERISA. Late remittances and associated earnings have not been fully corrected as of the date these financial statements were issued.
