Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

December 31, 2024

1. Plan Description

The following is not a comprehensive description of the Hawai'i Pacific Health 401(k) Plan (the Plan) and, therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the plan document and summary plan description for more complete information, copies of which can be obtained from Hawai'i Pacific Health (the Plan Sponsor).

General

The Plan is a defined contribution plan covering certain employees of Hawai'i Pacific Health (HPH), companies whose sole member is HPH and/or any one or more of the entities required to be aggregated with HPH under Internal Revenue Code (Code) Section 414(b) or 414(c) (collectively referred to as HPH). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). As of December 31, 2024 and 2023, and for the years then ended, Charles Schwab was the custodian and trustee of the Plan's assets.

Effective December 31, 2005, the Plan was frozen and no employees may contribute to the Plan thereafter. Eligible employees may participate in the Hawai'i Pacific Health Savings Plan, a tax sheltered annuity plan described in Internal Revenue Service (IRS) Code Section 403(b), effective January 1, 2006.

Participant Accounts

Each participant's account is credited with the participant's contribution (prior to January 1, 2006), the employer's matching or discretionary contribution (prior to January 1, 2006), and an allocation of Plan earnings. Allocations are based on account balances as defined. Participants may select from several investment options, each providing varying degrees of risk and growth.

Vesting

Effective January 1, 2006, all Plan accounts became fully vested.

Notes to Financial Statements (continued)

1. Plan Description (continued)

Participant Loans

Participants may borrow from their accounts up to a maximum of the lesser of 1) \$50,000 or 2) the greater of \$10,000 or 50% of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at prevailing rates. As of December 31, 2024 and 2023, participant loans bore interest at various rates ranging from 4.25% to 13.83%, with various maturity dates. Principal and interest are paid ratably through loan coupons.

Payment of Benefits

On termination of service, a participant has the option to receive the total vested value of his or her account at any time. Benefits are recorded when paid.

Plan Termination

Although it has not expressed any interest to do so, HPH has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participant accounts would be distributed as soon as practicable.

Administrative Expenses

Administrative expenses may be paid from Plan assets. Certain administrative expenses of the Plan are paid by HPH. Expenses that are paid by HPH are excluded from these financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Shares of mutual funds and personal choice retirement account investments allowed by the Plan (generally listed securities and mutual funds) are valued based on quoted market prices of shares held by the Plan at year-end. See Note 4 for further discussion and disclosure related to fair value measurements.

The HPH Retirement Investment Committee (the Committee) has engaged a third party to serve as a fiduciary with responsibility for determining the Plan's valuation policies and analyzing information provided by the investment custodian and issuers that is used to determine the fair value of the Plan's investments. The Committee oversees the services provided, including the Plan's valuation policies and investment analysis.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan receives monies under a revenue sharing arrangement with certain investment funds, which are used to pay plan expenses. Amounts received by the Plan under revenue sharing agreements with its service providers totaled \$245,702 and \$194,221 for the years ended December 31, 2024 and 2023, respectively.

The Guaranteed Interest Account meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The Guaranteed Interest Account invests primarily in a conservative array of securities and cash-equivalent investments with a minimum interest credit range between 1.00% and 3.00%. These investments are intended to provide stable crediting rates and limited volatility consistent with preservation of principal. Participants may deposit and withdraw on a daily basis at contract value and may also transfer to other investment options in the Plan. However, transfer restrictions may exist if the Plan offers competing funds. No direct transfers

from the Guaranteed Interest Account contract to a competing investment option are allowed. Competing options generally include money market funds, other guaranteed funds, and bond funds with a duration of less than three years. Any transfers from the Guaranteed Interest Account to a competing fund must first go through a noncompeting investment option and be held there for at least 90 days before completing the transfer. The Guaranteed Interest Contract can be terminated with a 30 days advance notice and settlement will be based on the terms defined in the Guarantee Interest contract, which are representative of contract value. As of December 31, 2024 and 2023 there are no events that would limit the Plan's ability to transact activities at contract value.

Notes Receivable From Participants

Participant loans are classified as notes receivable from participants and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been deemed necessary or recorded as of December 31, 2024 or 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Subsequent events have been evaluated through October 9, 2025, the date these financial statements were issued.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including non interest-bearing cash, investments held, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, including interest income on notes receivable from participants (2024—\$12,949; 2023—\$9,470) for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, clarifies that fair value is an exit price representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, ASC 820 establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

Level 1 – Observable inputs such as quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term for the assets or liabilities.

Level 3 – Unobservable inputs in which there is little or no market data and that are significant to the fair value of the assets or liabilities.

The Plan has classified its mutual funds and personal choice retirement account, primarily held in common stock and mutual fund investments, as Level 1 investments within the fair value hierarchy because these securities are valued using inputs observable in active markets for identical securities. The fair value of these securities are valued using the market approach and inputs observable in active markets for similar securities.

5. Tax Status

The Plan has received a determination letter from the IRS dated August 28, 2014, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Certain investments of the Plan are managed by Charles Schwab, and therefore, these transactions qualify as party-in-interest transactions. All of these transactions are exempt from the prohibited transactions rules.
