Report of Independent Auditors

To the Participants and Trustees of

Opinion

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of Plumbers Local #210 Health & Welfare Fund (the Plan) have been prepared using the accrual basis of accounting.

Contributions Receivable - Employer contributions due and not paid prior to year end are recorded as contributions receivable. Employer contributions due as determined by payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Investments - The investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Property and Equipment - Property and equipment are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation and amortization are computed by the straight-line method over the following estimated useful lives of the related assets:

Leasehold improvements	10 years
Furniture and equipment	5 years

Depreciation and amortization expense for each of the years ended December 31, 2024 and 2023 was \$42,911.

Note 1. Summary of Significant Accounting Policies (continued)

Leases - The Plan determines if an arrangement is a lease at inception. Operating leases are included in right-of-use (ROU) assets - operating leases and lease liability in the statements of net assets available for benefits. ROU assets represent the Plan's right to use an underlying asset for the lease term and lease liabilities represent the Plan's obligation to make lease payments arising from the lease. ROU assets and liabilities are recognized at the lease commencement date based on the present value of lease payments over the lease term. Lease terms may include options to extend or terminate the lease when it is reasonably certain that the Local will exercise that option. Lease expense for operating lease payments is recognized on a straight-line basis over the lease term. The Plan has elected to recognize payments for short-term leases with a lease term of 12 months or less as expense as incurred and these leases are not included as lease liabilities or right of use assets on the statements of net assets available for benefits. The Plan also used the practical expedient to not separately allocate lease and non-lease components.

When individual lease contracts do not provide information about the discount rate implicit in the lease, the Plan has elected to use a risk-free discount rate determined using a period comparable with that of the lease term for computing the present value of lease liabilities. Lease terms may include options to extend or terminate certain leases. The lease liability includes free rent and past and future lease incentives from the landlord. The value of a lease is reflected in the valuation if it is reasonably certain management will exercise an option to extend or terminate a lease.

Deferred Participant and Retiree Contributions - Participant and retiree contributions received in advance of the corresponding eligibility period are recognized as deferred income.

Benefit Obligations - Claims payable and claims incurred but not reported and postretirement benefit obligations are determined by the Plan's actuary using accepted actuarial principles, based on paid and incurred claim cost studies, Plan benefits, and other data as considered necessary.

The obligation for accumulated eligibility is determined by the Plan's actuary and represents an estimate of claims which will be due the following year for participants who had been credited with sufficient hours prior to the last day of the year to maintain eligibility after year end.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rate set forth in the collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 2 within a jurisdiction located in Lake, Porter, Newton, Jasper and LaPorte counties in Indiana.

Note 1. Summary of Significant Accounting Policies (continued)

Reciprocal Contributions - The Plan is signatory to various reciprocity agreements with various other multiemployer health and welfare plans for its participants who perform work outside the geographic jurisdiction of the local union. Participants who are normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When a participant of the home local works in the territory of a reciprocating local, the latter is to make contributions to the former's fringe benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local fringe benefit trust funds. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$191,564 and \$202,854 for the years ended December 31, 2024 and 2023, respectively, from various other health and welfare plans under the terms of reciprocity agreements. The Plan remitted a total of \$166,321 and \$175,691 in reciprocal contributions to various other health and welfare plans under the terms of reciprocity agreements for the years ended December 31, 2024 and 2023, respectively.

Benefits - All benefits are self-funded, with the exception of benefits for life insurance, vision, accidental death and dismemberment (AD&D) and prescription drug for Medicare-eligible retirees. Self-funded benefits include medical, dental, prescription drug and disability benefits for active participants.

Life insurance and AD&D benefits are provided under a group insurance contract with Reliance Standard Life Insurance Company. Prescription drug benefits for Medicare-eligible retirees are provided under a group insurance contract with Humana. Vision benefits are provided under a group insurance contract with VSP Vision.

Stop-Loss Insurance - The Plan maintains a stop-loss arrangement in an effort to limit its exposure for self-insured benefits. Under the terms of the contract, individual participant claims incurred within the contract year in excess of specific limits within the contract are reimbursed to the Plan. Self-funded benefits for medical, vision and dental for the year ended December 31, 2023 are reported net of stop-loss reimbursements of \$508,154. There were no stop-loss reimbursements received during the year ended December 31, 2024.

Note 1. Summary of Significant Accounting Policies (continued)

Prescription Drug Rebates - The Plan utilizes a pharmacy benefit manager (PBM) who periodically makes refunds to the Plan for rebates based on the Plan's actual utilization pattern of specific drugs. Rebates due from the Plan's PBM are recorded when earned. Self-funded benefits for prescription drug for the years ended December 31, 2024 and 2023 are reported net of rebates earned of \$450,224 and \$237,969 respectively.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan was established to provide health care, death and disability benefits for eligible participants and their dependents. The Plan is a multiemployer welfare plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

To become initially eligible for benefits, participants must be employed by a contributing employer or employers and working within the jurisdiction of the Plan and must be credited with contributions of 390 hours in the preceding work quarter. Once a participant becomes initially eligible, eligibility continues for three months. Quarterly coverage continues provided the participant is credited with a minimum of 390 hours during the immediately preceding work quarter. A participant who fails to meet the hours requirement may elect to continue coverage through self-pay contributions or by using dollar bank credits equal to the difference between the required contribution and the amount contributed by the employer. Retirees are also permitted to make self-payments to the Plan or use dollar bank credits for eligibility.

Quarterly employer contributions in excess of 492 hours are credited to each participant's dollar bank, which may be utilized to maintain eligibility. The maximum amount that a participant can accumulate in the dollar bank is \$5,000.

The Plan has a health center located in Merrillville, Indiana. The health center was established to provide participants with health clinic and wellness programs, including preventive, wellness, disease management, health consultation, occupational health and primary care services. The Plan entered into an agreement with Everside Health whereby the Plan pays a monthly per capita fee to cover costs incurred at the health center. As described in Note 9, the Plan pays rent and other occupancy costs incurred for the health center to the related local union.

Participants should refer to the summary plan description for more complete information.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

Note 4. Tax Status

The Plan's notice of exemption is dated September 22, 2004, in which the Internal Revenue Service stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code. The Plan has been amended since receiving the notice of exemption. The Plan's Trustees and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions and contributions from participants and retirees electing to self-pay for coverage. Participants may also elect COBRA coverage.

Participant employers contribute such amounts as provided in their collective bargaining agreements. The hourly contribution rate was \$9.45 through May 31, 2023, \$9.95 through May 31, 2024 and \$11.00 thereafter. The monthly COBRA rate for each of the years ended December 31, 2024 and 2023 was \$1,377. There were no COBRA self-pays for either of the years ended December 31, 2024 and 2023

Eligible retired participants are allowed to self-pay monthly contributions for benefit coverage. Retiree self-payment monthly rates for each of the years ended December 31, 2024 and 2023 ranged from \$203 to \$693 depending on the retiree's coverage option.

Note 6. Concentration of Cash

The Plan maintains its cash balances with financial institutions deemed to be creditworthy. Balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000.

Although balances may at times exceed insured limits, the Plan believes its credit risk to be minimal.

Note 7. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Level 2 Measurements

The money market fund is valued at cost, which approximates its fair value.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 9. Related Organizations

Identification of Related Organizations

The Plan has a number of related organizations including a local union, a defined contribution retirement plan and a training fund, all of which are tax-exempt.

Shared Administrative Expenses

The Plan shares facilities, equipment and staff with the related organizations. The local union provides office space to the Plan at no cost. Salary and fringe benefit expenses for an employee shared with the related local union and retirement plan are initially paid by the local union and are allocated to the Plan based on estimated time spent and actual costs incurred. Shared administrative expenses allocated to the Plan for the years ended December 31, 2024 and 2023 totaled \$66,260 and \$68,369 respectively. As of December 31, 2024 and 2023, the Plan owed the local union \$70,879 and \$82,705 respectively, which represent these shared administrative expenses as well as amounts due for contribution processing fees initially paid by the local union.

Health Center Lease

As described in Note 2, the Plan leases space from the local union to be utilized for purposes of a health center. The Plan pays the local union monthly rental payments of \$972 as required under the lease. Total operating lease expense under the operating lease totaled \$10,832 and \$10,657 for the years ended December 31, 2024 and 2023, respectively. Cash paid for the operating lease for each of the years ended December 31, 2024 and 2023 was \$11,664. These amounts are included with cost of benefits pertaining to the employee health center.

Lockbox Account

The Plan owns and shares a lockbox account with several of its related organizations. Contributions for the Plan and other related organizations are received and deposited in the lockbox account. On a regular basis, contributions due to the related organizations are transferred from the lockbox to the appropriate organization. Lockbox contributions not yet remitted at year end are reflected as a liability in the statements of net assets available for benefits.

Note 10. Postretirement Benefit Obligations

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The health trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point, it would increase the postretirement obligations as of December 31, 2024 and 2023 by \$3,243,000 and \$2,713,000 respectively.

Changes in actuarial assumptions for the year ended December 31, 2024 increased overall obligations by \$1,138,000. This was primarily the result of increasing the discount rate from 4.50% to 5.25%, updating the claims costs and expenses to reflect expected experience of the Plan and trends were updated to reflect the current marketplace.

Note 10. Postretirement Benefit Obligations (continued)

The cost of the postretirement benefit obligations is shared by the Plan's participating employers and retirees. The cost of the postretirement benefits is estimated annually by the Plan's consulting actuary. The Plan's Trustees then periodically adjust the portion to be paid by the participants. Retiree contributions are projected to cover approximately 37% and 45% of the estimated cost of postretirement benefits as of December 31, 2024 and 2023, respectively.

The Plan's excess of benefit obligations over net assets at December 31, 2024 and 2023 relates primarily to the postretirement benefit obligations, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreements. However, the Plan empowers the Board of Trustees to increase or decrease the amount of self-payments by eligible retired participants, and to modify the terms and conditions under which retiree eligibility may be maintained; therefore, the cost to the Plan can be reduced or eliminated prospectively by action of the Board of Trustees.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan was to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

Note 11. Major Employers

Contributions from two employers accounted for approximately 26% and 25% of total employer contributions for the years ended December 31, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would terminate coverage to the employers' participants as required under the Plan document. The Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.

Note 12. Concentration of Plan Investments

The Plan has a significant portion of its assets invested in a certain fixed income mutual fund. One fixed income mutual fund represented approximately 23% and 26% of the Plan's net assets available for benefits as of December 31, 2024 and 2023.

It is reasonably possible that changes in the fair value of these investment funds could materially affect the amounts reported in the statements of net assets available for benefits. If a significant decline in the fair values of these investments during the next year occurred, a change in the assumed rates of return used to calculate the present value of postretirement benefit obligations may be needed.
