Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cox Chevrolet 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024

I. Description of the Plan

The following description of Cox Chevrolet 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Cox Chevrolet and related adopting companies (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was restated on January 1, 2022.

Eligibility

To be eligible to participate in the plan the employee must be over the age of 18 and have completed two months of service. Prior to August 1, 2016, an employee had to be 21 years of age or older and have completed at least a year of service and 1,000 credited hours of service.

Participant Accounts

An employee may begin to participate in the Plan on the first day of the month following the date the employee satisfies the eligibility requirements. Each participant's account is credited with the participant's salary deferral, any rollover contributions, and the employer's matching contribution. Allocations of Plan earnings are based on the participant account balances in the Plan's investments. The participant is entitled to the benefit provided by the participant's vested account balance.

Contributions

Participants are automatically enrolled in the Plan when they become eligible at a 3% deferral rate. This percentage can be changed by the employee once enrolled in the Plan. Participants may contribute up to the maximum allowable limits of the Internal Revenue Service (IRS). For the year ended December 31, 2024, this limit was \$23,000 of annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, the annual catch-up contribution limit was \$7,500. The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company. The Company may also make a discretionary profit-sharing contribution. The Company did not make any profit-sharing contributions for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. The participants may change their investment elections at any time.

Vesting

Participants are immediately 100% vested in their voluntary pre-tax 401(k) contributions and Roth contributions plus earnings thereon. Vesting in the Company's profit sharing and matching contributions of their accounts is based on years of service as follows:

Investment Options

The Plan qualifies as participant-directed under ERISA Section 404(c). Upon enrollment in the Plan, a participant may direct and allocate their contributions to the investment options available. Employer contributions are allocated according to the participants' allocations. The percentage of contributions allocated to each of the investment options is at the discretion of the participant. Participants may change their investment options at any time using the Custodian's website or via telephone.

Plan Expenses

The Company pays the Plan's administrative service fees. For the year ended December 31, 2024, the Plan's administrative expenses were \$9,416.

Forfeitures

As of December 31, 2024 and 2023, there were \$35,604 and \$17,220, respectively, in forfeited amounts from non-vested amounts in accounts of participants who terminated employment. Forfeitures are allocated in the Plan year when the forfeiture occurs. Forfeitures may be used to pay Plan expense or to reduce amounts otherwise required to be contributed to the Plan. The Plan didn't use funds in forfeited accounts to reduce the employer contributions for the year ended December 31, 2024.

Payment of Benefits

If a participant ceases to be employed by the Company for any reason other than death or total and permanent disability prior to satisfying the age and service requirements for normal retirement (sixty-five), the terminated participant may elect, with the consent of his or her spouse, to receive any vested amounts plus the earnings thereon. Withdrawals may be subject to tax withholdings and penalties. If a participant's vested balance is \$5,000 or less, then they will receive a single-sum payment at termination of employment.

Upon termination of service, due to death or normal retirement age of 65, a participant becomes fully vested and may elect to receive a lump sum distribution equal to the value of his or her account balance, as described in the Plan.

Upon termination of service, (due to reasons other than death or normal retirement), a participant may elect to receive a lump sum distribution equal to the value of his or her vested account balance, as described in the Plan.

Hardship Distributions

Hardship distributions are permitted by the Plan at the discretion of the Company for allowable expenditures.

Notes Receivable from Participants

Participants are able to obtain loans from the assets of the Plan using their individual account balances as collateral. Loan amounts cannot exceed the lesser of \$50,000 or 50% of the participant's vested account balance and must be for a minimum amount of \$1,000. A participant can only have one loan outstanding from the Plan at any time. Each loan shall bear interest at a rate equal to the prime rate plus 1%. For the years ended December 31, 2024 and 2023, the interest rates ranged from 4.25% - 9.50% and 4.25% - 9.50%, respectively. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

1. Description of the Plan (Continued)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated by the employer, each participant's benefit becomes fully vested.

2. Summary of Accounting Policies

Financial Statements

The financial statements and notes are a representation of the Plan Administrator who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Use of Estimates and Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Fair Value Measurement

The Company adopted the Fair Value Measurement and Disclosures Topic of the FASB Accounting Standards Codification for fair value measurements of financial assets and financial liabilities that are recognized and disclosed at fair value in the financial statements on a recurring basis. The Fair Value Measurements and Disclosures Topic established a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurement. The financial statements reflect the adoption of the Fair Value Measurements and Disclosures Topic.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits present the investment contracts at contract value, which approximates fair value. The statement of changes in net assets available for benefits is prepared on a contract value basis, which also approximates fair value (See Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation in the Fair Value of Investments

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments. This consists of the realized gains and losses and the unrealized appreciation and depreciation of those investments.

Financial Instruments Not Measured at Fair Value

The Plan's financial instruments that are not measured at fair value on the recurring basis but are recorded at amounts that approximate fair value due to their liquid or short-term nature include employer and participant contributions receivable.

Benefits Paid to Participants

Benefits are recorded when paid.

3. Information Certified and Provided by Empower Annuity Insurance Company of America

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the custodian that the information provided to the Plan Administrator by the custodian related to the following investments is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

Empower Annuity Insurance Company of America also certified the completeness and accuracy of the net appreciation in fair value of investments of \$91,656, interest income of \$9,682 and dividend income of \$660,305 for the year ended December 31, 2024.

4. Fair Value Measurements

The Fair Value Measurements and Disclosures Topic provides enhanced guidance for using fair value to measure assets and liabilities and clarifies the principle that fair value should be based on the assumptions market participants would use when pricing the assets or liabilities and establishes a hierarchy that prioritizes the information used to develop those assumptions. The hierarchy gives the highest priority to unadjusted quoted prices in active markets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

4. Fair Value Measurements (Continued)

The three levels for measuring fair value are based on the reliability of inputs and are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is the quoted market price in the active market; therefore, the mutual funds are classified as Level 1 of the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contracts

The Plan has one fully benefit responsive group annuity contract with Empower Annuity Insurance Company of America, which is called the Guaranteed Portfolio Fund. The insurance company maintains the contributions in separate general accounts, which are credited with earnings and charged for participant withdrawals and administrative expenses.

Since the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The guaranteed crediting rate will be no less than 1% and no more than 3%.

The average yield earned by the Plan for the Guaranteed Portfolio Fund, is derived by averaging the quarterly gross interest rates for the fund over the year. The actual average yield earned by the Plan for the contract is derived by averaging the Plan's quarterly interest rates.

6. Party-in-Interest to the Plan

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. The guaranteed investment contracts are managed by the custodian. Transactions related to these investments qualify as party-in-interest transactions. The supplemental Schedule of Assets (Held at End of Year) identifies these investments. At December 31, 2024 and 2023, the total market value of these investments was \$6,471,417 and \$6,372,307 or approximately 88% and 82% of total assets, respectively.

7. Tax Status

The volume submitter plan has received an opinion letter dated June 30, 2020, from the IRS as to the plan's qualified status and has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for the 2021 through 2024 plan years.

8. Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.
