NOTE 1 – PLAN DESCRIPTION

Plan Description

The following description of the DM Group, Inc. (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is sponsored by DM Group, Inc.

General

The Plan is a defined contribution profit sharing plan covering substantially all employees of the Plan sponsors. Employees are eligible to participate in the Plan on January 1st or July 1st following the completion of one year of service. An employee is considered to have completed a year of service after completing 1,000 hours of service during the 12-month period which begins on the date of employment. In addition, an employee must have completed 1,000 hours of service per each plan year and be employed on the last day of the plan year in order to be eligible to receive any employer match and profit-sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”). The Board of Trustees is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Participants may contribute pretax annual compensation as defined by the Plan, up to a maximum of \$23,000 during the 2024 plan year. Participants over the age of 50 are also allowed additional catch-up contributions up to \$7,500 for 2024. The Plan also permits participant rollover contributions.

The Plan has an auto-enrollment provision, whereby all newly eligible employees who do not make an opt-out election will be automatically enrolled in the Plan at a salary deferral of 6%. On January 1st of each year, any new or existing participant who is not currently making a salary deferral, or who is making a salary deferral of less than 6%, will again be automatically enrolled at 6%. This policy will apply to all participants unless they affirmatively elect not to participate in the Plan, annually.

The Company determines and declares annually an employer match contribution and a profit-sharing contribution. There were no matching contributions for the year ended December 31, 2024.

Contributions are subject to limitations set by the Internal Revenue Service.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, Company's matching and profit-sharing contributions, forfeitures and Plan earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All funds are participant-directed unless otherwise noted.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. Employer matching contributions and earnings are vested 20% per year, starting after one full year of service. A participant is fully vested after five years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of thirty investment options, sponsored by Principal Trust Company, the Plan's custodian. Participants may change their investment options daily through an electronic voice activation system or through website interaction provided by the custodian.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Loan transactions are treated as transfers between the investment fund and the participant loan fund. Loan terms are not to exceed five years, unless the loan was for the purchase of a primary residence. The loans are secured by a fifty percent security interest in the participant's vested account balance and bear interest at the Prime rate charged by the United States Federal Reserve System as of the day of the loan request, plus 1%. principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeitures of the non-vested portion of a participant's employer matching account are primarily used to pay plan administrative costs or to reduce the employer's matching contribution. Alternatively, forfeitures may be allocated to participants as an additional matching contribution. At December 31, 2024 and 2023 non-vested employer contribution forfeitures are \$5,868 and \$124, respectively.

Plan Administrative Costs

The majority of administrative costs of the Plan are paid by the Plan sponsors. Plan participants paid \$51,583 of administrative costs for the year ended December 31, 2024.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, subject to the Plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or annuity. If a participant has reached the age of 59 ½, distributions may be made at the participant's election from their vested balance, without requiring the participant to terminate employment.

NOTE 2 –SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with U.S. generally accepted accounting principles (GAAP) on the accrual basis.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 9 for discussion of fair value measurements.

NOTE 2 –SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Deferred Payment of Benefits

Net assets available for plan benefits include \$2,959,272 and \$ 3,744,267 at December 31, 2024 and 2023, respectively, which represent deferred vested benefits for participants who have withdrawn from the Plan but have not been paid. Benefit deductions are recognized when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles of the United States requires the Plan’s administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Subsequent Events

Events that occurred subsequent to December 31, 2024 have been evaluated by the Company’s management for potential recognition or disclosure in the financial statements through the date of the independent auditor’s report, which is the date the financial statements were available to be issued. Management has determined that no events occurred that would require recognition or disclosure.

Allowance for Credit Losses

In accordance with ASC Topic 326 – Financial Instruments – Credit Losses, the Company assesses the need to record an allowance on financial assets. The Company evaluates the collectability of its financial assets by considering various factors, including historical loss experience, current economic conditions, and reasonable and supportable forecasts of future conditions. The allowance for credit losses is determined using the current expected credit loss (CECL) model, which requires the Company to estimate expected credit losses over the life of the financial asset. The Company considers the following factors in estimating credit losses:

- The historical credit loss experience of similar financial assets
- Current and future economic conditions and forecasts, including customer creditworthiness and industry-specific risks
- The aging of accounts receivable and other outstanding balances
- The nature and credit risk of individual receivables and loans

The provision for credit losses is recorded in the period in which the estimated credit losses are recognized, and adjustments are made to the allowance for credit losses based on changes in the estimate of expected credit losses. As of December 31, 2024 and 2023, there was no material impact to the financial statements in regard to the allowance for credit losses.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and assets of the Plan will be distributed in accordance with the Plan’s provisions.

NOTE 4 – TAX STATUS

The Plan is qualified pursuant to Section 401(a) of the Internal Revenue Code and, accordingly, the net investment income is exempt from income taxes. The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving its latest determination letter. However, the Plan administrator and the Plan’s management believe that the Plan is currently designed and being operated in compliance with the with the applicable requirements of the Internal Revenue Code.

NOTE 5 – EXCESS PARTICIPANTS’ CONTRIBUTIONS

There were no corrective distributions as of December 31, 2024.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

The administrator of the Plan is Principal Trust Company, who receives fees from Plan participants (see Note 1). The custodian of the Plan is Principal Trust Company, who acts as the Plans' trustee and who receives fees as a reduction of the return earned on each fund. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

NOTE 9 – FAIR VALUE MEASUREMENTS

U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standard Codification (“ASC”) 820 are described as follows:

Level 1

Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of reporting date;

Level 2

Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and.

Level 3

Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds

These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and these investments are classified within Level 1 of the valuation hierarchy.
