## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the  
Wellpower UAW Local #2571 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Wellpower UAW Local #2571 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. Description of Plan

The following description of the Wellpower UAW Local #2571 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering employees under the collective bargaining agreement between Stryten Energy Components (the Company) and the UAW Local #2571 union. The Plan covers employees who have completed 60 days of service and who are age 21 or older. Participants are allowed to enroll in the Plan on the first day of the month coinciding with when the requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each participant may make pre-tax contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus additional "catch-up" contributions of up to \$7,500 for those participants who have attained age 50. Employees are automatically enrolled in the Plan at a rate of 2% upon satisfying the eligibility requirements unless they elect otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company is required through the collective bargaining agreement with the UAW Local #2571 union to make contributions equal to fifty cents multiplied by the participant's hours of service. Such contributions are earned and recorded quarterly. In order to share in these employer contributions, the participant must work at least 250 hours during the quarter and be employed on the last day of the quarter. This requirement is waived upon death, disability, or attainment of qualified retirement age (65) during the period to which contribution relates. During 2024, matching contributions were \$109,446, of which \$80,793 were funded using forfeitures.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, rollovers, the Company's contribution and earnings and losses on the investments in their account and is charged with certain fees related to specific transactions and an allocation of administrative expenses based on participant account balances. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. Participants vest at a rate of 20% after two years of employment, then vest at a rate of 20% for each the next two years, and then become fully vested upon five full years of service. A participant must work at least 1,000 service hours annually to be credited with a year of service.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. At December 31, 2024, notes had fixed rates of 3.25% to 8.50% for the term of the note not to exceed 5 years, or 10 years if used for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

### **Payment of Benefits**

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution, or a series of distribution payments. After attaining the age of 59½, participants may also be eligible to make an in-service withdrawal of all or part of their vested account. The participant's contributions may also be withdrawn for certain hardship situations. If a participant terminates employment and has an account balance of less than \$7,000, the participant will automatically receive a lump-sum distribution of their vested account.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$28,046 and \$51,455, respectively. These accounts can be used to reduce future Company contributions or to pay Plan administrative expenses. During 2024, the Plan used \$21 of forfeitures to pay Plan expenses and \$80,793 to reduce employer matching contributions.

### **Administrative Expenses**

The Plan document permits certain administrative expenses to be paid by the Plan. In 2024, a portion of Plan administrative expenses was allocated to participants as a deduction of earnings, and certain transaction fees were charged to participants receiving the service. Certain recordkeeping fees are paid by the Plan. These expenses are paid to a service provider of the Plan and qualify as party-in-interest transactions. All other expenses are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

The Plan has established an ERISA account where the qualified institution deposits revenue sharing payments that can be used to pay Plan administrative expenses. The account balance at December 31, 2024 and 2023 was \$4,638 and \$3,309, respectively, and is included in the stable value core account on the accompanying statements of net assets available for benefits. During 2024, \$1,329 was deposited into the account, including investment earnings. Deposits to this account are included in net change in contract value of investment in the accompanying statement of changes in net assets available for benefits.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company contributions are considered payable to the Plan when they are approved by the Company, at least quarterly. Any unfunded participant or Company contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

#### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value, except for the stable value core account which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Net change in fair value and contract value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

#### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding principal balance. Interest income is recorded when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan

administrator deems the participant note to be in default, the participant note balance is reduced, and a deemed distribution is recorded. Notes receivable from participants qualify as party-in-interest transactions.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by the Qualified Institution**

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Transamerica Financial Life Insurance Company Inc. (TFLIC), the Plan's qualified institution.

### **4. Investments and Fair Value Measurements**

Certain Plan investments include pooled separate accounts and the stable value core account managed by Transamerica Life Insurance Company (TLIC), an affiliate of TFLIC (collectively, Transamerica), and by TFLIC. TFLIC is the qualified institution of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of the investment as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for similar assets or liabilities in active markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in pooled separate accounts are valued daily using net asset value (NAV). The NAVs are based on the fair value of the underlying mutual funds, stocks, debt instruments, and other securities in the accounts. Participants can trade the pooled separate accounts daily at the published NAV, and the market is considered active, therefore, management has categorized them as Level 1.

The following table summarizes the Plan's investments, at fair value, based on the inputs used to determine their fair values as of December 31, 2024 and 2023:

### Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive investment contract through a group annuity contract issued by Transamerica. This is an investment based on the general unallocated account of Transamerica. Transamerica pays interest and guarantees the Plan's capital deposit regardless of

the activity in the general account. The investment, as a deposit liability of Transamerica has no direct investments on behalf of the Plan. The investment value is based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica's insurance ratings. The effective annual interest rate is established every six months. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. The average yield earned by the account was 1.58% and 1.17% in 2024 and 2023, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all of or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. Although Plan participants may direct withdrawals at any time without restrictions, a hold can apply in the event the Company requests a full distribution from the investment. The Plan has no intention to request a full distribution at this time.

The Plan's ability to receive amounts due is dependent on Transamerica's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. At this time, the plan administrator is not aware of any events that may limit the ability of the Plan to transact at contract value with the contract issuer or limit the ability of the Plan to transact at contract value with the participants.

### **5. Plan Termination**

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in Company contributions.

### **6. Income Tax Status**

The Plan is a non-standardized pre-approved profit sharing/money purchase/CODA plan (pre-approved plan) created by Transamerica Retirement Solutions LLC, an affiliate of TFLIC. The Internal Revenue Service has determined and informed Transamerica by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter. The Plan administrator believes the Plan is designed and is currently being operated in

compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
