INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of

Opinion

I have audited the financial statements of Teamsters Union Health & Welfare Fund Trust d/b/a HOFFA Medical Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In my opinion, the accompanying financial statements present fairly, in all material respects, the financial status of Teamsters Union Health & Welfare Fund Trust d/b/a HOFFA Medical Plan as of December 31, 2024 and 2023, and the changes in its financial status for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion
