Scope and nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ray Laethem Buick GMC, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ray Laethem Buick GMC, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ray Laethem Buick GMC, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note A: **Description of Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** – The Plan was adopted effective January 1, 1991. The Plan is a defined contribution plan covering all employees with completion of three consecutive months of employment and are age 21 or older. It is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). Ray Laethem Buick GMC, Inc. is the sponsor of the Plan. The Plan is a tax deferred retirement plan under Section 401(k) of the Internal Revenue Code.
2. **Eligibility** – An employee may become a participant in the Plan after completing the selected service requirements and attaining the age of 21. Eligible participants may enter the Plan on January 1st or the same day of the month occurring in each successive 3-month period, coincident with or next following satisfaction of the eligibility requirements.
3. **Contributions** – Eligible employees may make elective contributions to the 401(k) plan by deferring a percentage of compensation for the year not to exceed the maximum contribution allowable by the Internal Revenue Code (IRC) adjusted annually for cost of living changes. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The employer can elect to make discretionary matching contributions. Any matching contributions are invested directly in the investment options chosen by the participants. Additional profit sharing amounts may also be contributed, at the option of the employer, and are invested directly in the investment options chosen by the participant. Contributions are subject to certain limitations.

4. **Participant Accounts** – Each participant's account is credited with the participant's contributions, the employer's contributions and any income or loss allocation of Plan earnings or losses and forfeitures of terminated participants' non-vested accounts. Allocations are based upon participant earnings or account balances, as defined in the Plan.
5. **Investment Options** – Upon enrollment in the Plan, a participant may direct employee and employer contributions, in any increments, to any of the investment options offered by the Plan. These options consist of several different mutual funds and guaranteed insurance accounts, each with its own financial goals and array of investments. Participants may change their investment options at any time.
6. **Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus actual earnings thereon is based on continuous service. A participant is 100% vested after four years of credited service.

Note A: Description of Plan (Continued)

7. Payment of Benefits – Distributions are allowed upon retirement, attainment of age 59 ½, disability, the death of the employee and termination of service without affecting rights under the Plan. A terminated participant will receive an involuntary cash-out distribution only if the participant's vested account balance is \$1,000 or less. A participant or their beneficiary may elect to purchase an annuity with his or her lump sum distribution equal to the value of their account or installment payments as requested by the participant, subject to minimum distribution requirements under the Internal Revenue Code.
8. Forfeitures – If a participant is not fully vested on their termination date, the non-vested amount of the account is forfeited and used to pay administrative expenses, and then used to reduce future employer contributions. During the year ended December 31, 2024, \$24,761 was used to reduce future employer contributions. A balance of \$52,978 remains in the forfeiture account at December 31, 2024.

Note B: Summary of Significant Accounting Policies

1. Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.
2. Use of Estimates – The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America periodically requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.
3. Investment Valuation and Income Recognition – Quoted market prices, where available, are used to value investments at fair value. The change in the difference between cost and fair value from the beginning of the year to the end of the year, as well as the realized gains and losses during the year, is reflected as net appreciation (depreciation) in fair value of investments. Investments with no quoted market price represent estimated fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.
4. Payment of Benefits – Benefits are recorded when paid.
5. Administrative Expenses – Certain administrative expenses are paid by the Plan and are reflected in the accompanying financial statements. In addition, the Company provides other administrative expenses to the Plan as discussed in Note E.

Note C: Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820 Fair Value Measurement and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. These level 3 fair value measurements are based primarily on management's own estimates, using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the assets. Significant level 3 inputs include information provided by fund managers, third-party appraisals, year-end audited financial statements, projected discounted cash flows, and net asset value with adjustments related to certain restrictions. Management assesses the valuation of these investments through the engagement of a third-party investment advisor and periodic meetings to review these investments.

In instances whereby inputs used to measure fair value fall into different levels in the above fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgement and considers factors specific to each asset.

Note C: Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Plan's investments:

Mutual funds – Mutual funds are valued at closing quoted prices reported in active markets.

Insurance company general investment account – These investments are valued at net asset value per share (or its equivalent) of the investment, which is based on the fair value of the investment company's underlying net assets.

Money market funds – These investments are valued at their outstanding balance, which is the best estimate of fair value.

Note E: Investments

During the years ended December 31, 2024, and 2023, the Plan's investments (including investments bought and sold, as well as held during the year) appreciated in value by \$437,492 and \$667,652, respectively, which resulted from the Plan's investment in mutual funds and money market funds.

Note F: Party-in-Interest Transactions

The Company, participants and the Custodians have all been identified as parties-in-interest.

Certain plan investments are shares of mutual funds managed by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions.

Certain expenses, including salaries and services required for Internal Revenue Service reporting, related to the administration of the Plan are paid the Company. The Company is the sponsor of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Note G: Plan Termination

Although it has not expressed any intentions of doing so, the Company has the right under the Plan to terminate at any time. Termination of the Plan would not affect the rights of a participant as to the distribution or withdrawal of the participant's account balance as of the effective date of such termination, subject to the provisions of ERISA. In the event of the Plan termination, participants become 100% vested in their accounts.

Note H: Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administration and the Plan's tax counsel believe the Plan continues to be designed and is operating in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax exempt.

Note I: Tax Uncertainties and Open Tax Years

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examination for years prior to December 31, 2021.

Note J: Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

All funds held in the Insurance company general investment account are not insured by FDIC or any governmental agency.

Note K: **Prohibited Transactions**

During the Plan year ended December 31, 2024, there were untimely deposits amounting to \$19,367, of participant deferrals into the Plan. Pursuant to Section 406(a) of ERISA, this constitutes loans between the plan sponsor and the Plan, which are prohibited transactions. As of October 13, 2025, the plan sponsor is in the process to make the necessary corrective actions to pay the applicable lost earnings on the late remittances.

Note L: **Subsequent Events**

The date to which events occurring after December 31, 2024, the date of the most recent Statement of Net Assets Available for Benefits, have been evaluated for possible adjustment to the financial statements or disclosures is October 13, 2025, which is the date on which the financial statements were available to be issued.
