## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

**1. Description of Plan**

Robbins Research International, Inc. 401(k) Plan ("the Plan") was formed on July 1, 1995 and restated effective January 1, 2016. The following description of the Plan, is for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was restated effective January 1, 2022.

**General**

The Plan is a defined contribution 401(k) Plan, covering all eligible employees of Robbins Research International, Inc. ("the Sponsor"), and its participating affiliates, ("Employer"), who have completed one month of service and attained age 18 or older. The Plan administrator controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participation in the Plan becomes effective on the first day of the month on or after a Participant meets the eligibility requirements.

**Employee Contributions**

Each year, participants may elect to defer up to 100% of their annual compensation on a pre-tax basis, subject to limitations. The Plan also allows for after-tax Roth contributions. The maximum dollar amount is \$23,000 for 2024, with a catch-up contribution limit for age 50 or older of \$7,500. Participants may increase or decrease their elective deferrals percentages on the first day of any month. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also allows elective deferral contributions to be made as Roth contributions after tax basis. If certain requirements are met, a qualified distribution from Roth contribution account in the Plan will not be taxed.

**Participant Accounts**

Each participant account is credited with the participant's contributions and allocations of the Company's contribution and plan earnings (losses) from the funds in which the account is invested, and charged with an allocation of administrative and investment-related expenses, and participant-specific charges, if applicable. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Rollover and Transfer Contributions**

The Plan accepts rollover contributions from any qualified plan if proof can be furnished that the contribution has been in such a plan or a rollover Individual Retirement Account.

**Employer Contributions**

The Company may make matching contributions, qualified non-elective contributions, and discretionary contributions on behalf of each eligible participant. There were no company matching contributions made during the year.

**Withdrawals and Distributions**

Participants may elect to withdraw all or a portion of their own pre-tax contribution accounts vested, employer matching accounts vested, profit sharing accounts, and rollover accounts at any time on or after the day the participant attains age 59 1/2. If a participant is under 59 1/2, withdrawals from pre-tax contribution accounts are subject to certain hardship rules as provided by the Plan description. Participants may receive a distribution on account of hardship from all of their accounts that are fully vested, except their Qualified Non-Elective Contribution Account. There was no hardship distribution during the year.

**Notes Receivable from Participants**

The Plan has adopted a loan program to provide loans to plan participants. Participants are permitted to have two loans outstanding at any time. Loans bear reasonable rates of interest (the prime rates) and are adequately secured. The maximum amount of which a loan may be made is the lesser of \$50,000 or one-half of present value of participants' vested account balances in the plan, whichever is less. Participant may repay a loan in accordance with the repayment schedule or make a full or partial prepayment. The minimum amount of any loan is \$1,000. All loans are required to be repaid in full according to the loan agreement or upon termination of employment. The loan interest rate is based on prime rate of interest plus one percent.

**Payment of Benefits**

Benefit payments for vested amounts are paid to participants or their beneficiaries in a manner requested by the participant or beneficiary as soon as practicable after the participant's termination of employment, disability, retirement or death, as governed by the Plan agreement. For the year ended December 31, 2024 benefits paid to participants were \$1,453,749.

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; Tax years 2021 through 2023 are open to examination, however, there are no audits for any tax periods in progress.

**Plan Termination**

Although the Company has no intentions of terminating the Plan, the Company may amend or terminate the Plan at any time in its sole discretion, subject to the provisions set forth in ERISA. In the event of a full termination of the Plan, the accounts of each participant shall become fully vested.

**Forfeited Accounts**

Forfeited non-vested amounts may be used to reduce administrative expenses of the Plan, then any remaining forfeitures shall be applied to reduce employer matching contributions. As of December 31, 2024 and 2023, the ending balance was \$20 and none, respectively.

**2. Summary of Significant Accounting Policies****Basis of Accounting**

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. The modified cash basis of accounting recognizes revenues and contributions as they are received, expenses and distributions as they are paid and adjusts investments in securities to fair value.

**Use of Estimates**

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2023 excess contributions to the applicable participants subsequent to year end. There were no excess contributions payable for the period of December 31, 2024.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments. During the year, total annual fees paid by the Plan were \$50,089.

**3. Information Prepared and Certified by Custodian (unaudited)**

At December 31, 2024 and 2023, the Plan's investments were held by the Custodian. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds and Exchange-Traded Funds: Valued at the daily closing price as reported by the fund. Mutual funds and Exchange-Traded Funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and exchange-traded funds held by the Plan are deemed to be actively traded.

Common collective funds: Fair value of this investment contract, prior to contract termination, equals the contract value. Contract value is determined using a discounted cash flow valuation methodology where the interest rate for this portfolio investment contract is reset at least as frequently as annually. This contract is not fully benefit responsive and therefore is reported at fair value on the financial statements.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**6. Related-Party and Party-in-Interest Transactions**

Certain plan investments are managed by American Trust Company. Plan administrative services are provided by American Trust Company. Additionally, American Trust Company acts as trustee for funds held as investment vehicles for the Plan. Therefore, investment fund transactions are classified as party-in-interest transactions for which an exemption exists.
