Independent Auditors' Report

To the Compensation Committee and Plan Administrator of
Current Retirement Plan for Collectively Bargained Employees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Current Retirement Plan for Collectively Bargained Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Current Retirement Plan for Collectively Bargained Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment and notes receivable from participants information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Current Retirement Plan for Collectively Bargained Employees and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Current Retirement Plan for Collectively Bargained Employees' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements referred to above, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i – Schedules of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Current Retirement Plan for Collectively Bargained Employees (the Plan) provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Current Lighting Employee Co LLC and related employers, including Hubbell Incorporated and Litecontrol Corporation (collectively, the Company). Only collectively bargained employees of The International Union of Electronic, Electrical, Salaried, Machine and Furniture Workers and Communications Workers of America, AFL-CIO, Local 160 (Christiansburg) and the International Brotherhood of Electrical Workers, AFL-CIO, Local 1499 (Plympton) are eligible to participate in the Plan after 90 days of service, excluding residents of Puerto Rico, leased employees, temporary employees who have not completed 12 months of service, and nonresident aliens who do not receive any earned income from a U.S. source. Eligible employees are permitted to enter the Plan on the first day of each calendar month coinciding with or next following satisfaction of such eligibility requirements. Prior service is credited to employees for employment with Hubbell Incorporated prior to July 1, 2022. A retroactive amendment was executed on December 23, 2024, effective July 1, 2022 such that prior service is credited to employees for employment with Litecontrol Corporation prior to July 1, 2022 (instead of prior to April 16, 2014 as originally provided by the plan document).

The Plan was originally established on July 1, 2022 as a spin-off from the Hubbell Incorporated Employee Savings and Investment Plan for Collectively Bargained Employees.

The Compensation Committee and Plan Administrator are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA).

Setting Every Community Up for Retirement Enhancement (SECURE) Act and SECURE 2.0 Act

The SECURE Act and the SECURE 2.0 Act had various provisions in effect during the year ended December 31, 2024. The most significant change required including long-term part-time (LTPT) employees who attained 500 or more hours of service in three consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. The Plan is required to be formally amended on or before December 31, 2025 for the SECURE Act and on or before December 31, 2026 for the SECURE 2.0 Act.

Contributions

Each payroll period, participants may contribute between 1% and 50% of eligible compensation (as defined by the Plan) as pre-tax, Roth, and catch-up contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Contributions...continued

Generally, participants direct the investment of their contributions into various investment options offered by the Plan; however, the Plan includes an automatic enrollment provision for employees hired after July 1, 2022, whereby all newly eligible employees not previously eligible based on prior credited service and rehires are automatically enrolled in the Plan unless they elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 6% of eligible compensation on the first day of the calendar month coinciding with or next following satisfaction of eligibility requirements and their contributions are invested in a designated fund until changed by the applicable participant. Each automatically enrolled participant will have his or her pre-tax deferral rate increased by 1% each September 1 until his or her deferral rate reaches 20%.

The Plan provides for employer discretionary matching contributions for eligible participants who are members of the International Brotherhood of Electrical Workers, AFL-CIO, Local 1499 (Plympton) and are contributing any combination of pre-tax, Roth, and catch-up contributions to the Plan. True up calculations are discretionary. For the year ended December 31, 2024, the Company elected to match up to 50% of the first 6% of eligible compensation that was contributed to the Plan by each employee as any combination of pre-tax, Roth, and catch-up contributions. The contribution period for purposes of calculating the amount of employer discretionary matching contributions is each payroll period. The Company made employer discretionary matching contributions for the year ended December 31, 2024 totaling \$122,405. No discretionary true up calculation was performed for the year ended December 31, 2024.

The Plan also provides for nonelective employer contributions for eligible employees who are members of The International Union of Electronic, Electrical, Salaried, Machine and Furniture Workers and Communication Workers of America, AFL-CIO, Local 160 (Christiansburg). For the year ended December 31, 2024, nonelective employer contributions were 4% of each participant's eligible compensation each payroll period totaling \$258,654.

During the year ended December 31, 2024, management discovered that the automatic enrollment feature was not operating as required by the plan document for certain employees since inception and certain contributions were not remitted to the Plan. Such amounts were corrected and deposited into the Plan during the year ended December 31, 2024. Corrective employee contributions receivable totaled \$26,575 as of December 31, 2023; corrective employer discretionary matching contributions receivable totaled \$28,418 as of December 31, 2023; and corrective nonelective employer contributions receivable totaled \$20,141 as of December 31, 2023. These amounts were funded during the year ended December 31, 2024 and were included in corrective contributions receivable on the accompanying statement of net assets available for benefits as of December 31, 2023. Management also identified that the Plan is not properly applying certain participants' elected contribution rates; however, the potential net correction was deemed insignificant to the Plan as a whole and such amounts were not recognized on the accompanying financial statements. Management intends on calculating and correcting such errors subsequent to the issuance date of these financial statements.

All contributions and compensation are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. The allocation of earnings or losses is based on each participant account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from Participants

The Plan permits its participants to obtain loans against their account balances. A participant may borrow from his or her vested account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the participant's account during the last twelve-month period, or 50% of his or her vested account balance. While a participant's after-tax, prior plan profit sharing, qualified nonelective, Roth, and Roth rollover contributions sub-accounts are available for determining the maximum amount available for the loan, they are not available for loan processing. A participant may have one loan outstanding at any given time and must wait thirty days after loan payoff to apply for a new loan.

Notes receivable from participants are secured by the vested balance in each participant's account and shall bear interest at the prime rate charged for a loan made under similar circumstances by persons in the business of lending money plus 1% (8.50% as of December 31, 2024). Loans are limited to a maximum of five years unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond ten years from the date of the loan.

Loans must be repaid via payroll deduction, certified check, money order, cashier's check, or ACH. Loans may be prepaid in their entirety at any time. Any such prepayment shall be made by certified check, money order, cashier's check, or in any form approved by the Plan Administrator. The Plan Administrator may suspend loan repayments for a period of one year or less if a participant is on a leave of absence, however, the loan must still be repaid in full on the maturity date. The Plan Administrator shall consider a loan in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. As of December 31, 2024, the rates of interest on outstanding notes receivable from participants ranged from 4.25% to 9.50%, with various maturities through 2029. Certain other restrictions may apply to notes receivable from participants as defined in the plan document.

Vesting

Each participant is immediately vested in his or her voluntary contributions, rollover contributions, nonelective employer contributions, and corrective contributions plus actual earnings thereon. Participants will become immediately vested in all contribution sources upon reaching normal retirement age (65) while still employed, disability, or death.

Participants vest in employer discretionary matching contributions as follows:

Forfeitures

Forfeitures represent the nonvested portion of terminated participant account balances plus related earnings. As of December 31, 2024 and 2023, forfeitures held by the Plan totaled \$1,104 and \$700, respectively. These amounts can be used to reduce employer contributions or pay the Plan's expenses by the end of the immediately following plan year.

During the year ended December 31, 2024, \$158 in forfeited nonvested accounts were used to reduce amounts funded related to corrective contributions for the year ended December 31, 2024.

Payment of Benefits

Withdrawals may be made from a participant's account at death, disability, or termination of employment. The participant's vested account shall be distributed to the participant in a single lump-sum payment or partial payments (or to the participant's beneficiary in the event of the participant's death in a single lump-sum payment in full by the end of the calendar year that contains the fifth anniversary of the participant's death). Distribution shall be made to an eligible participant from his or her vested account as soon as reasonably practicable following the date the participant's application for distribution is received by the Plan Administrator, but in no event later than the participant's attainment of age 73.

A participant may elect, at the time and in the manner prescribed by the Plan Administrator, to have the entire vested amount in his or her account (with a minimum of \$500) rolled over into another qualified plan, as directed by the participant. A participant may elect to withdraw all or a portion of his or her elective and rollover contribution sub-accounts at any time. Hardship withdrawals must be for a minimum of \$500 and from the respective participant's elective and rollover contribution sub-accounts. Each participant who has attained age 59½ while employed may elect to withdraw all or a portion of his or her vested account. The Plan Administrator can elect to distribute funds out of the Plan when a participant terminates employment and has a vested balance in the Plan less than \$5,000.

All distributions are subject to the applicable provisions of the Plan.

Investment Elections

Each participant shall direct the investment of his or her account and shall select among various mutual funds and common collective trust funds. Each participant has the ability to change his or her investment allocations at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Compensation Committee and Plan Administrator determine the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. As of December 31, 2024 and 2023, accrued, but unpaid interest has been deemed insignificant to the Plan. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from the participant to be a distribution, the notes receivable from participants balance is reduced and a benefit payment is recorded within the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant initiated transactions are charged directly to the applicable participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. For the year ended December 31, 2024, the Company paid certain other administrative expenses incurred by the Plan.

3. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820, *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means; or
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds – Mutual funds are valued at the daily closing price as reported by each mutual fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission, which are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds – Common collective trust funds are valued at the NAV of units of the applicable collective trust fund. The NAV, as provided by T. Rowe Price Trust Company (T. Rowe Price), the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the applicable fund less its liabilities. This practical expedient is not used when it is determined to be probable that the applicable fund will sell the investment for an amount different than the reported NAV. Transactions of investments or withdrawals may occur on a daily basis and there are no redemption restrictions on these funds. There are no unfunded commitments as of December 31, 2024 and 2023.

4. Information Prepared and Certified by Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment and notes receivable from participants activity reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Tax Status

The Plan has adopted a pre-approved plan in which the IRS determined, by an opinion letter dated August 19, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Compensation Committee and Plan Administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

7. Party-in-Interest Transactions

Certain investments of the Plan are a mutual fund and common collective trust funds managed by T. Rowe Price and qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in participant accounts, and constitute party-in-interest transactions.

8. Risk and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events for potential disclosure or recognition through October 8, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the SECURE 2.0 Act expanded LTPT provisions to include employees who attained 500 or more hours of service in two consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. Further, participants from ages 60 to 63 will be allowed to contribute catch-up contributions equal to 150% of the standard limit.
