We have performed an audit of the financial statements of Garnet Auto Group Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). #### Note 1. Description of the Plan

The following description of the Garnet Auto Group Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Garnet Ford, Inc. (the "Company") who are at least 21 years old and who have completed six months of service. Eligible employees may enter the Plan on the first day of the month after satisfying the eligibility requirements. The Plan includes the following affiliated participating employers: Garnet KS, Inc., Garnet VW, Inc., Garnet of West Chester, Inc., Garnet of Leesport, LP, and Garnet VW of Leesport, LP. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a percentage of their compensation into a regular 401(k) account and/or into a Roth 401(k) account, as defined in the Plan. However, the total of all such participant contributions is subject to annual limits set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a 2% withholding of pretax annual compensation. The Plan provides for a discretionary employer matching contribution. For the plan year ending December 31, 2024, the match was 100% of the first 3% of compensation that a participant contributes and 50% of the next 2% of compensation that a participant contributes to the Plan. The Company may also make discretionary profit-sharing contributions at an amount to be determined annually. There were no such contributions for the Plan year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions including the Company matching contribution, the Company's discretionary profit-sharing contribution, if any, and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. Allocations of the Company's discretionary profit-sharing contributions, if any, are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change the allocation of their contributions among investment options at any time.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1%. Principal and interest are paid through payroll deductions.

### Note 1. Description of the Plan (Continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching and discretionary profit-sharing contributions is based on years of continuous service. A participant is 20% vested after two years of service are completed, 40% vested after 3 years of service is completed and vests an additional 20% per year until full vesting after six years. A participant is fully vested in the event of death or disability.

Payment of Benefits: Benefits are payable upon normal retirement age 65, disability, death, or termination of employment. The plan allows hardship withdrawals and in-service withdrawals at age 59 ½, subject to provisions described in the Plan document. Benefits are payable in lump sum payments or non-recurring partial payments.

Forfeited Accounts: When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures are accumulated in a separate account and may be utilized for payment of administrative expenses and then to reduce the Company's matching and non-elective contributions. There were unused forfeitures of \$3,777 and \$1,091 at December 31, 2024 and 2023. During 2024, forfeitures of \$5,404 were used to pay plan expenses.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account.

### Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies and collective investment trusts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Note 2. Summary of Significant Accounting Policies (Continued)

Notes Receivable from Participants: Notes receivable from participants are measured at the unpaid principal balances, plus any accrued interest. Delinquent loans are treated as distributions based upon the terms on the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

### Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Ascensus, LLC, an affiliate of Ascensus Trust Company (the Plan's Custodian).

### Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The three levels of the fair value hierarchy are as follows:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The Plan's investments, consisting of registered investment companies and collective investment trusts, are held by Ascensus Trust Company, LLC. The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and registered investment companies: Shares of registered investment companies (mutual funds) are valued at the daily closing prices as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: The Plan invests in a collective investment trust offered Great Gray Trust Company, LLC. The collective investment trust is valued based upon the net asset value (NAV) per unit times the number of units held by the Plan at year-end. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value.

Great Gray Trust Company, LLC offers Great Gray CIT III for Metlife GAC No. 25554 whose objective is to provide safety of principal, adequate liquidity and a competitive yield with low return volatility. Purchases or sales are executed at NAV typically determined as of the close of trading on the trade date. The fair value of the collective investment trust is based on the fair value of the collective trust's underlying investments as reported by the fund manager to the Trustee, net of accrued account level fees.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5. Related Party and Party-in-Interest Transactions**

Plan investments include shares of registered investment companies managed by Ascensus Trust Company, LLC. Ascensus Trust Company, LLC is the current Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 7. Tax Status**

The Plan adopted a non-standardized pre-approved plan sponsored by Ascensus, LLC. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the Plan's qualified status. Although the Plan has since been amended, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
