## **Report of Independent Auditors**

To the Administrator of PSCU Incorporated 401(k) Retirement Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of PSCU Incorporated 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **1. Description of Plan**

The following description of the PSCU Incorporated 401(k) Retirement Plan (the “Plan”) provides only general information. Detailed descriptions of the Plan’s benefits and provisions are contained in the Plan documents, which can be obtained from PSCU Incorporated (the “Company” or “Plan Sponsor”).

##### **General**

The Plan is a defined contribution plan offered to all full-time employees of the Company and its wholly owned subsidiaries (“Participants”). Participants are eligible to participate in the Plan after one month of service. The Plan excludes employees covered under a collective bargaining agreement, non-resident aliens who do not receive any compensation from United States (“U.S.”) sources, independent contractors, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and the Internal Revenue Code of 1986 (“IRC”), as amended.

On January 1, 2024, the Company combined with CU Cooperative Systems, LLC, forming a new company called PSCU/Co-op Holdings, LLC (“PSCU/Co-op”). Additionally, on January 1, 2024 the Company’s name changed to PSCU, LLC from PSCU Incorporated. On May 7, 2024, PSCU/Co-op’s name was changed to Vclera Solutions, LLC.

On November 30, 2025, Participants of wholly owned subsidiary Lumin Digital, LLC were no longer eligible to participate in the Plan and related assets of these Participants were transferred out of the Plan. See Note 10 for further information.

On January 1, 2025, the Plan merged with the Vclera 401(k) Retirement Savings Plan (“Vclera Plan”), previously named the Co-op Solutions 401(k) Retirement Plan. See Note 10 for further information.

##### **Administration**

The Plan is administered by the Company through a committee covering various benefit and compensation plans (the “Committee” or “Plan Administrator”). The Committee has been given all powers necessary to carry out its duties, including, but not limited to, the power to administer and interpret the Plan, to answer all questions affecting eligibility of Participants in the Plan, and to authorize disbursements for the payment of Plan benefits.

The Company entered into an agreement with Lincoln Retirement Services Company, LLC, to provide an array of core services, most notably recordkeeping, transaction processing and compliance testing. Lincoln Financial Group Trust Company, Inc. (“Lincoln Financial”), is the trustee of the Plan and has the authority to invest and control all contributions made to it under the Plan.

##### **Contributions**

Each year, Participants may make salary deferral contributions up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan, up to the maximum allowed by the IRC. The maximum annual deferral for 2024 was \$23,000. Participants age 50 and over were eligible to make additional catch-up contributions of up to \$7,500 in 2024. The Plan provides a Safe Harbor Matching Contribution equal to 100% of the first 3% of plan compensation and 50% of the next 3% of plan compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Additionally, if the Plan becomes top heavy in any Plan year ending December 31, non-key employees who are eligible to receive a top-heavy contribution under the Plan generally will receive a minimum contribution equal to the lesser of 3% of plan compensation or the highest percentage provided to any key employee (as defined in the Plan).

#### **Participants' Accounts**

Each Participant's account is credited with the Participant's contributions and allocations of (a) the employer contributions, (b) Plan earnings or losses, and (c) administrative expenses. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is equal to the vested balance in the Participant's account.

#### **Investment Options**

Upon enrollment in the Plan, a Participant may direct contributions in a variety of investment options. All funds vary in types of investments, rates of return, and investment risk. Participants may elect, on a daily basis, to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

#### **Vesting**

As the Plan is a Safe Harbor Plan, employees are always 100% vested in employee deferral contributions, rollover contributions, and employer match contributions.

#### **Notes Receivable From Participants**

Participants may borrow from their funded accounts a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000, reduced by any outstanding notes. Participants are limited to no more than one outstanding loan. Note terms range from one to five years for non-residential loans or are able to be extended up to 30 years for residential loans consistent with commercial home loan practices for the purchase of a primary residence. The notes are secured by the balance in the Participant's account and bear interest at a rate commensurate with local prevailing rates as determined by Lincoln Financial. Principal and interest are paid ratably through biweekly deductions made from the Participant's personal bank account. Interest rates on outstanding Participant loans ranged between 3.25% and 9.50% at December 31, 2024 and December 31, 2023, respectively.

#### **Payments of Benefits**

Upon termination of service, death, disability, or attainment of normal retirement at age 65, a Participant may elect to receive a lump-sum distribution, installment payments equal to the vested value of the Participant's account or transfer these amounts to another qualified retirement plan or individual retirement account. Participants may also take voluntary in-service withdrawals upon reaching age 59½, hardship withdrawals, and certain qualified active military duty if certain criteria are met as outlined in the Plan document. In addition, the Plan allows withdrawals where financial hardship can be demonstrated by the Participant as defined in the Plan document.

#### **Forfeited Accounts**

Given that the Plan is a Safe Harbor Plan and employees are always 100% vested, there are no forfeitures related to the Plan or Participant accounts.

#### **Plan Transfers**

Plan transfers represent account balances transferred to other plans, as described in Note 10.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting, except for benefits paid to participants, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by Lincoln Financial. See Note 4 for further discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan. As such, the guaranteed fund contract is stated at contract value on the accompanying statements of net assets available for benefits.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments, and the Plan Administrator deems the Participant's loan to be in default, the Participant's loan balance is reduced, and a benefit payment is recorded.

### **Contributions**

Employer and Participant contributions are accrued by the Plan in the year in which they are withheld from compensation or become obligations of the Company.

### **Payment of Benefits**

Benefit payments to Participants are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivables from Participants are charged directly to the Participants' accounts and are included in administrative expenses. Other income represents the portion of Participant contributions that are used to fund the administrative expenses of the Plan. Investment related expenses are included in net appreciation in fair value of investments.

**3. Information Certified by Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator obtained certifications from Lincoln Financial that the information provided to the Plan Administrator by Lincoln Financial related to the following information included in the accompanying financial statements and supplemental schedule required by ERISA is complete and accurate:

**4. Fair Value Measurements**

Fair value is defined as the price that will be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value is based on a three-level hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered Investment Companies**

Registered investment companies are valued at the quoted market prices of shares held by the Plan at year end in the active market on which the individual securities are traded.

**Collective Investment Trust**

The collective investment trust is valued at the NAV as reported by the investment manager at year end based upon audited financial statements. The fund's underlying assets consist of investment contracts and security-backed contracts.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully Benefit-Responsive Investment Contracts**

The Plan offers Participants the option to invest in the Lincoln Stable Value Account (“SVA”), a guaranteed interest contract, which is a fixed annuity contract issued by Lincoln National Life Insurance Company and is considered a fully-benefit responsive investment. The SVA is backed by the general account issuing company as such there are no specifically identifiable underlying assets. The SVA guarantees a fixed interest rate to Participants with a minimum of 1%. As described in Note 2, the value of the investment in the SVA is recorded at contract value, which represents the amount Participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing plan.

Withdrawals from the SVA to pay Participant benefits are made at contract value. Certain events may limit the ability of the Plan to transact at contract value at which time a surrender charge is applicable and market value adjustment or withdrawals are made in installment payments only over a period of time as elected by the contract holder. The Company does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with Participants, is probable.

**6. Related-Party and Party-in Interest Transactions**

Certain Plan investments are shares of the SVA managed by an affiliate of Lincoln Financial as defined by the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return of each fund. The Plan also issues loans to Participants, which are secured by the vested balances of the Participants’ accounts. As such, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. In addition, the Company provides certain accounting, recordkeeping and administrative services to the Plan for which it is not compensated.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will remain 100% vested in their accounts.

#### **8. Income Tax Status**

The Plan document is a prototype basic savings plan sponsored by LRSC. In a determination letter dated March 31, 2014, the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress, and the plan believes it is no longer subject to income tax examinations for years prior to 2021.

#### **9. Risks and Uncertainties**

The Plan utilizes various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **10. Plan Transfers**

On November 30, 2024, total assets of \$25,355,615 were transferred out of the Plan relating to Participants of Lumin Digital, LLC, as described in Note 1. This transfer included \$215,844 in notes receivable from participants.

On January 6, 2025, total assets of \$285,428,293 were transferred out of the Plan in conjunction with the merger of the Plan into the Velera Plan, as described in Note 1. This transfer included \$4,450,055 in notes receivable from participants. As described in Note 1, participants become eligible to participate in the Velera Plan effective January 1, 2025.
