NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Charles McMurray Company of Fresno 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Charles McMurray Company of Fresno (hereafter referred to as the Employer) who have completed six months of service, and during which worked at least 500 hours and are age 18 or older. Employees who do not satisfy the hours requirement during the six-month period will satisfy the eligibility service requirement if 1,000 hours are worked during either the twelve-month period beginning on the date of hire or the twelve month period upon each anniversary of the date of hire. The Plan was established on November 12, 1972. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustees are responsible for the oversight of the Plan and the appropriateness of the Plan's investment offerings. The Plan participants are responsible for monitoring the performance of investments in which they choose to allocate Plan contributions.

Contributions: Each year, participants may contribute up to the maximum amount allowable under Internal Revenue Service limits, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, classified as rollover contributions. The Plan has an automatic enrollment feature of 3% of compensation if the Plan participant fails to make a deferral election, with annual increases of 1%, up to a maximum rate of 10%. The Employer has elected to operate the Plan as a safe harbor 401(k) plan. For safe harbor matching contributions, the Employer contributes a matching contribution of 100% of the first 4% of the participant's salary reduction contributions for the Plan year. In addition to the safe harbor matching contribution, the Employer may make a matching contribution, qualified matching contribution, qualified nonelective contribution or a profit sharing contribution into the Plan. Employer matching contributions, qualified matching contributions, qualified nonelective contributions and/or employer profit sharing contributions are determined annually by the Employer and in an amount determined by Plan management. For both years ended December 31, 2024 and 2023, the Employer made a matching contribution in addition to the safe harbor matching contribution of 100% of the first 1% of the participant's salary reduction contributions for the Plan year. Profit sharing contributions are allocated using a pro rata formula, whereby the Employer's contribution is divided among all eligible Plan participants based on their compensation as compared to all eligible participants' compensation. For both years ended December 31, 2024 and 2023, the Employer made a profit sharing contribution totaling 5% of the participants' compensation. Contributions are subject to certain limitations. Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions, the Employer's contributions, an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

An individual account is maintained for each participant, which includes the following components:

1. Employee contributions
2. Employer contributions
3. The participant's pro rata share of net investment income
4. Deductions for benefits paid to participants

Vesting: Participants are vested immediately in their contributions, the Employer's safe harbor matching contributions, the Employer's qualified matching contributions, and the Employer's qualified nonelective contributions, plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of credited service.

Employer matching and profit sharing contributions are vested as follows:

- 20 percent: after two years
- 40 percent: after three years
- 60 percent: after four years
- 80 percent: after five years
- 100 percent: after six years

Participant loans: The Plan does not permit loans to participants.

Payment of benefits: On termination of service due to death, disability, retirement, or termination of service for other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan can elect to distribute account balances that are \$1,000 or less upon termination. The Plan will make a rollover or distribution for any amounts between \$1,000 and \$5,000 upon termination. Participant accounts with balances greater than \$5,000 are not required to take distributions from the Plan until the required minimum distribution rules apply. In service distributions and hardship withdrawals are not allowed according to Plan provisions.

Forfeited accounts: During the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$31,728 and \$13,870, respectively. Forfeited non-vested accounts can be used to reduce the Plan's administrative expenses or to reduce future employer contributions. At December 31, 2024 and 2023, there were \$32,646 and \$14,014, respectively, in forfeited non-vested accounts available. The employer matching contribution for the years ended December 31, 2024 and 2023, was reduced by \$32,646 and \$14,000, respectively, from forfeited non-vested accounts subsequent to year end. During the years ended December 31, 2024 and 2023, administrative expenses were reduced by \$122 and \$294, respectively, from forfeited non-vested accounts. Dividends, capital gains, and other income totaling \$782 and \$322, were realized on forfeited non-vested accounts during the years ended December 31, 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting: The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to interest in collective trust contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statements of Net Assets Available for Benefits is prepared using the contract value basis for collective trust investment contracts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Use of estimates: The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for the investments in collective trusts measured at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: All reasonable Plan administration expenses, including those involved in retaining necessary professional assistance, may be paid from the assets of the Plan. These expenses may be allocated among all of the Plan participants, or for expenses directly related to a specific participant (i.e. distribution fees, etc.), will be charged directly against the appropriate participant's account. The Employer may, in its discretion, pay any or all of these expenses. Expenses that are paid by the Employer are excluded from these financial statements. Certain fees related to the administration of the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in the fair value of investments.

Subsequent events: In compliance with accounting standards, management has evaluated events that have occurred after year-end to determine if these events are required to be disclosed in these financial statements. Management has determined that no events require disclosure in accordance with accounting standards. These subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

**NOTE 4 – INVESTMENTS**

The Plan provides that contributions to the Plan will be invested in certain individual programs offered by The Vanguard Group, Inc. (Vanguard) and as directed by each participant. Participants may change their investment options as desired.

**NOTE 5 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, and there have been no transfers between levels during the years ended December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 – INVESTMENTS AT CONTRACT VALUE**

The Plan offers a collective trust contract with Vanguard Retirement Savings Trust (the Trust). The Trust is a tax-exempt collective trust invested primarily in investment contracts issued by insurance companies and commercial banks, and similar types of fixed-principal investments. The trust intends to maintain a constant net asset value of \$1.00 per share. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

As described in Note 2, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the collective trust. The collective trust is presented on the face of the Statements of Net Assets Available for Benefits. Contract value, as reported to the Plan by Vanguard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value with certain limitations as defined. The contract values at December 31, 2024 and 2023, are \$622,985 and \$927,557, respectively.

**NOTE 6 – INVESTMENTS AT CONTRACT VALUE (continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain plan investments are shares of mutual funds managed by Vanguard. Vanguard is the trustee as defined by the Plan and, therefore, these investments and investment transactions qualify as party-in-interest transactions. Fees charged to the Plan for investment or management services by Vanguard were \$10,186 and \$11,304 for the years ended December 31, 2024 and 2023, respectively.

The owners of the Plan sponsor are participants in the Plan and, therefore, qualify as parties-in-interest. The Plan advisor is considered a party-in-interest. Fees paid to the Plan advisor were \$12,500 and \$12,500 for the years ended December 31, 2024 and 2023, respectively.

There were no transactions with any parties-in-interest that would be considered prohibited transactions by DOL regulations.

**NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their employer contributions.

**NOTE 9 – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC; therefore, the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 9 – TAX STATUS (continued)**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 10 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
