#### **NOTE 1. DESCRIPTION OF THE PLAN**

The following description provides only general information on the provisions of the **BELL FLAVORS & FRAGRANCES, INC. RETIREMENT SAVINGS AND PROFIT SHARING PLAN** (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **A. General**

The Plan is a defined contribution plan established by **Bell Flavors & Fragrances, Inc.** (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

##### **B. Eligibility and Participation**

All employees, except for residents of Puerto Rico, reclassified employees and leased employees, who have attained the age of 21, as defined in the Plan, are eligible to participate in employee contributions and employer matching contributions.

##### **C. Contributions**

Participants may elect to contribute up to 20% of their pre-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Upon meeting eligibility requirements, employees are automatically enrolled at a 3% deferral rate. Each subsequent year employees’ deferrals are automatically increased by 1% until they reach a 6% deferral rate. The employee may change, stop or resume deferring at any time. The Company will match 50% of employee salary deferrals that do not exceed 6% of compensation for the year ending December 31, 2024. The Company may also make a discretionary profit-sharing contribution. The maximum deferral and contribution are subject to Internal Revenue Code limitations.

##### **D. Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions and related employer matching contributions, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations are based on the participant’s eligible compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### **E. Notes Receivable from Participants**

A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance with a minimum loan amount of \$1,000. Loans are required to provide for level amortization with payments to be made not less frequently than quarterly, over a period not to exceed five years. The total participant loan balance outstanding as of December 31, 2024 and 2023 was \$932,151 and \$812,950, respectively. Interest rates are determined by the Plan Administrator based on prevailing market conditions and are fixed over the life of the loan.

##### **F. Vesting**

Participants are fully vested in their contributions. Participants who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested. Company discretionary matching and profit-sharing contributions are vested in accordance with the following schedule:

Vesting under the Plan is based upon the ‘hours of service’ method. The participant will receive a year of service upon completion of 1,000 hours of service during the Plan year.

##### **G. Benefits**

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of a participant’s account balance is distributed in the form of a lump-sum payment or partial withdrawals, with a minimum of \$1,000. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan.

##### **H. Forfeitures**

Participant forfeitures are used to reduce the Plan’s employer contributions and administrative expenses. In 2024 and 2023, forfeitures of \$34,971 and \$38,664 were used, respectively, to offset employer contributions and administrative expenses. At December 31, 2024 and 2023, the Plan had \$70,924 and \$49,535 in unapplied forfeitures, respectively.

#### **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **A. Basis of Presentation**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

##### **B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### **C. Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Participant loans are valued at the outstanding principal balances. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date.

##### **D. Notes Receivable from Participants**

Notes receivable from participants are measured at outstanding principal balance. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

##### **E. Payments of Benefits**

Benefits are recorded when paid.

##### **F. Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### **NOTE 3. FAIR VALUE MEASUREMENTS**

VALUATION OF INVESTMENTS – FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

LEVEL 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

LEVEL 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

LEVEL 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the daily closing price as reported by the fund. Pooled separate accounts held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The pooled separate accounts held by the Plan are deemed to be actively traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed income contract:* Valued at fair value which is equal to contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals, and fees.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 4. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company LLC, the Trustee, has certified that the following data included on accompanying financial statements and supplementary schedule is complete and accurate:

- a. Total investments and participant loans as shown on the accompanying Statements of Net Assets Available for Benefits were \$38,799,686 and \$37,106,470 as of December 31, 2024, and 2023, respectively.
- b. Total investment income (loss) and interest on participant loans as shown on the accompanying Statements of Changes in Net Assets Available for Benefits were \$3,977,790 and \$4,296,959 for the years ended December 31, 2024 and 2023, respectively.

Additionally, the Trustee certified all information on Schedule H, Line 4i – Schedule of Assets (Held at Year End) at December 31, 2024, which may be found on the supplementary schedule.

The Plan's Independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included on the related financial statements and supplementary schedule.

#### **NOTE 5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **NOTE 6. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan adopted accounting principles related to uncertain tax positions. Currently, the 2021, 2022 and 2023 tax years are open and subject to examination by the Internal Revenue Service and the Department of Labor. However, the Plan is not currently under audit nor has the Plan been contacted by either of these jurisdictions.

#### **NOTE 6. TAX STATUS – Continued**

The Plan has evaluated its tax positions taken for all open tax years. Based on the evaluation of the Plan's tax positions, the Plan Administrator believes all positions taken would be upheld under an examination. Therefore, no liability for the effects of uncertain tax positions was recorded at December 31, 2024 and 2023. Any interest and penalties recognized and associated with a tax position would be classified as other deductions on the Plan's financial statements. No such amounts were recognized in the years ended December 31, 2024 and 2023.

#### **NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported on the Statements of Net Assets Available for Benefits.

#### **NOTE 9. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company (“Prudential”) totaling \$4,686,319 and \$7,953,495 at December 31, 2024 and 2023, respectively. Prudential maintains the contributions in a general account.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction exemption under ERISA, or (4) premature termination of the contract. The Plan Administrator does not believe events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **NOTE 10. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Prudential Insurance Company of America. Prudential Insurance Company of America is the Trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

#### **NOTE 11. SUBSEQUENT EVENTS**

The Plan has evaluated events subsequent to December 31, 2024, for possible adjustment or disclosure to the accompanying financial statements. This evaluation was done through the date of the independent Auditor's Report, which is the date the financial statements were available to be issued.

Effective April 1, 2025, the Plan was amended to allow voluntary contributions, decrease the maximum deferral rate to 20% and change the maximum auto enrollment deferral percentage to 9%. The Plan also revised the definition of in service withdrawals.

Effective July 1, 2025, the Plan was amended to allow participants who have a zero deferral rate to affirm their election, otherwise they will be subject to auto enrollment.
