## INDEPENDENT AUDITORS' REPORT

*General.* The Plan consists of a defined contribution and tax deferred account plan. The Plan was established by American Christian Education Association, Inc. (the School) on November 1, 2004. Administrative staff and other employees of the School are eligible to participate in the Plan immediately upon employment. Instructional staff are eligible to participate in the Plan on September 30th after being employed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Participants may elect to defer a portion of their compensation to a 403(b) savings option, subject to certain limitations and exceptions. Participants may also contribute amounts representing distributions from other qualified retirements plans.

The School, in its sole discretion, may make a matching contribution in an amount determined by the School. Upon the age of 21, employees are immediately eligible to defer contributions and to receive matching contributions made by the School. The School makes matching contributions for elective deferrals and catch-up deferral. The School made matching contributions of employee deferrals up to 4% through August 2024. Effective September 2024, the School made matching contributions of employee deferrals up to 5%.

*Participant Accounts.* Each participant's account is credited with the participant's contributions, related School matching contributions, and Plan's earnings (losses) and charged with their benefits paid and an allocation of administrative expenses, if not paid by the School. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are 100% vested at all times in all accounts.

*Payment of Benefits.* Upon termination of service for any reason, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account. If the participant does not elect to receive a distribution, the vested account balance will be distributed after reaching normal retirement age. All participants entitled to receive a distribution of benefits under the Plan may elect to receive that distribution in a single lump sum. Hardship withdrawals are allowable in accordance with current Internal Revenue Service guidelines.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with U.S generally accepted accounting principles (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Variable Annuity Life Insurance Company (VALIC) and Empower Trust Company, LLC (Empower), the Custodian and Trustee. See Note 5 for discussion of fair market value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments that are exposed to various risks, such as interest rate, credit, and market volatility risks. Due to the levels of risk associated with certain investments, it is possible that changes in the value of investments may occur in the near term and that changes could materially affect the amounts reported in the statements of net assets available for benefits.

Benefits payable

Benefits are recorded when paid.

Administrative expenses

The School paid all administrative expenses of the Plan except for certain contract administrator fees.

Subsequent events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - PLAN ADMINISTRATION**

The Plan is administered by the School, which serves without compensation. The School is responsible for accurate books and records with respect to its employees for purposes of administering the Plan. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform these responsibilities. The Custodian and Trustee, VALIC and Empower, are appointed by the Plan Administrator. The Custodian and Trustee manage, invest, and reinvest the Plan's assets.

**NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AND TRUSTEE**

Certain information included in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, is certified as complete and accurate by the Custodian and Trustee.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts reported at contract value) in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 3 Fair Value Measurements*

The fixed annuity contracts are non benefit-responsive contracts and are reported at contract value, which approximates fair value. The value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. See Note 6 for additional information about investments at contract value.

**NOTE 6 - INVESTMENTS AT CONTRACT VALUE**

Certain contracts with Empower and VALIC meet the fully benefit-responsive investment criteria and therefore are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower and VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals.

The contract issuer groups the premium dollars it receives over defined time periods into vintages, typically composed of one or more contiguous calendar months, for the purpose of determining the crediting rate to participant's accounts. The crediting rate for each vintage is determined, in part, by the net investment earnings rate of the assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**NOTE 6 - INVESTMENTS AT CONTRACT VALUE (CONTINUED)**

The contract issuer is contractually obligated to repay the principal and a specified interest rate, generally 1%, that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. The contract issuer Board of Trustees may declare additional amounts on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month declaration year that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. The guaranteed investment contracts do not permit the issuer to terminate the agreement prior to the scheduled maturity date.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments include shares of mutual funds and other investment contracts managed by the Custodian and Trustee. Therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan for the contract administration services of Empower and VALIC amounted to \$19,036 for the year ended December 31, 2024.

**NOTE 8 - TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

**NOTE 10 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

As reported on the Supplemental Schedule of Delinquent Participant Contributions (Schedule H, line 4a), certain Plan contributions were not remitted within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt prohibited transactions between the Plan and the Plan sponsor for the year ended December 31, 2024. The Plan remitted all amounts due and owing the Plan during the Plan year and paid all accrued interest subsequent to the year ended December 31, 2024.
