## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
District 1199J - New Jersey Benefit Fund for  
Hospital and Health Care Employers

### Opinion

We have audited the financial statements of the District 1199J - New Jersey Benefit Fund for Hospital and Health Care Employers (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the District 1199J - New Jersey Benefit Fund for Hospital and Health Care Employers and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

The supplemental information is the responsibility of the Plan’s management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS**

DECEMBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF THE PLAN**

The following brief description of the District 1199J - New Jersey Benefit Fund for Hospital and Health Care Employers (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan was adopted pursuant to the authority of the Board of Trustees granted under the agreement and declaration of trust. The Plan is a welfare benefit plan covering employees of the employers having collective bargaining agreements (CBA) with District 1199J, the National Union of Hospital and Health Care Employees, AFSCME, AFL-CIO (the Union), and are required to make contributions to the Plan pursuant to those agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

A participant becomes eligible following 30 consecutive days of contributions by their contributing employer. New employers of a contributing employer must complete the waiting period specified in their employer's CBA before the contributing employer is obligated to begin making contributions on an employee's behalf.

**Benefits** - The Plan provides hospitalization, major medical, prescription drug, dental, optical, life insurance, weekly sickness and accident, accidental death and dismemberment, and behavioral health benefits to eligible participants. The Plan also provides certain benefits to eligible spouses and dependents of participants as well as retired participants and their spouses and dependents.

**Plan Amendments** - Effective June 1, 2021, the Plan was amended in an effort to mitigate cash flow concerns. Significant plan amendments are as follows:

- Spousal coverage will now require a \$250 per month participant contribution.
- Prescription drug coverage will be eliminated for retirees age 65 and over.
- Medicare Part B reimbursements were suspended through December 31, 2021.
- Coinsurance and annual deductibles are now required.
- Maximum death benefit for retirees will be \$10,000.

Effective December 31, 2021, the Plan was amended as follows:

- Medicare Part B reimbursements were suspended into 2022 and thereafter until such time the Trustees determine the benefit should be reinstated.
- Participant will cease being eligible for coverage at the end of the calendar month in which the event causing participant to be ineligible occurs.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting.

**Investments** - Investments are carried at fair value. Short-term investments are valued at cost, which approximates fair value.

Purchases and sales are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Employer Contributions Receivable** - Employer contributions due and not paid at year end are recorded as contributions receivable. Allowance for credit losses is considered unnecessary and is not provided.

**Property and Equipment** - Property and equipment are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation is computed over the estimated useful lives for furniture and fixtures of 5 to 10 years by the straight-line method.

Depreciation expense totaled \$1,941 for the year ended December 31, 2023. Property and equipment was fully depreciated as of December 31, 2023.

**Payments of Benefits** - Benefit payments to or for participants are recorded when paid.

**Claims Incurred but not Reported** - Claims incurred but not reported at year end were estimated by the Plan's consultant based on claims experience.

**Stop Loss Coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Leases** - The Plan is required to recognize a right-of-use model (ROU) asset and lease liability on the statement of net assets available for benefits for all leases with a term longer than 12 months. ROU assets represents the lessee's right to control the use of the leased asset during the lease. Leases will be classified as finance or operating, with classification affecting the pattern and classification of expense recognition in the consolidated statement of activities. Lease liabilities represent the present value of the future lease payments over the expected lease term. The present value of the lease liability is determined using the incremental borrowing rate at the lease inception. Over the lease term, the Plan uses the effective interest rate method to account for the lease liability as lease payments are made and the ROU asset is amortized into expenses in a manner that results in a straight-line expense recognition in the statement of changes in net assets available for benefits. The Plan has determined the lease identified as an operating lease.

**NOTE 3. FUNDING**

The Plan is financed by employer contributions, participant contributions and contributions from participants electing COBRA coverage. The employer and participant contribution rates are specified in collective bargaining agreements.

**NOTE 4. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect, however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

**NOTE 5. TAX STATUS**

The Plan obtained its latest exemption letter dated June 16, 1993 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(c)(9). The Plan has been amended since receiving the exemption letter. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

## **NOTE 5. TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

## **NOTE 6. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

## NOTE 6. FAIR VALUE MEASUREMENTS (continued)

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

All of the above entities qualify as tax-exempt organization.

The entities listed above share common trustees or officers with this plan.

Plan investments are managed by the custodian, Principal. Therefore, transactions of these investments qualify as party-in-interest transactions. These investments and related transactions have been denoted as such on the supplemental schedules of assets held at end of year and reportable transactions.

**NOTE 7. RELATED PARTY TRANSACTIONS (continued)**

**Common Administrative Expenses**

The related Funds share administrative services and staff. Joint administrative expenses are initially paid by the Pension Fund. Joint administrative expenses are allocated on a basis approved by the Plan's Trustees. The amount allocated to the Plan for its share of administrative expenses for the years ended December 31, 2024 and 2023 was \$1,347,301 and \$1,314,777, respectively.

As of December 31, 2024 and 2023 the Plan owed \$101,437 and was owed \$135,254, respectively, from the Pension Fund, for its balance of shared administrative expenses.

**Shared Occupancy**

The Plan leases space from a related entity, District 1199J - New Jersey Pension Fund Title Holding Company. On February 1, 2022 the Plan entered into a new lease which expires on January 31, 2027. The Plan's rent expense for the years ended December 31, 2024 and 2023 was \$135,920 and \$153,391, respectively.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 8. POSTRETIREMENT BENEFIT OBLIGATIONS**

The Plan provides certain health care coverage to eligible retirees and their dependents.

Accounting principles generally accepted in the United States of America require that the Plan include the actuarial present value of postretirement benefit obligations in the benefit obligations of the Plan.

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

The following are significant assumptions used in the postretirement benefit obligation valuations as of December 31, 2024 and 2023:

Mortality:

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rate increased by one percentage point, that would increase the obligation as of December 31, 2024 and 2023 by \$70,000 and \$96,000, respectively.

**NOTE 11. FEES MANDATED BY THE PATIENT PROTECTION AND AFFORDABLE CARE ACT**

The Plan is subject to certain fees mandated by the Patient Protection and Affordable Care Act. Fees payable to the Patient-Centered Outcomes Research Institute (PCORI) are equal to \$3.22 and \$3.00 per covered life for the 2024 and 2023 calendar years, respectively. For the years ended December 31, 2024 and 2023, the Plan paid \$10,193 and \$15,453 in PCORI fees, respectively.

**NOTE 12. LEASES**

The Plan has an operating lease for their office space. The lease has a remaining lease term of four years. The Plan has elected to use the incremental borrowing rate as the discount rate for the leases.

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, sector, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**NOTE 13. RISKS AND UNCERTAINTIES (continued)**

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 14. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
