To the Plan Sponsor and Administrator
Guaranteed Returns 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Guaranteed Returns 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Guaranteed Returns 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Guaranteed Returns 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Substantial Doubt about the Plan's Ability to Continue as a Going Concern

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Notes 1 and 2 to the financial statements, the Plan sponsor, Devos Ltd. D/B/A Guaranteed Returns, is experiencing significant financial difficulties and is in the process of winding down its operations. Although the Plan sponsor does not currently intend to terminate the Plan, the Plan sponsor can no longer support the Plan's operations, or any make any further contributions to the Plan. Management's evaluation of the events and conditions and management's plans regarding those matters are also described in Note 1 to the financial statements. Due to the Plan's relationship with the sponsor, there is substantial doubt about the Plan's ability to continue as a going concern. In accordance with the Plan document, in the event of termination the Plan's participants should receive all vested account balances. The financial statements do not include any adjustments that might result from the outcome of this uncertainty. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Guaranteed Returns 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Guaranteed Returns 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of Guaranteed Returns 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Impact of Plan Sponsor Financial Status and Inability to Support the Plan

The Plan sponsor, Devos Ltd. D/B/A Guaranteed Returns, is experiencing significant financial difficulties and is in the process of winding down operations. Although the Plan sponsor does not currently intend to terminate the Plan, the Plan sponsor cannot support the Plan’s operations or any make any further contributions to the Plan. As of October 10, 2025, the Plan sponsor has sold off a significant amount of its assets and has limited operations. The Plan is dependent on the Sponsor for administration of the Plan and funding the employer matching contributions; accordingly, the Plan cannot continue without the support of the Plan sponsor. See Note 2.

General

The Plan was established on January 1, 1993, as a defined contribution plan covering all eligible employees of Devos Ltd. D/B/A Guaranteed Returns (the “Company”). The Plan covers employees of the Company who have completed three months of service and are over the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Participant Salary Deferral

Participants in the Plan may contribute a discretionary amount of their annual compensation provided that the participant’s contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (“IRS”) each year, which is \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Employees over the age of 50 can elect to contribute an additional \$7,500, for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in the default investment alternatives until changed by the participant. The amount to be automatically withheld will increase by 1% each plan year until the amount withheld reaches 10% of compensation or the deferral election is changed by the participant.

Employer Contributions

The Company made safe harbor contributions amounting to \$74,659, for the year ending December 31, 2024. Effective August 15, 2024, the Plan was amended to eliminate employer matching contributions, including safe harbor nonelective contributions. The amendment does not affect safe harbor nonelective contributions eligible employees have earned under the Plan prior to the effective date of the amendment.

Additional discretionary profit-sharing amounts may be contributed at the option of the Company’s Management. Company contributions are subject to certain limitations. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Vesting

Participants are immediately vested in their contributions as well as the safe harbor contributions plus actual earnings thereon. Participants vest in the Company's profit sharing contributions plus actual earnings thereon based on the following schedule:

Participant Accounts

Individual participant accounts are credited with applicable participant contributions and the Company's contributions; plus an allocation based on each participant's compensation and account balance of the Company's profit-sharing contribution, forfeitures of terminated participants' nonvested benefits, and the Plan's net earnings. Allocations are based upon participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of their account. The Plan allocates participant forfeitures to pay administrative expenses of the Plan with any remaining amounts used to reduce the employer contributions otherwise made for the Plan year in which the forfeiture occurs. There were no forfeitures used to reduce the employer contribution for the years ended December 31, 2024 and 2023. The forfeiture account totaled approximately \$8, as of December 31, 2024 and 2023.

Investment Options

Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as well as a common/collective trust as investment options for participants. For participants who do not make an investment election, the accounts will be invested in accordance with the default investment alternatives established by the Plan.

Distributions

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 65 (ii) termination of employment, (iii) death or permanent disability, and (iv) a proven hardship. Distributions from a participant's account are made in the form of a lump-sum payment, installment payments or partial distributions. If a participant's account balance does not exceed \$5,000, the distributions can only be made in the form of a lump-sum payment and may be distributed to a terminated participant without consent.

Notes Receivable from Participants

In general, the plan administrator may permit participants to borrow from their fund accounts, up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance, which is the amount limited under the Internal Revenue Code ("IRC").

Loans are secured by the balance in the participant's account and bear interest at 1% above the prime interest rate and carry a maximum maturity of five years. In cases where the loan is used to acquire principal residences, the maturity may exceed five years. Loans are repaid through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Going Concern Uncertainty

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America. The financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 1 of the Plan's financial statements, Devos Ltd. D/B/A Guaranteed Returns, the Plan Sponsor has experienced significant financial difficulties and is unable to continue supporting the Plan. The Plan sponsor may discontinue contributions and terminate the Plan in accordance with the Plan provision and ERISA without any liability for such discontinuance or termination. It is uncertain what effect these matters may have on the Plan. These uncertainties raise substantial doubt about the Plan's ability to continue as a going concern. In accordance with the Plan Document, in the event of termination, the Plan's participants should receive all vested account balances. The accompanying financial statements do not include any adjustments that may result from the outcome of these uncertainties.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Dividends are recorded on the ex-dividend date. Interest income is included in income when earned, based on the terms of the investments and the periods during which the investments are owned. Purchases and sales of securities are recorded on a trade-date basis.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits the net change in the fair value of its investments which consists of realized gains or losses, and unrealized appreciation or depreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of the Plan income and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

CARES Act

In March 2020, the COVID-19 outbreak was declared a pandemic by the World Health Organization. The COVID-19 pandemic has led to increased volatility in financial markets. The extent to which such increased volatility will impact the value of the Plan assets will depend on future developments that are highly uncertain and cannot be predicted.

3. Information Prepared and Certified by the Trustee of the Plan as Complete and Accurate

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. John Hancock Trust Company LLC, the trustee of the Plan has certified that the following data included in the accompanying financial statements is complete and accurate.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held, during the period) appreciated in fair value by \$818,449.

4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification ("ASC") No. 820, *Fair Value Measurements and Disclosures* ("ASC 820"), provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common collective trusts: Valued at NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Management has evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers.

5. Related Party Transactions

The Company administers the Plan from its office. Certain Plan investments are managed by John Hancock Trust Company LLC, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to approximately \$50,000, for the year ended December 31, 2024, and are included in administrative fees, on the Statement of Changes in Net Assets Available for Benefits.

6. Tax Status

The Internal Revenue Service ("IRS") has determined by a determination letter dated June 30, 2020, stating that the underlying non-standardized pre-approved profit sharing/money purchase/CODA plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator has determined the Plan is eligible to and has chosen to rely on the current IRS prototype plan letter. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine

audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.

9. Subsequent Events

The Plan has evaluated subsequent events for possible recognition or disclosure in the financial statements through October 10, 2025, the date the financial statements were available to be issued.

In October 2025, the Plan Sponsor made a decision to terminate the Plan. The Plan is expected to terminate prior to December 31, 2025.
