We have performed audits of the financial statements of NSM Insurance Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### **(1) Description of Plan**

The following description of the NSM Insurance Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution profit sharing plan covering all eligible employees of NSM Insurance Services, LLC (the Company), who have completed 30 days of service and are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustee and plan administrator are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

##### ***Transfers Out of Plan***

On February 1, 2024, net assets related to Embrace Pet Insurance (Embrace) participant balances of approximately \$9,500,000 were transferred out of the Plan as a result of the Company's divestiture of Embrace.

##### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to the maximum allowable under Internal Revenue Code (IRC) guidelines. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. The Plan includes a Qualified Contribution Arrangement (QACA), whereby 5% of the participants' compensation will be deferred unless the participant makes a contrary election. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary employer matching contributions each plan year. During 2024 and 2023, the Company made a safe harbor matching contribution based on 100% of the first 3% of participant deferrals. During 2024 and 2023, the Company made a profit-sharing contribution generally based on 1.50% of eligible employees' compensation.

Effective March 1, 2021, participants may make deferrals to the Plan on an after-tax basis in accordance with the Roth provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001.

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### (1) Description of Plan, Continued

##### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portions of their accounts is based on years of service according to the following schedule:

Years of Service	Vested Percentage

1	25%
2	50%
3	75%
4	100%

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance. The maximum loan term is five years, unless the loan is acquired for the purchase of the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 10.25%, which are commensurate with local prevailing rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant or survivor may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or an annuity.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$100,336 and \$235,294 respectively. Forfeited accounts may first be used to pay administrative expenses and then used to reduce future Company contributions. During 2024 and 2023, forfeitures of \$316,997 and \$40,850, respectively, were used to reduce Company contributions and pay administrative expenses.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee and plan administrator determine the Plan's valuation policies utilizing the information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by the Custodians

Certain information related to investments disclosed in the accompanying financial statements and Schedule H, Line 4i- Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (Principal) and Lincoln Financial Group Trust Company, Inc. (Lincoln), qualified institutions. Principal held the Plan's investment assets as of December 31, 2023 and executed investment transactions for the period January 1, 2023 to June 28, 2024. Lincoln held the Plan's investment assets as of December 31, 2024 and executed investment transactions for the period June 29, 2024 to December 31, 2024.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units held by the Plan at year end based on the fair value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market.

*Common collective trust:* Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Guaranteed investment contract:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. In determining the reasonableness of the methodology, the Plan's trustee and plan administrator evaluated a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain observable inputs are assessed through review of contract terms (for example, duration or payroll date) while others are substantiated utilizing available market data.

#### **(5) Investment Contract with Insurance Company**

The Plan maintained group annuity contracts with Principal through the guaranteed interest accounts until the assets were transferred to Lincoln. The annual crediting interest rate and average yield for the guaranteed interest accounts for the year ended December 31, 2023 ranged from .56% to 4.83% and .58% to 4.38%.

#### **(6) Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of registered investment companies, pooled separate accounts, common collective trust, and stable value fund managed by Lincoln and Principal. Principal and Lincoln are the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The plan sponsor pays directly certain other fees related to the Plan's operations.

Under an agreement with Lincoln, the Plan is a beneficiary of a reduction of a portion of the Plan's registered investment companies' fees, which are rebated to the Plan. During 2024, rebate income received by the Plan amounted to \$12,500 and was used to pay plan expenses or allocated to participants as earnings, in accordance with the agreement.

#### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

#### **(8) Tax Status**

The Plan adopted a non-standard form of a prototype plan document sponsored by Limestone Pension Associates, LLC. The prototype plan has received a letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting policies generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


