Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of First National Bank of Michigan 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the 2022 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, amount other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Assets Held for Investment Purposes at End of Year is presented for purposed of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A – Plan Description

The following description of the First National Bank of Michigan 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution retirement plan available to eligible employees of First National Bancorp, Inc. (the Company). The Plan was established January 1, 2006, and was amended and restated October 1, 2023. The Company is the Plan administrator. Employees of the Company who are U.S. residents, are not covered by a collective bargaining agreement, and are at least 18 years old are eligible to participate in the Plan's elective deferrals and matching contributions. Employees who have completed one year of eligibility service (1,000 hours of service) in addition to the previous requirements, will be eligible to receive any discretionary non-elective profit-sharing contributions from the Plan. Upon attaining the eligibility requirements, participants are automatically enrolled in the Plan under the Plan's automatic 5% deferral provision until such time as a participant modifies their deferral percentage or elects not to defer compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan Sponsor and named Plan Administrator is First National Bancorp, Inc. (the Company). The Plan administrator is responsible for the oversight of the Plan. The Plan administrator's management determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees.

Greenleaf Trust is the Plan's trustee and invests all employee and employer contributions, as well as earnings thereon, pursuant to the terms of the Plan.

Contributions

Each employee who enrolls as a contributing participant may specify whether their elective deferrals are to be pre-tax qualifying elective deferrals, Roth elective deferrals, or a specified combination. Participants may contribute the maximum percentage allowable to the extent such percentage does not exceed the annual dollar limits established by law. Participants who have obtained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company contributes a safe harbor matching contribution equal to 100% of the first 3% of plan compensation deferred plus 50% of 3-5% of plan compensation deferred. Contributions are accumulated and invested, as directed by participants, in a trust fund held by the trustee, Greenleaf Trust. The Company may make a discretionary non-elective profit-sharing contribution to the Plan as determined by its board of directors. For 2024 and 2023, the Company did not make a profit-sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of net Plan earnings and administrative expenses. Allocations are based on the participant's account balance as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A – Plan Description (Continued)

Vesting

Participants are immediately vested in their contributions, employer matching contributions, and any income thereon. Should the Company choose to make a profit-sharing contribution, participants become 20% vested after 2 years, 40% vested after 3 years, 60% vested after 4 years, 80% vested after 5 years, and 100% vested after 6 years. Participant accounts are distributed without regard to the vesting provisions in the event of death, permanent disability, or upon retirement while employed at the Company in accordance with Plan provisions.

Investments

Participants may direct the investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers a money market fund and several mutual funds as investment options. Additionally, in accordance with Plan provisions, participants may segregate their accounts and direct their investment options into investments of their choosing.

Payment of Vested Benefits

On termination of service, participants with vested account balances of \$1,000 or less are subject to forced cash-outs, in which automatic distribution of their account balance will occur. Participants whose vested balance is between \$1,000 and \$5,000 will automatically have their vested balance rolled over to an IRA selected by the Plan Administrator unless the participant consents to a lump sum by timely returning a completed election form. Participants whose vested account balances exceed \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments, or partial withdrawals. For termination of service upon early retirement, a participant electing to withdraw his account will receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan provides that participants may elect to withdrawal their balances upon the attainment of retirement age, as defined in the Plan.

Administrative Expenses

Administrative expenses are paid from the assets of the Plan.

Tax Status

The Plan is utilizing a pre-approved plan document with a restatement effective date of October 1, 2023, which has been filed with the IRS and has received a favorable opinion letter dated June 30, 2020 from the IRS stating that the Non-standardized Prototype 401(k) Profit Sharing Plan and Trust (the prototype plan of Greenleaf Trust upon which the Plan is based) qualifies under Section 401(a) of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to income tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan was amended and restated on October 1, 2023. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will be fully vested and non-forfeitable.

NOTE B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the use of management's estimates. These estimates affect the amounts reported in the financial statements and the disclosures provided. Actual results may differ from management's estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are stated at fair market value. Fair value is the price that would be received from an asset sale or paid to resolve a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

Management has performed a review of events subsequent to the statement of net assets available for benefits date through October 2, 2025, the date the financial statements were available to be issued.

NOTE D – Fair Value Measurements and Disclosures

FASB codified accounting standards for Fair Value Measurements and established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts are valued at net asset value (NAV) based on the last reported sales price of the underlying investments held and the number of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value.

The Plan's investments as of December 31, 2023 include pooled separate accounts, which are measure at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that are measured as such are not classified on the fair value hierarch.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – Party-In-Interest Transaction

Plan investments in the segregated account were managed by Greenleaf Trust, who is the Plan trustee and, therefore, a party in interest. The Plan paid the trustee approximately \$40,000 in administrative fees in the year ended December 31, 2024. Additionally, fees were netted with investment income and paid through revenue sharing.

The United States Department of Labor requires all transactions in excess of 5% of the current value of the Plan's net assets for non-participant-directed investments to be disclosed separately in the financial statements as a reportable transaction. As the Plan's investments are participant-directed, there were no reportable transactions for the year ended December 31, 2024.

NOTE F – Investment Risks and Uncertainties

The Plan's investment securities have exposure to various risks such as interest rate risk, financial market risk, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that any such changes could materially affect the value of investment securities reported in the Plan's financial statements.
