Opinion

We have audited the financial statements of Bulab Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Bulab Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Bulab Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

Bulab Holdings, Inc. (the “Company”) established the Plan effective January 1, 1994. The Plan operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by Bulab Employee Stock Ownership Committee appointed by the board of directors of the Company.

Employees of the Company are eligible to participate in the Plan after completing 1,000 hours of service, as defined, during the participant’s first year of employment provided the participant is employed on December 31 of the first year of employment. Only participants who have completed a year of service during the plan year and are actively employed on the last day of the plan year are eligible for an allocation of Company contributions for the year.

Each participant is entitled to exercise certain voting rights attributable to the shares allocated to his or her account as specified in the plan document. The Plan trustees generally vote the entire block of stock.

Contributions

Company contributions are determined at the discretion of the Board of Directors of the Company. Contributions by participating employees are not permitted. Contributions are allocated to participant accounts in proportion to the ratio that each participant’s compensation (within plan limitations) bears to the aggregate compensation of all participants for that plan year.

Vesting

If a participant’s employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service to the company.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Plan provides for time restricted put option for participants or former participants receiving distributions of the Company stock. The purpose of the put option is to ensure that the participants can ultimately obtain cash.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of the Company contributions and forfeitures of terminated participants' non vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to their account. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution which is transferred to the BULAB Profit Sharing and 401(k) Plan.

Forfeitures

Shares forfeited during the year by non-vested employees are allocated at the end of each year to active participants in proportion to the ratio that each participant's compensation (within Plan limitations) bears to the aggregate eligible compensation of all participants for that plan year. Forfeitures with an aggregate fair value of \$84 in cash and 36.6688 in shares of company stock were allocated to participants for the year ended December 31, 2024. Forfeitures with an aggregate fair value of \$635 in cash and 88.6125 in shares of company stock were allocated to participants for the year ended December 31, 2023.

Payment of Benefits

Upon termination of service by death, permanent disability, or normal retirement (as defined by the Plan), the participant or the participant's beneficiary may elect to receive their vested account balance in cash or in whole shares of Company stock (at the request of the participant or beneficiary) with the value of any fractional shares paid in cash. Plan benefits are distributed in a single lump sum or equal installments in accordance with the Plan's provisions. Distributions of cash to participants are computed at the fair value of the stock at the date of distributions. Fair market value of Bulab Holdings, Inc. stock is determined annually.

Administrative Expenses

As provided in the plan document, administrative expenses may be paid either by the Plan or the Company. Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are reported on the accrual basis of accounting.

The Plan's investments are stated at fair market value, as defined by generally accepted accounting principles. See Note 4 for disclosure of fair value measurement.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Contributions receivable is recorded at the estimated net realizable value. An allowance for credit losses is recorded based upon management's estimate of expected credit losses, determined by using subsequent collections. Management has determined that an allowance for credit losses is not considered necessary as of December 31, 2024.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits are recorded when paid.

Date of Management's Review

The plan sponsor evaluated the Plan's December 31, 2024 financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued. Other than the events mentioned in Note 10, the plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

The stated fair values of \$198.08 and \$166.60 per share utilized at December 31, 2024 and 2023, respectively, are based on independent valuations using financial information through December of each year. All shares of stock held by the Plan have been allocated to participant accounts.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Fixed income securities: The Company utilizes a third-party pricing service to determine the fair value of each of these investment securities that includes certificates of deposit and municipal bonds for which quoted prices are not available in active markets for identical instruments.

Bulab Holdings, Inc. common stock: The fair value of the Company's common stock held by the Plan is reported at fair value upon an appraisal. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. Plan management reviews the appraisal prior to its completion. This appraisal was based upon a combination of income and market valuation techniques consistent with prior years.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities, including the Company's common stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 6 - PLAN TERMINATION

The Board of Directors of the Company has the right under the Plan to terminate the Plan subject to Plan provisions. In the event of plan termination, participants will become 100 percent vested in their accounts, and the Trustees shall direct the distribution of the assets of the trust fund to participants in accordance with the Plan provisions and the IRC.

NOTE 7 - FEDERAL INCOME TAX STATUS

The IRS issued a determination letter on July 29, 2014 that the Plan qualifies under the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

NOTE 8 - SEPARATED PARTICIPANTS

At December 31, 2024, the Plan's assets included \$32,754 in benefits allocated to withdrawing participants for benefit claims that have been processed and approved for payment prior to year-end, but not yet paid as of that date. No additional employer contributions to these accounts are allowed, nor do the separated participants continue to increase the vested portion of their account.

NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets, which consist principally of the sponsor Company's common stock, are considered to be party-in-interest investments. Plan expenses that are directly paid by the Company also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provisions of ERISA and the Internal Revenue Code.

NOTE 10 – SUBSEQUENT EVENTS

On February 28, 2025, the Plan Sponsor entered into a Merger agreement in which the Company was to be acquired. As a term of that agreement, the BULAB Employee Stock Ownership Plan was required to be terminated effective as of the closing date of the acquisition, which was July 1, 2025. On this date, all participants became fully vested in their account balances under the ESOP, and all ESOP participants', former participants', and beneficiaries' account balances shall be distributed in accordance with the terms of the ESOP termination amendment. 70% of each Participants' cash account balance was distributed in a single lump sum from the plan immediately following the termination of the Plan. The remaining Participant balances are to be distributed as soon as practicable following the date the determination letter issued by the Internal Revenue Service is received indicating that the termination of the ESOP does not adversely affect the Plan's qualified tax status.
