Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

1. Description of Plan

The following description of the Myco Mechanical, Inc. 401k Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering substantially all employees of Myco Mechanical, Inc. (the "Company") who are age 18 or older, unless specifically excluded. Participants should see the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may elect to voluntarily contribute up to the lesser of 100% of pretax compensation or \$23,000 in a calendar year, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of the first 3% of base compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Company made employer matching contributions in the amount of \$843,303. Contributions are subject to certain IRS limitations. Contributions to the Plan are recorded in the period that payroll is taken from Plan participants. Employer matching contributions are recorded based on employee contributions during the period.

The Plan also allows prevailing wage contributions to be made to participants. The Plan sponsor will make these contributions to help satisfy fringe benefit requirements of the law. Participants will receive this contribution based on the work they perform during the plan year that is subject to the law. Participants who receive this contribution will be 100% vested. Highly compensated employees are not eligible to receive prevailing wage contributions. During the year ended December 31, 2024, the Company made prevailing wage contributions of \$3,374,438.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are vested immediately in their contributions and employer matching contributions, plus actual earnings thereon.

Payment of Benefits

On separation from service for any reason except death, a participant may elect to receive a lump-sum amount equal to the value of his or her account. If a participant dies before payments begin as specified above, the entire account balance shall be paid to their beneficiary or their estate if no individual is named as beneficiary. The Plan also provides for hardship withdrawals.

Participant Loans

Participants may borrow only from their salary deferral contributions and rollover contributions up to a maximum \$50,000 or 50% of their elective account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$176 and \$63, respectively. These accounts will be used to reduce future employer contributions and administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with Financial Accounting Standards Board Accounting Standards Codification for Defined Contribution Plans ASC 962.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Fair Value Accounting

Valuation techniques used in fair value measurements need to maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. Assets and liabilities measured at fair value are categorized into one of three different levels depending on the observability of the inputs employed in their measurement. Level 1 inputs are quoted prices in active markets for identical assets or liabilities. Level 2 inputs are observable inputs other than quoted prices included within Level 1 for the asset or liability, either directly or indirectly through market-corroborated inputs. Level 3 inputs are unobservable inputs for the asset or liability, including the Plan's own assumptions in determining the fair value of the assets or liabilities. See Note 3 for discussion of fair value measurements.

Allowance for Credit Losses

When the Plan records contributions receivables, the Plan records an allowance for credit losses for the current expected credit losses (CECL) inherent in the asset over its expected life. The allowance for credit losses is a valuation account deducted from the amortized cost basis of the assets to present their net carrying value at the amount expected to be collected. Each period the allowance for credit losses is adjusted through earnings to reflect expected credit losses over the remaining lives of the assets. The Plan evaluates participant loans to determine whether any of the losses arise from concerns about the underlying collateral and record an allowance for credit losses, if required.

Contributions

Contributions to the Plan are recorded in the period that payroll is taken from Plan participants. Employer matching contributions are recorded based on employee contributions during the period.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions in 2024.

3. Fair Value Measurements

Money market funds are valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Mutual Funds are valued at quoted market prices, which represent the Net Asset Value (NAV) per share at the close of the financial markets. The NAV is based on the value of the underlying assets owned by the investment, minus its liabilities and then divided by the number of shares outstanding. Mutual funds report NAV daily and are required to transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Certain Plan investments are shares of mutual funds or common/collective trusts managed by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company's contributions.

7. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Tax Status

The Plan uses a pre-approved plan document sponsored by Ascensus Trust Company, dated June 30, 2020, stating the form of the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan continues to be tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal Form 5500 for years before 2021.

9. Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Ascensus Trust Company, the Trustee, has certified to the completeness and accuracy of all investments reported in the accompanying Statement of Net Assets Available For Benefits as of December 31, 2024 and 2023, and the supplemental Schedule of Assets (held at end of year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available For Benefits for the year ended December 31, 2024.
