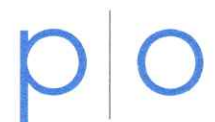

INDEPENDENT AUDITOR'S REPORT

TO MANAGEMENT OF NORDEX USA 401(k) PLAN:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nordex USA 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

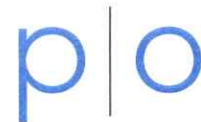

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

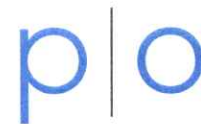

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN:

The following description of Nordex USA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is sponsored by Nordex USA, Inc. The purpose of the Plan is to allow eligible employees to accumulate funds on a tax-deferred and post-tax basis, thereby promoting future retirement security.

The Plan is a defined contribution plan covering all eligible employees of the Company. Employees become eligible for participation in the Plan on the first day of the month following completion of one month of service. Each participant has a separate account to which employer contributions, individual participant contributions, investment income and loss, and forfeitures are allocated in accordance with Plan provisions. The Plan consists of a discretionary profit-sharing feature and a 401(k) pay deferral plan with annual discretionary employer matching contributions.

All of the Plan’s assets are held in a trust fund which is the sole source of all benefit payments. The assets of the trust fund are not commingled with Company assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute to the Plan as 401(k) salary contributions of up to 80% of their eligible compensation, not to exceed a specific dollar amount determined by the Internal Revenue Service. For 2024, the dollar amount is \$23,000. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the company may make a discretionary matching contribution. The Company matched 100% of employee contributions up to 3% of compensation plus 50% of contributions between 3% and 5% of compensation for the year ended December 31, 2024.

Profit-sharing contributions are discretionary and are only made each year the Company decides to do so. There was no profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contributions, and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF THE PLAN (Continued):

Vesting

Participants are immediately vested in their voluntary and rollover contributions, as well as all safe harbor, employer matching and profit-sharing contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum amount equal to the lesser of: a) 50% of the value of the vested portion of the participant's total accrued benefits, or b) \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined periodically by the Plan administrator. All loans must be repaid by an assignment of wages sufficient enough to repay the loan and the accumulated interest within five years from the date the participant receives the loan from the Plan. A longer repayment period may be granted by the Trustees only if the loan is used to purchase or repair a primary residence.

All loans must be repaid on or before the participant reaches their normal retirement date. If the participant otherwise stops working for the company, the loan must be repaid in full within a reasonable amount of time as determined by the plan administrator, or the balance of the loan will be considered a distribution and the participant will become responsible for any taxes and penalties due as a result of the distribution.

Payment of Benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount, in annual installments over a period not longer than the participant's life expectancy, or a direct rollover distribution.

Other Withdrawals

The Plan permits hardship withdrawals from 401(k) contributions. Hardship is defined as an immediate and heavy financial need of the Participant when lacking other available resources. Financial needs considered immediate and heavy include, but are not limited to expenses incurred or necessary for medical care (as described in Section 213(d) of the Internal Revenue Code) of the Employee, the Employee's Spouse or dependents; the purchase (excluding mortgage payments) of the principal residence for the Employee; payment of tuition and related educational fees for the next 12 months of post-secondary education for the Employee, the Employee's spouse, children or dependents; the need to prevent the eviction of the Employee from, or a foreclosure on the mortgage of, the Employee's principal residence; or funeral expenses of a member of the Participant's family.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Significant accounting practices and policies followed in the preparation of the accompanying financial statements are as follows:

Method of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reported period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's assets are primarily stated at fair value as determined by quoted market prices. Its investments in participant loans are stated at cost which approximates fair value. Interest income is recorded on the accrual basis. Unrealized appreciation or depreciation in the fair value of investments held at year-end and realized gains or losses on sales of investments during the year are determined using the beginning of the year fair value or purchase price if acquired subsequent to that date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Net Appreciation (Depreciation) in the Fair Value of Investments

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Operating Expenses

Fees and expenses of the Plan are allocated among and charged to, individual participants' accounts. The employer absorbs significant costs of plan administration.

3. CERTIFICATION OF FINANCIAL INFORMATION:

The following financial data included in the accompanying financial statements and supplemental schedules as of and for the years ended December 31, 2024 and 2023 has been certified as complete and accurate by Fidelity Management Trust Company, the trustee of plan assets, and had not been audited by the independent auditors for the Plan: investments, notes receivable from participants, net appreciation in fair value of investments, investment income, interest from participant notes receivable and the schedule of assets (held at end of year).

4. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosure*, ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies: Investments in registered investment companies are based on quoted net asset values of the shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS:

The plan document is on a prototype document, which has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. Employers who utilize an IRS approved prototype document for its qualified plan, and who do not alter the provisions offered in that IRS approved document, will generally have automatic reliance that the form of the plan satisfies the qualification requirements. The plan administrator believes that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. CONCENTRATIONS:

Of the investments in registered investment companies, one investment has an individual balance over 10% of the total net assets available for benefits.

7. PARTY-IN-INTEREST TRANSACTIONS:

Parties in interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others.

All plan investments at December 31, 2024 were shares of registered investment companies (mutual funds) offered by the Fidelity Management Trust Company. Accordingly, these investments qualify as party-in-interest investments.

Administrative fees of \$136,689 were paid by the Plan to Fidelity Management Trust Company for the plan year ended December 31, 2024, which qualify as party-in-interest transactions.

Participants in the Plan are permitted to borrow funds from their vested balance as described in Note 1. These investments qualify as party-in-interest investments. Notes receivable from participants were \$1,354,292 and \$1,009,433 at December 31, 2024 and 2023, respectively.

8. RISKS AND UNCERTAINTIES:

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to level of risks associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
