## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Retirement Accumulation Plan for Employees of the National Urban League (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from the Principal Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### NOTE 1      DESCRIPTION OF PLAN

The following description of the Retirement Accumulation Plan for Employees of the National Urban League (the Plan) provides only general information. National Urban League (NUL) is the Plan Sponsor. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

#### General

The Plan is a profit-sharing plan covering all eligible employees of NUL who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Effective January 1, 2020, NUL ceased its employer contribution to the Plan. Simultaneously, NUL elected to make contributions to another qualified plan, a 403(b) plan, sponsored by NUL. However, in 2023, contributions were made to this Plan for the plan year ended December 31, 2023. It was a 2% employer contribution of active participant's compensation.

However, prior to January 1, 2020, each year, NUL would contribute to the Plan an amount equal to 5%, multiplied by each participant's compensation for the Plan year. If NUL did not contribute such amount for all participants, the amount would be allocated to each participant's account in the same proportion that the participant's total compensation for the Plan year bears to the total compensation of all participants for such year. The balance of NUL's contribution over the amount allocated above would be allocated to each participant's account in a dollar amount equal to 4.5%, multiplied by the participant's excess compensation. If NUL did not contribute such amount for all participants, each participant would be allocated a share of the contribution in the same proportion that the participant's excess compensation bears to the total excess compensation of all participants for that year. The balance of the employer's contribution over the amount allocated above, if any, would be allocated to each participant's account in the same proportion that the participant's total compensation for the Plan year bears to the total compensation of all participants for such year.

At the discretion of the Plan administrator, eligible participants may be permitted to deposit into the Plan distributions received from other plans, with all or a portion of any amount that the participants are entitled to receive as a distribution from such plan. This type of deposit is called a 'rollover' into the Plan.

Participant Accounts

Each participant's account is credited with: (a) NUL's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount.

Vesting

Participants are vested immediately in their rollover contributions plus actual earnings thereon. Vesting in NUL's contribution portion of their accounts is based on years of service as noted below:

<u>Period of Service</u>	<u>Vesting (%)</u>
Less than 2 years	0
>2 years	25
>3 years	50
>4 years	75
>5 years	100

Participants will be credited with a period of service for each 12-month period, beginning from their date of hire until their date of termination.

Payment of Benefits

Participants may receive a distribution of their vested portion upon termination of employment or because of death, disability, or retirement. A participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan.

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts are used to reduce Plan expenses first and then to reduce non-elective company contributions. The forfeited account balances at December 31, 2024 and 2023, were \$12,278 and \$14,559, respectively. These forfeited amounts were used to reduce NUL's contributions in both years.

#### Plan Termination

Although no such intent has been expressed, NUL has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to ERISA's provisions. Should the Plan terminate, participants will become 100% vested in their accounts.

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Operating Expenses

Management fees are paid by the Plan. Other administrative fees are paid by NUL.

### NOTE 3 INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of ERISA. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments at December 31, 2024 and 2023 and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee, Principal Trust Company (Principal).

### NOTE 4 FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (*i.e.*, an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in markets that are not active.
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (*e.g.*, interest rate and yield curve quotes at commonly quoted intervals).
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs for the asset or liability (*i.e.*, supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

**NOTE 4 FAIR VALUE MEASUREMENTS** *(continued)*

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Fair value is determined by quoted market prices available in an active market.

*Pooled separate accounts:* This category includes investments valued at net asset value as a practical expedient in highly diversified funds designed to remain appropriate for investors in terms of risk throughout a variety of life circumstances (life cycle funds). Additionally, there is equity, fixed-income securities and other funds in these accounts that offer a range of risk/return characteristics, and performance goals are to consistently outperform benchmarks, other funds, or certain indexes. There are currently no transfer or redemption restrictions on these investments. There were no unfunded commitments.

The methods described above may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5        RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 6        RELATED-PARTY TRANSACTIONS**

Transactions relating to investment options managed by Principal qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

### **NOTE 7        TAX STATUS**

The Plan has received an advisory letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the Plan is qualified under Section 401 of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. The Plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS volume submitter advisory letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 8        SUBSEQUENT EVENTS**

Management evaluated the need for additional disclosures and/or adjustments resulting from subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued. Based on this evaluation, no additional disclosures or adjustments were required to be made to the financial statements.
