## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees  
Eton Academy 403(b) Defined Contribution Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Eton Academy 403(b) Defined Contribution Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS

**NOTE A - Description of Plan:**

The following brief description of the Eton Academy 403(b) Defined Contribution Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

1. **General** - The Plan consists of a tax deferred annuity plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the requirements of Section 403(b) of the Internal Revenue Code. Eton Academy is the sponsor and administrator of the Plan. The custodian, TIAA-CREF, manages investments of the Plan and also provides record keeping services.
2. **Eligibility** - Employees are eligible to participate in the salary deferral portion of the Plan on the first day of the month following his or her date of hire. To participate in the employer contribution portion of the Plan, employees must have completed two (2) years of service commencing on his or her date of hire. A year of service is defined as the 12 month period commencing with the employee's date of hire, during which an employee is credited with at least 1,000 hours of service, and each anniversary date thereafter. Employees who work less than 20 hours per week, and students, are not eligible to participate in the Plan.
3. **Contributions** - Each year, participants may contribute up to 100% of pretax regular earnings (base pay), as defined in the Plan up to the maximum allowable under the provisions of the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, individual retirement plans or annuities (rollover contributions). In accordance with the Plan, Eton Academy makes a non-elective employer contribution in an amount equal to 5% of an eligible employee's regular earnings (base pay) each payroll period.
4. **Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. **Vesting** - Participants are immediately vested in all contributions plus actual earnings thereon.
6. **Plan Loans** - Plan loans are issued as separate contracts by TIAA as contemplated under IRC Section 72(p)(5) and do not represent Plan assets. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to \$50,000 or 45% of his or her TIAA Traditional account balance subject to annuity contract and Plan provisions. Loans are only permitted from an employee's elective deferrals. Principal and interest is paid ratably by the participant to TIAA and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance. Plan loan balances outstanding from participants to TIAA were \$567 and \$3,867 as of December 31, 2024 and 2023, respectively.
7. **Notes Receivable from Participants** - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 reduced by the greater of the outstanding loan balance of any loan from the Plan to the participant on the date the loan is made or the highest outstanding balance on loans from the Plan to the participant during the one year period ending on the date before the loan is approved or 50% of the values of the participant's employer contribution account as of the valuation date immediately preceding the date on which the loan is approved. The loans are secured by the balance in the participant's account and bear interest rates ranging between 4.25% and 9.00%, which is commensurate with local prevailing rates. As of December 31, 2024 and 2023, the balance of outstanding loans was \$6,180 and \$6,211, respectively. Principal and interest is paid ratably through monthly payroll deductions.

**NOTE A - Description of Plan (continued):**

8. Payment of Benefits - Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan agreement. The Plan provides for distributions at age 59 ½, while the participant is currently employed. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or an annuity. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan.

**NOTE B - Summary of Significant Accounting Policies:**

1. Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.  
  
Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.
2. Investment Valuation and Income Recognition - The Plan's pooled separate account, money market, registered investment companies, and non-fully benefit responsive contract are valued at fair value as determined by the custodian using quoted market prices. The Plan's fully benefit responsive fixed annuity contract investment is valued at contract value, which approximates fair value. The Plan administrator determines the Plan's valuation policies. See Note C for details on inputs, valuation techniques and fair value measurement level within the fair value hierarchy.  
  
Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.
3. Administrative expenses - Certain administrative expenses of the Plan are paid directly by the employer, Eton Academy, and are therefore excluded from these financial statements.
4. Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
5. Payment of Benefits - Benefits are recorded when paid.
6. Certain items in the financial statements and in Note C - Fair Value Measurements for 2023 have been reclassified to conform to the current year presentation for comparability purposes.
7. Subsequent Events - Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**NOTE C - Fair Value Measurements:**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Mutual Funds (including money market accounts) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Pooled Separate Accounts - Variable Annuity (Real Estate): The TIAA Real Estate Account (REA) is an insurance company separate account of TIAA that generally invests in real estate properties and real estate - related investments. Audited financial statements are available. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter. Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA General account provides the REA with a liquidity guarantee -- i.e., TIAA ensures that the REA has funds available to meet participant redemption, transfer of cash withdrawal requests executed at quoted unit values.

Variable Annuities - TIAA Access Annuities: TIAA Access Annuities are variable annuity products that are funded through TIAA Separate VA-3 (VA-3), a separate investment account of TIAA. VA-3 invests in proprietary and nonproprietary mutual funds through various subaccounts. Audited financial statements for VA-3 are available.

Subaccount unit values are calculated daily. The underlying investments are generally valued using market quotations obtained from independent pricing services. There are no investment restrictions. The participant has the option of annuitizing these investments.

Variable Annuities - CREF Accounts: CREF Accounts are investment options available and permitted under the governing Plan, fund variable annuity contracts issued by CREF. Audited financial statements are available.

The Accounts invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. Each Account determines its unit value each day. The participant has the option of annuitizing these investments.

Accumulation units in CREF Accounts are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. In an effort to reduce market timing and excessive trading, shareholders will not be permitted to make electronic transfers (i.e., transfers over the internet, by telephone or by fax) back into that same account through a purchase or exchange for 90 days, if a purchase, sale and repurchase within that account is made within a sixty-day period.

**NOTE C - Fair Value Measurements (continued):**

TIAA Traditional Annuity - Non-Benefit Responsive: The non-fully benefit responsive (NFBR) fixed annuity contract, composed entirely of the TIAA Traditional Annuity Contract, is reported at fair value. Fair value is determined using a discounted cash flow model. The fair value equals the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals. The TIAA Traditional Annuity Contract is not available for sale or transfer on any securities exchange. The fixed annuity contract is subject to various restrictions.

On each statement date, a proportionate share of the investment earnings (or losses, if any) of a participant's selected investment funds will be allocated to their account(s).

The preceding methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - Plan Termination:**

Although it has not expressed any intent to do so, Eton Academy has the right under the Plan to terminate the Plan subject to the provisions of ERISA at any time.

**NOTE E - Tax Status:**

The Plan has been informed by its contract administrator that the adopted volume submitter 403(b) plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since its adoption. The plan administrator is of the opinion that the Plan is currently being operated and fulfills the applicable requirements of a qualified plan. Accordingly, no provision for federal or state taxes has been provided.

**NOTE E - Tax Status (continued):**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE F - Information Certified by Custodian:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, TIAA-CREF Insurance Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**NOTE G - Risks and Uncertainties:**

The Plan invests in a variety of investment options. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H - Investment Contracts with Insurance Company:**

**Fully Benefit-Responsive Contract:** The Plan entered into a traditional fully benefit-responsive fixed annuity contract with TIAA and CREF. TIAA and CREF maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and varies based on when the contract was entered. The minimum guaranteed interest rate is between 1% and 3%. Such interest rates are reviewed on an annual basis for resetting. The fixed annuity does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the fixed annuity is fully benefit-responsive, contract value is the relevant measurement for the fixed annuity, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA and CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 was \$967,996 and \$951,767, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE H - Investment Contracts with Insurance Company (continued):**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) and uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Non-Fully Benefit-Responsive Contract: The Plan has entered into an investment contract with TIAA and CREF. As part of the contract, TIAA and CREF maintains a portion of the contributions in a guaranteed account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by TIAA and CREF. The guaranteed account is included in the financial statements at fair value and totaled \$90,754 and \$302,818 at December 31, 2024 and 2023, respectively.

**NOTE I - Related-Party Transactions and Party in Interest Transactions:**

Certain Plan investments are managed by TIAA-CREF. TIAA-CREF is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.
