Opinion

We have audited the financial statements of Power Engineers, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of Power Engineers, Inc. Employee Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the year then ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Description of Plan

The following description of the Power Engineers, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan provides health and other benefits to all full-time, part-time, and temporary employees of Power Engineers, Inc. (the Company). Full and part time employees are eligible on the first day of the month following their hire date. For temporary employees, the date of eligibility is the first day of the month following 60 days of employment.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (the ERISA).

Benefits

The Plan provides medical, dental, vision, life, disability and accidental death and dismemberment benefits to eligible employees of the Company and their covered dependents as defined by the Plan document. Additionally, employees may set aside money pre-tax in a cafeteria flex spending account in accordance with Section 125 of the Internal Revenue Code (IRC).

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits (basic and dependent), accidental death and dismemberment, and disability (short-term and long-term) benefits through insurance contracts. Premiums for basic life insurance, accidental death and dismemberment insurance, and medical long-term disability insurance programs are paid to the insurance company from the general assets of the Company. Premiums for all other insured benefits are paid from the assets of the VEBA trust.

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (for individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits

The Plan is self-insured for medical, dental, and vision benefits up to individual and aggregate stop loss limits. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

The Plan has a section 125 cafeteria flexible benefits plan (Flex) that is funded solely through participant contributions. Flex allows eligible participants to be reimbursed tax free for qualified medical and dependent care expenses subject to a specified ceiling. Effective for the year ended December 31, 2024, each participant's remaining balance up to \$500 may be rolled forward for use in the subsequent year. Any amounts remaining at the end of the year in excess of \$500 per person, or for terminated employees, are forfeited. The Company is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical and dependent care expenses; and remaining amounts are not portable upon termination once the employee leaves the Company. The Company has elected to leave these forfeited funds in the Plan for accommodating claims paid prior to payroll deductions.

The Plan offers a Health Savings Account option with participation in the high deductible health plan, funded with employee pre-tax deferrals. The associated activity is excluded from the Plan's financial statements as the Plan is not obligated to pay the benefits.

The Plan offers fertility benefit with Progyny and it is a carved-out benefit that offers fertility and family building treatments. The plan pays for administration fees. Similar to the medical plan, there is a cost share of the claims between the member and the plan. Eligible members are subject to deductibles for those utilizing this benefit.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and disability insurance programs based on the current group rate premium cost. The Company pays 50% of the cost of basic life insurance, accidental death and dismemberment insurance. The stop loss premiums are included in the overall plan premiums which are shared by the employee and the Plan.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. The Company's policy is to make sufficient contributions to the Plan to fund all medical, dental, and vision benefit obligations incurred during the Plan year.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payments of Benefits

Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as due to claims administrators in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in administration fees in the accompanying statement of changes in net assets available for benefits. There have not been stop loss claims refunds in the current period, that would have been netted with claims paid in the accompanying statement of changes in net assets.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds of \$1,018,345 due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$2,674,439 have been netted with claims and premiums paid in the accompanying statement of changes in net assets available for benefits and statement of changes in Plan's benefit obligations for the year ended December 31, 2024.

Flexible Spending and Health Savings Accounts

Participant contributions totaling \$7,035,961 were received during the Plan year for health care and dependent care reimbursement spending accounts and are reflected in participant contributions in the accompanying statement of changes in net assets. Claims submitted under the health care and dependent care reimbursement accounts before year end or during the subsequent extension period totaled \$1,655,138 and are included in claims paid in the statement of changes in net assets available for benefits.

HSAs are not considered Plan assets as they belong to the individual participants; therefore, there is no reporting in the accompanying financial statements as there is no obligation of the Plan to pay the benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies and procedures utilizing information provided by investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statement of changes in the net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include bank charges, accounting and legal fees, preferred provider organization and review fees, and other administration fees. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are directly paid by the Company, such as professional fees, are excluded from these financial statements.

Claims Incurred but not Reported

Plan obligations at December 31, 2024 and 2023, for health claims incurred by participants but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan year end. Such estimated amounts are included in the accompanying statements of Plan's benefit obligations in the amounts currently payable. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Subsequent Events

The Company has evaluated subsequent events through August 25, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market deposit accounts (sweep program)– Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Note 4 - Cash and Cash Equivalents

The Plan defines cash and cash equivalents as instruments with an original maturity of three months or less. As of December 31, 2024 and 2023, cash and cash equivalents were held in a Principal Deposit Sweep Program account and a Wells Fargo cash depository account. The money market account is not insured by FDIC. Balances in the depository account in excess of FDIC coverage were \$237,901 and \$291,595, at December 31, 2024 and 2023, respectively.

Note 5 - Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated January 29, 2010, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Party-In-Interest Transactions

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. The estimated liability for accumulated eligibility credits is a mathematical calculation using current hours and rate data. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
