Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

Note A – Plan Description

The following description of the Machine Build Technologies, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General – In 2019 the Plan changed names from Springs Fabrication Inc. 401(k) Profit Sharing Plan to Machine Build Technologies, LLC 401(k) Plan. The Plan is a participant directed defined contribution plan sponsored by Machine Build Technologies, LLC (the Company) covering all employees who are not members of unions, leased employees, or non-resident alien employees of the Company and any affiliates who have adopted the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions – Each year, participants may make traditional contributions up to the maximum dollar limits set by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions and profit sharing amounts are discretionary and are determined annually by the Company's board of directors. Contributions are subject to certain limitations. All contributions were made to Matrix Trust Company (Matrix), the Custodian of the Plan.

Participants' Accounts – Each participant's account is credited with the participant's contribution, allocation of the Company's contribution, plan earnings and any fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts and actual earnings thereon is based on years of continuous service. A participant is fully vested after four years of credited service.

Payment of Benefits – On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested account or defer receipt until age 65 or normal retirement age (as defined in the plan agreement), whichever is later. Terminated participants with balances less than \$1,000 receive a lump-sum distribution net of required federal tax withholdings. Terminated participants with balances between \$1,000 and \$5,000 may elect to receive either a lump-sum cash distribution net of required federal tax withholdings, or may roll the distribution to an individual retirement account (IRA) or the qualified plan of the new employer. The Plan allows for disability and hardship withdrawals. Benefits provided by the Plan are not insured by the Pension Benefit Guaranty Corporation.

Forfeited Accounts – Nonvested participants' accounts that are forfeited upon termination of service may be used to reduce future employer contributions or to pay expenses of the Plan. The forfeiture balance was \$3,597 and \$24,649 as of December 31, 2024 and 2023, respectively, and is included in investment totals. During 2024 and 2023, employer contributions were reduced by \$29,947 and \$0, respectively, from forfeited nonvested accounts.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate, as defined. Principal and interest is paid ratable through monthly payroll deductions.

Note B – Summary of Accounting Policies and Investments

Basis of Accounting – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Custodian. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note C – Information Certified by the Plan's Custodian (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedules, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the Custodian of the Plan.

Note D – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E – Related-Party Transactions and Party-in-Interest Transactions

A party-in-interest, as defined by section 3(14) of ERISA, includes, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered in the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the Custodian are considered party-in-interest transactions. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Administration fees paid by the Plan to Vestwell amounted to \$34,859 and \$37,050 for the years ended December 31, 2024 and 2023, respectively. There were no fees payable at December 31, 2024 and 2023.

Note F – Plan Tax Status

The Company has adopted the Plan based on a prototype plan document sponsored by Vestwell Holdings, Inc. Vestwell Holdings, Inc. has received an opinion letter from the IRS dated March 14, 2022 that states the form of the prototype plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”). The Plan administrator has not requested a determination letter from the IRS on the Plan. The Plan has been amended since the date of the IRS opinion letter on the prototype plan. While the Plan cannot rely on the IRS opinion letter, the Company and the Plan administrator believe that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amount reported in the statements of net assets available for benefits.
