## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Houston Hospitals, Inc. Participatory Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Houston Hospitals, Inc. Participatory Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

**1. DESCRIPTION OF PLAN**

The following description of Houston Hospitals, Inc. Participatory Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan Sponsor, Houston Hospitals, Inc. (the Company), established the Plan effective as of November 1, 1994. The Plan is a defined contribution plan generally covering all employees of the Company. The Fiduciary Committee is responsible for oversight of the Plan. The Fiduciary Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a matching contribution of 50% of the first 4% of compensation, as defined by the Plan, which a participant contributes to the Plan. Participants who have attained age 21 and have completed one year of service, except those who normally work less than 20 hours per week or are LPN2, LPN3, RN2 and RN3 employees are eligible for the Company match. Employer discretionary nonelective contributions may be made at the option of the Company's Board of Directors. The Company did not elect to make a discretionary contribution in 2024. Participants eligible for the Company matching contributions are also eligible for the employer discretionary nonelective contributions except the additional exclusion of employees who were hired or rehired on or after May 1, 2009, and employees who were hired before May 1, 2009, but did not attain age 45 prior to January 1, 2011. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of: (1) the Company's contribution and (2) Plan earnings, and are charged with an allocation of administrative expenses. Allocations are based on participant deferral contributions, compensation or account balances, as applicable and pursuant to the terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are 100% vested in their deferral contributions plus earnings thereon. Vesting in employer matching contributions and employer nonelective discretionary contributions is based on years of continuous service. A participant is 100% vested after five years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or distributions not less than minimum distributions based on the participant's or the participant's designated beneficiary's life expectancy. For terminations of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are not permitted. In-service distributions may be made to a participant who has not separated from service, provided the participant has attained age 59½.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$141,406 and \$102,252, respectively. These accounts will be used to reduce future employer contributions and/or reduce Plan administrative expenses. In 2024, employer contributions were reduced by \$97,881 from forfeited nonvested accounts.

**Subsequent Events**

Management has evaluated subsequent events through October 14, 2025, the date the report was available to be issued, and has determined there are no further subsequent events requiring disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

Investments, except for the fully benefit-responsive investment contracts described in Note 5, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants represent loans to participants and are measured at the unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, and certain other expenses, including recordkeeping fees, have been paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. INFORMATION CERTIFIED BY CERTIFYING ENTITIES**

All investment information, except for the self-directed brokerage accounts, regarding the Plan in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was prepared by or derived from information provided by State Street Bank and Trust Company, Transamerica Financial Life Insurance Company, Inc. (TFLIC), and Lincoln National Life Insurance Company, the Certifying Entities of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Certifying Entities that such information is complete and accurate.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Observable inputs such as quoted prices in active markets.
- Level 2 – Inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3 – Unobservable inputs, in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts consist of mutual funds and exchange traded funds that are valued on the basis of readily determinable market prices and money market funds valued at the NAV of shares held by the Plan at year end.

## 5. GROUP ANNUITY CONTRACTS

In 2020, the Plan entered into a group annuity contract with the Lincoln National Life Insurance Company (Lincoln). The Lincoln Stable Value Separate Account is a fully benefit-responsive, fixed annuity contract issued by Lincoln. Assets backing this contract are held in a separate account that is segregated from the general assets of the issuing company. Assets in the Lincoln Stable Value Separate Account are held for the exclusive benefit of contract owners and are not subject to the claims of insurance company creditors or other general account contract owners. All Lincoln Stable Value Separate Account contracts are in the same pooled separate account.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Company or other Plan events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the Plan to qualify for exemption from federal taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

Under the contract with TFLIC, the Plan also invests in the Transamerica Stable Value Option (the Stable Value Option). The Stable Value Option investment is a non-tradable obligation of TFLIC. The terms of the group annuity contract require all permitted participant-initiated transactions involving the Stable Value Option to occur at contract value with no conditions, limits or restrictions. The Stable Value option is backed by the general account of TFLIC. While TFLIC declares rates periodically and backs the principal and interest of the Stable Value Option, any guarantees are subject to the claims paying ability of TFLIC. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

## **6. RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by TFLIC. TFLIC is the insurance company as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue-sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment to Transamerica Retirement Solutions, the recordkeeper for the Plan, of \$128,763, which was not covered by revenue-sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

## **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

## **8. TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
