Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Aesculapian Management Company, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Aesculapian Management Company, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Note A - Description of Plan

The following description of the Aesculapian Management Company, LLC 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of Intercoastal Medical Group, Inc., Aesculapian Management Company, LLC, and Aesculapian Surgery Center, LLC d/b/a Intercoastal Medical Group Ambulatory Surgery Center, as of the first day of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of January 1, 2002, the name of the Plan was changed from Intercoastal Medical Group, Inc. to Aesculapian Management Company, LLC.

Contributions. Each year, participants may contribute 100% of pretax annual compensation, as defined in the Plan up to \$23,000 (\$30,500 for ages 50 and above) and \$22,500 (\$30,000 for ages 50 and above) for 2024 and 2023, respectively. Starting in 2006, the Plan allowed employees to make Roth contributions to their 401(k). Participants may also contribute amounts representing distributions from certain qualified retirement plans. These distributions will be placed in a separate account called a "participant's rollover account." In addition, the plan allows for contributions from the employer at the option of the employer's Board of Directors. For the years ending December 31, 2024 and 2023, the employer made a safe harbor non-elective contribution equal to 3% of the participant's annual compensation.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution and, (b) Plan earnings and losses. The allocation of the employer's contribution to participant accounts is determined by the Board of Directors on an annual basis. The allocation of Plan earnings and losses are based on participant account balances at the fund level using the daily valuation method, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after four years of credited service.

Participant Notes Receivable. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance less any outstanding balances. Loan terms shall not exceed 5 years or a reasonable period of time for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest payments are credited to the participant's account.

Administrative Costs. Aesculapian Management Company, LLC absorbs a portion of the administrative costs associated with the Plan. Certain loan processing and withdrawal expenses are charged directly to the participant.

Payment of Benefits. On termination of employment, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts. At December 31, 2024, and 2023, forfeited non-vested accounts totaled \$2,212 and \$2,110, respectively. These accounts are used to reduce future employer contributions and pay plan fees. Employer contributions were reduced by \$-0- and \$4,110 in 2024 and 2023, respectively, from forfeited non-vested accounts. Forfeitures in the amount of \$0 were used to pay plan fees in 2024 and 2023.

Automatic Enrollment. Effective January 1, 2009, an automatic enrollment feature has been implemented in the Plan. Under this feature, eligible employees not previously making elective contributions to the Plan will have 3% of their eligible pay contributed to the Plan as a pre-tax elective contribution until a valid election is made to contribute more, less, or nothing.

Blackout Period. During the year, the Plan experienced a blackout period from October 30, 2024 to November 17, 2024 in connection with the transition of plan recordkeeping services from Nationwide to Principal. During this time, participants were temporarily unable to make changes to their accounts, including investment elections, loans, or distributions. The blackout period did not result in any material financial impact on the Plan's assets or liabilities.

Note B - Summary of Significant Accounting Policies

Basis of Accounting. The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Refer to Note G for discussion of fair value measurement methodology. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized and unrealized gains and losses and is reflected in the accompanying statement of changes in net assets available for benefits.

Notes Receivable From Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits. Benefits are recorded when paid.

Note C - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note D - Information Prepared and Certified by Nationwide and Principal

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide and Principal, the Plan's trustees, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statement of net assets available for benefits.
- Investment income, as shown in the statement of changes in net assets available for benefits.
- The schedule of assets (held at end of year) as of December 31, 2024, as shown in the supplementary schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except comparing such information to the related information included in the financial statements and supplementary schedule.

Note E - Tax Status

The Plan obtained a determination letter on July 7, 2010, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note F - Excess Contributions

There were no excess contributions for the plan years ended December 31, 2024 and 2023.

Note G - Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Trusts – Valued at the net asset value (NAV) per share (or its equivalent) as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the fund. Principal has concluded that the NAV represents fair values as of the reporting date, as the underlying investments are valued based on quoted prices in active markets.

Guaranteed investment contract – Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. (See note H)

Mutual Funds – Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

Pooled Separate Accounts (PSA) – Valued at the net asset value (NAV) of the PSA is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying investments of the PSA. Principal has concluded that the NAV represents fair value as of the reporting date, as the underlying investments are valued based on quoted prices in active markets.

Self-Directed Brokerage Accounts – Consists of participant-directed investments in mutual funds, common stocks, exchange-traded funds, and other marketable securities. Valuation of the self-directed brokerage accounts is based on the value of the underlying investments. Principal has concluded that the underlying investments are valued based on quoted prices in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note H - Investment Contract with Insurance Company

The Plan had a benefit-responsive guaranteed investment contract with Nationwide through the end of the blackout date (refer to Note A), afterwards a benefit-responsive guaranteed investment contract was established with Principal. Nationwide and Principal maintained the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value with an adjustment to contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$2,321,491 and \$2,558,658, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not have a maturity date and will continue in force until all assets have been distributed, or no further payments are due.

Note I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note J - Related-Party Transaction

Nationwide managed certain plan investments and was the trustee as defined by the plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for investment management services and administrative services amounted to \$99,694 and \$22,703, respectively for the year ended December 31, 2024.

Principal managed certain plan investments and is the trustee as defined by the plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for investment management services amounted to \$33,333 for the year ended December 31, 2024.

Note K - Subsequent Events

Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued.
