December 31, 2024

1. Description of the Plan

The following brief description of the DMAX 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information, copies of which may be obtained from DMAX, Ltd. (the Company or Employer or Plan sponsor).

General

The Plan is a defined contribution plan for all eligible employees who are employed by the Company that meet the Plan's eligibility criteria. Eligible hourly employees are automatically enrolled in the Plan unless they affirmatively decline to participate. Approximately 88% of the Plan's participants are covered by a collective bargaining agreement that is effective through April 30, 2026. Fidelity Management Trust Company (Fidelity) serves as the trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants in the Plan may contribute up to 60% of their pretax and/or Roth after-tax annual compensation, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). If automatically enrolled, a participant's deferral is set at 3% of eligible compensation until changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

Company contributions are as follows:

Employer Match – Salaried Employees

The Company contributes 100% of the first 4% of compensation, as defined, that a participant contributes to the Plan.

Employer Fixed Nonelective – Salaried Employees

An age-weighted contribution amount ranging from 3% to 7% of compensation, as defined. Participant contributions are not required to be eligible for such contributions.

1. Description of the Plan (continued)

Employer Nonelective Discretionary

Funded based on compensation, as defined. For 2024, the discretionary contribution for salaried employees was 1.3%. For hourly employees, the discretionary contribution was 6.0%. Participant contributions are not required to be eligible for such contribution.

All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and nonelective contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan currently offers a mix of mutual funds, and a common trust fund, as investment options for participants.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of service. Full vesting also occurs if a participant becomes disabled, as defined; dies while actively employed; or reaches full retirement age, as defined.

1. Description of the Plan (continued)

Payment of Benefits

When a participant terminates employment for any reason, all vested amounts in the participant's account, upon request, shall be distributed to the participant or, in the case of death, to a designated beneficiary. Terminated participants may defer receipt of their distribution. However, terminated participants cannot postpone benefit payments if their balance is \$1,000 or less. The Plan administrator will instruct the trustee to distribute to the participant a lump-sum payment without the participants' consent if they do not request a distribution of their benefits. For purposes of a distribution, a participant's account is valued at fair value as of the day prior to distribution. In-service withdrawals are available in certain limited circumstances, as defined by the Plan document. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available distributions prior to requesting a hardship withdrawal.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum level equal to the lesser of (a) 50% of the participant's vested account balance or (b) \$50,000. The loans are secured by the balance in the participants' accounts. Loan terms range to a maximum of 60 months or 120 months if the loan is for the purchase of a principal residence. The interest rate on loans outstanding is determined at the prime rate and ranges from 3.25% to 9.50%. Principal and interest are repaid weekly through payroll deduction or by check. A participant's loan is treated as a distribution if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter (end of the cure period) in which a loan is initially past due or if there is any outstanding balance at the end of the cure period for the last scheduled payment date.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined, represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future employer contributions or to pay Plan administrative expenses for the Plan year. However, if a participant is reemployed and fulfills certain requirements, as defined, the account will be reinstated. At December 31, 2024 and 2023, forfeited non-vested

accounts totaled \$75,363 and \$141,730, respectively. During the year ended December 31, 2024, forfeitures of \$167,643 were used to pay administrative expenses, and forfeitures of \$420,895 were used to reduce Employer contributions.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company. Pursuant to an agreement with Fidelity, revenue sharing amounts are used to pay expenses of the Plan. Expenses may also be paid from the forfeiture account. Should expenses exceed available revenue sharing and forfeiture accounts, expenses will be paid by the Company. Certain transaction related fees are charged to the account of the participant.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

3. Fair Value Measurement

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

Mutual Funds: Shares of mutual funds are valued based on quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Common Trust Fund: Valued at the NAV provided by the administrator of the fund.

Transfers Between Levels

4. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The Plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan

administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of the collective bargaining agreement and ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

6. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Fidelity, the trustee of the Plan.

7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Exempt Party-in-Interest and Related Party Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and these transactions, including issuances of loans to participants, qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on the fund.

9. Subsequent Events

Management evaluated subsequent events for the Plan through October 10, 2025, the date the accompanying financial statements were available to be issued.
