INDEPENDENT AUDITOR’S REPORT

To the Trustees, Plan Administrator, and Participants of Professional Packaging Systems, LLC 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Professional Packaging Systems, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Professional Packaging Systems, LLC 401(k) Profit Sharing Plan and Trust’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Professional Packaging Systems, LLC 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Professional Packaging Systems, LLC 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF THE PLAN

The following description of the Professional Packaging Systems, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Professional Packaging Systems, LLC (the “Company”) January 1, 1995, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

Plan Amendments

Effective August 14, 2023, the Plan was amended to permit participants to renegotiate loans. Effective September 1, 2023, the Plan was amended to permit Roth contributions. No significant effects on net assets resulted from the Plan amendments.

Plan Administration

Empower Annuity Insurance Company of America (“Empower”) is the custodian of the Plan’s investment assets. Empower holds the Plan’s investments and executes investment transactions at the direction of plan participants, receives contributions, interest and dividend income, pays administrative expenses, and makes distributions to participants. Empower Retirement, LLC is the recordkeeper and maintains participant account information. The Plan also uses the services of a third-party administrator, Definiti, LLC, to perform annual compliance testing, prepare the Plan’s Form 5500, and assist the plan administrator in day-to-day activities of the Plan. The rollover IRA custodian is PenChecks Trust Company of America. For investment advisory services, the Plan consults with Commonwealth Equity Services, LLC. The plan administrator is an employee appointed by the Company. Three officers of the Company serve as trustees of the Plan and are charged with oversight of the Trust fund. No owner or employee receives compensation for services.

Eligibility

Employees of the Company become eligible to participate in the Plan upon attaining 18 years of age and satisfying the service requirement. The service requirement is met by completing at least one hour of service during the first three months of continuous employment or completing a year of service (defined as at least 1,000 hours). Plan entry dates are January 1, April 1, July 1, and October 1. The Plan excludes collectively bargained employees and employees who are nonresident aliens who receive no compensation from the Company which constitutes U.S. source income.

Contributions

Each year, participants may contribute up to the maximum annual limits established by the Internal Revenue Service (the "IRS"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Roth deferrals are permitted under the Plan. For the year ended December 31, 2024, the maximum deferral limit is \$23,000 and the catch-up limit is \$7,500. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"), as defined.

The Company may contribute to the Plan, on behalf of each eligible participant, a discretionary matching contribution. For the year ended December 31, 2024, the Company elected to make a discretionary matching contribution of 50% or 100% of an employee's contributions limited to \$3,000 or \$4,500, depending on the employee's group.

Contributions are subject to certain IRS limitations.

Investment Options

Participants direct the investment of their contributions and Company contributions into investment options offered by the Plan. The investment options include various pooled separate accounts and a guaranteed interest contract. If participants do not elect specific investments, their contributions are invested in the Plan's qualified default investment alternative, a target date retirement series.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contribution, if any, and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expense paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company contribution portion of a participant's account is based on years of continuous service as follows:

However, a participant's vesting percentage increases to 100% if, while employed with the Company, the participant dies or becomes disabled.

Forfeited Accounts

Participants, whose employment terminates prior to being fully vested, forfeit the non-vested portions of their accounts. Forfeitures can be used either to pay administrative expenses of the Plan or to reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,160 and \$1,856, respectively. In 2024, Company contributions were reduced by \$41,877 from forfeited non-vested accounts.

Notes Receivable From Participants

Participants are allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The term of the note cannot exceed five years, except in the case of a loan used to acquire a participant's principal residence, for which the term cannot exceed 30 years.

The loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Notes receivable from participants, as of December 31, 2024 and 2023, bear interest rates of 4.25% to 9.50%. Maturities at December 31, 2024, are January 2025 through October 2029. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

The normal retirement age is 65 or the fifth anniversary of the first Plan year in which participation in the Plan commenced. On termination of service due to death, disability, or termination of employment, participants may receive their distribution as a lump-sum payment or elect to transfer their account balance into an individual retirement account ("IRA") or another qualified plan. Participants who have attained the age of 55 may take an in-service withdrawal of vested employer contributions, and after attaining the age of 59-1/2 may take an in-service withdrawal of deferral contributions. In the event of hardship due to an immediate and heavy financial need, as defined by the Plan and as modified by recent legislation, a participant may request a hardship withdrawal from deferral and employer contribution accounts.

Distributions under the Plan may be made in lump-sums (or partial withdrawals of amounts greater than \$5,000) in cash only. The Plan provides for involuntary cash-outs if a terminated participant makes no affirmative election to receive or roll over his or her account balance of \$5,000 or less. Involuntary cash-out balances are automatically rolled over to an IRA for the benefit of the participant.

Recent Legislative Changes to Plan Provisions

Changes to Plan provisions have been or may be made due to the enactment in recent years of various laws. Some of the changes are required by law and some become effective only if adopted by the Plan. Changes which may affect participants relate to required minimum distributions, disaster-related distributions, repayment of Coronavirus-related distributions, distribution of lifetime income investments, and participation of long-term, part-time employees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies employed in the preparation of the accompanying financial statements are as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive group annuity contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian, investment advisers, and Trustees. See Note 3 for discussion of fair value measurements. See Note 4 for discussion of investment contracts reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions and related earnings (losses) of \$75,101 and \$77,671, respectively, to the applicable participants prior to March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefit distributions are recorded when paid. At December 31, 2024, there were no benefits approved for payment but not paid.

Administrative Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Recently Issued Accounting Pronouncements

Recently issued accounting standards that have been issued or proposed by the FASB or other standards-setting bodies which have not yet been adopted by the Plan are not expected to have a material impact on the Plan's financial position or results of activity.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (“ASC”) 820 are described as follows:

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Share prices are obtained from the National Securities Clearing Corporation and/or directly from the fund house, or a secondary pricing source, such as Interactive Data Corporation. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Unit values are calculated daily by the annuity provider and are based on the quoted price for the underlying mutual funds as adjusted for annuity provider expense factors. The unit value is determined in a manner similar to a mutual fund NAV.

Collective Trust Funds: Unit values are reported at NAV as a practical expedient to estimate fair value and is generally obtained from the fund house or other investment provider. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

4. GROUP ANNUITY CONTRACT

The Plan has a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America, valued at \$500,634 and \$620,693 at December 31, 2024 and December 31, 2023, respectively. The insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. In 2024, the average crediting rate was 1.4%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

5. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and participant loan interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodian of the Plan.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are offered and managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America, is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions that are exempt under ERISA.

During 2024, the Plan made the following direct payments to related parties and parties-in-interest: \$18,005 to Empower Advisory Group, LLC for investment management fees; \$5,827 to Definiti, LLC for contract administration fees; and \$32,527 to Commonwealth Equity Services, LLC for investment advisory fees. These amounts are reported in the statement of changes in net assets available for benefits as administrative expenses.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their discretionary employer contributions.

8. TAX STATUS

The Plan is based on a pre-approved defined contribution plan document developed by Definiti LLC. Definiti LLC received a favorable opinion letter dated June 30, 2020, from the IRS stating that the form of the plan is acceptable under Section 401 of the Internal Revenue Code ("the Code"). The Plan Administrator believes that the Plan, as adopted and amended, is designed, and is currently being operated, in compliance with applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
