INDEPENDENT AUDITORS' REPORT

To the Limited Trustee of
Greater Seacoast Community Health 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Greater Seacoast Community Health 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Greater Seacoast Community Health 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Greater Seacoast Community Health 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF PLAN

The following description of Greater Seacoast Community Health 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan’s provisions.

General

The Plan, which became effective January 1, 2004, is a defined contribution plan covering all eligible employees, as defined by the Plan, of Greater Seacoast Community Health (“the Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Limited Trustee oversees the governance of the Plan, the appropriateness of the Plan’s investment offerings and monitors the Plan’s investment performance.

Contributions

Each year, eligible participants, as defined in the Plan, may contribute up to 100% of pretax or after tax annual compensation up to the maximum annual limit provided by the Internal Revenue Service, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor contributes matching discretionary contributions equal to 2% of compensation. For the years ended December 31, 2024 and 2023, employer discretionary matching contributions totaled \$153,318 and \$244,988, respectively.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, if any and, (b) plan earnings (losses) and is charged with an allocation of administrative expenses, depending on the participant’s choice of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Previous to February 1, 2011, participants were immediately vested in their contributions and employer contributions plus earnings thereon. Subsequent to that date employees vested in employer matching contributions 25% per year after completing two years of eligible service. Participants were fully vested after six years. In conjunction with the Plan amendment, effective August 1, 2018, the Plan changed its vesting provisions to the following:

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan adoption agreement, the participant's account will be restored. Forfeitures may be used to reduce Plan expenses and employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,184 and \$75,996, respectively. For the years ended December 31, 2024 and 2023, certain forfeitures were used to offset employer contributions and Plan expenses which totaled \$88,473 and \$25,544, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in whole unit increments in a variety of mutual funds and a stable value fund offered by Ascensus. Participants may change their investment options and make transfers between investments at any time via an automated system or through human resources. All investments of the Plan are participant directed.

Notes Receivable from Participants

An employee may borrow from his or her 401(k) account for the reasons outlined in the Plan's loan procedure document. The maximum loan is 50% of a participant's vested account balance up to \$50,000. The loans must be repaid over a period not extending beyond five years from the date of the loan, unless it's for the purchase of a principal residence. The loans are secured by the remaining balance in the participant's account. Loan principal and interest payments are paid ratably through payroll deductions.

Payment of Benefits

Benefits are recorded when paid.

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount, a direct transfer to another qualified retirement account, or a combination of the two, equal to the participant's vested interest in his or her account.

For termination of service due to other reasons, a participant, unless electing otherwise, will begin receiving payments as soon as practical based on the preceding valuation date. Participants with a balance of \$5,000 or greater have the right to keep their retirement account in the Plan or elect to have the benefits paid in a lump sum. Participants with a balance of less than \$1,000 will automatically receive a lump sum payment as soon as the Limited Trustee instructs the custodian to do so. Participants with a balance greater than \$1,000 but less than \$5,000 are automatically rolled over into a separate individual retirement account with Ascensus.

In-Service Withdrawal and Hardship Withdrawal

An employee is permitted to take a distribution while being an active participant in the Plan at the age of 59 ½. Such a distribution will not be subject to a 10% excise tax but will be subject to income taxes.

An employee may take a distribution from the Plan if a heavy financial burden can be demonstrated to the Plan Limited Trustee. The Limited Trustee shall grant a hardship withdrawal only if it is determined the withdrawal is necessary to meet an immediate and heavy financial need of the participant, as defined by the Plan. Such a distribution will be subject to income taxes and may be subject to a 10% excise tax.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for investment contracts. They are reported at contract value. See **Note 4**.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Limited Trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results could differ from those estimates. See **Note 3** for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases making loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See **Note 3** for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements), and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Reliance Trust Company, specifically MetLife Stable Value Fund Series 25053 - Class 0. Reliance Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed to that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$245,012 and \$246,341, respectively. The crediting interest rate is estimated based on quarter end values. For the year ended December 31, 2024 and 2023 the Plan received an average crediting rate of 2.89% and 2.86%, respectively.

The Limited Trustee may terminate the guaranteed investment contract at any time, subject to the notice provisions below, and shall terminate the guaranteed investment contract upon the performance of all of its duties under the Declaration of Trust. The Limited Trustee will provide prior written notice of 60 days or more of the Trust's termination to all Participating Plans and after the date of such notice, no further contributions to the Trust shall be permitted. Upon termination, or as promptly thereafter as is reasonably feasible, the Limited Trustee will (a) make withdrawals under the Investment Contracts of all available assets, and (b) distribute, in cash or in kind, the net assets of each Series to each Participating Plan in proportion to the Participating Plan's ratable share of the fair value of the assets of the Series at the date of termination. The Limited Trustee will not be liable for any amount by which assets so distributed have a value lower than that determined on any valuation date as long as it acted in good faith and with due care.

NOTE 5. INFORMATION CERTIFIED BY THE PLAN'S ASSET CUSTODIAN

The Limited Trustee has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian, Ascensus Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at year end) is complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this information, for the years ended December 31, 2024 and 2023, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 6. ADMINISTRATIVE EXPENSES

The Company provides certain administrative and accounting services to the Plan at no cost. Administrative expenses paid directly by the Company include audit and annual compliance testing and certain record keeping fees. Administrative expenses in the statement of changes in net assets available for benefits consist of participant fees, investment advisory fees, audit reimbursement and annual processing fees. All other expenses are included in the net appreciation in fair value of investments.

NOTE 7. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments including shares of mutual funds and the stable value fund, are managed by Ascensus, the asset custodian; therefore, these transactions qualify as party in interest transactions in accordance with Section 3(14) of ERISA. Additionally, the Limited Trustee of the Plan is currently participating in the Plan.

These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, and the Internal Revenue Code governing termination of employee benefit plans and with a 60 day written notification to the Plan Limited Trustee. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 9. TAX STATUS

This Plan as adopted, is based on a Prototype Non-Standardized Profit-Sharing Plan. The Prototype Plan received a determination letter dated June 2020 and the Plan relies on the notification letter issued by the National Office of the Internal Revenue Service as evidence that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Limited Trustee believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Limited Trustee has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
