### 1. Description of the Plan

The following description of the KBC Employee Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan covers employees of KBC Nursing Agency, Inc. (the “Company” or the “Plan Sponsor”) who have attained the age of 21 and completed 1000 hours of service. Participants enter the plan on January 1<sup>st</sup> and July 1<sup>st</sup> once their eligibility provisions are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan's Administrative Committee is responsible for oversight of the Plan. The Plan is intended to be a tax qualified defined contribution plan that satisfies the requirements of the Internal Revenue Code (the “Code”).

Empower holds the assets of the Plan in accordance with the provisions of the Empower agreement. The recordkeeping administrative services are performed by Empower.

#### ***Contributions***

Each year, participants may contribute up to 100% of their pretax eligible annual compensation, up to the maximum allowed by the Internal Revenue Code (“IRC”), as defined in the Plan document. Contributions can be made on a pre-tax (before federal and state taxes are withheld) and after tax (Roth 401K) basis through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to certain Empower limitations. Participants may also contribute amounts representing distributions from other qualified plans, which are reflected as rollover contributions in the statement of changes in net assets available for benefits. The company may make a discretionary match. There may be a special requirement for employee to receive a company contribution.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, Company’s discretionary matching contributions and a discretionary profit-sharing contribution, if any, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Discretionary profit-sharing contributions and discretionary matching contributions, if any, vest 20% after two years of service and increase 20% for each additional year of service and are 100% vested after six years of service. Benefits attributable to each participant will become fully vested in the event of death, disability, or normal retirement.

### ***Notes Receivable from Participants***

No loans allowed in the plan.

### ***Payment of Benefits***

Participants are eligible to receive a distribution of their account balance, to the extent vested, upon termination of employment, death, disability, or retirement. While employed by the Company, a participant may make a withdrawal if the participant has attained age 59 ½. Generally, benefits are payable as a lump sum amount equal to the participant's entire vested interest in the Plan. Terminated employees with any account balances may receive distributions as soon as administratively feasible following severance of employment.

### ***Forfeited Accounts***

Participants who terminate their employment prior to the completion of the minimum number of applicable years forfeit their unvested employer contributions. Forfeitures may be used to pay administrative expenses of the Plan or reduce contributions made by the Company. As of December 31, 2024, the forfeiture balance was \$0.45.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ

materially from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, custodian and Empower. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses incurred for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan totaled \$35,416 for the year ended December 31, 2024.

### ***Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***New Accounting Pronouncements***

The Financial Accounting Standards Board (FASB) has issued new accounting pronouncements effective in upcoming years. The Plan has reviewed those pronouncements and determined that none are expected to have a material impact on its financial statements. Notable ones include:

and Disclosure of Crypto Assets. This update requires entities holding crypto assets to measure them at fair value each period and provide enhanced disclosures. The Plan does not hold crypto assets, so adoption is not expected to affect its financial statements.

ASU 2022-03, Fair Value Measurement (Topic 820): Fair Value Measurement of Equity Securities Subject to Contractual Sale Restrictions. This clarifies that contractual sale restrictions do not reduce fair value and adds related disclosures. The Plan does not have equity securities subject to such restrictions and, consequently, does not expect a material effect.

ASU 2023-09, Income Taxes (Topic 740): Improvements to Income Tax Disclosures. This update expands income tax disclosure requirements, mostly impacting public business entities. Because the Plan's activities under Topic 740 are minimal, management does not expect the requirements to have a material effect on the Plan's disclosures.

Management continues to monitor future pronouncements as they are issued and will evaluate their applicability to the Plan in future periods.

### 3. Fair Value Measurements

The Plan measures certain assets at fair value on a recurring basis in accordance with ASC 820, Fair Value Measurement. ASC 820 establishes a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are defined as follows:

- Level 1: Quoted prices in active markets for identical assets.
- Level 2: Observable inputs other than quoted prices for identical assets.
- Level 3: Unobservable inputs significant to the measurement.

Investments that are measured at net asset value ("NAV") as a practical expedient are not classified within the fair value hierarchy.

### Valuation Techniques

#### ***Mutual funds***

Valued at quoted market prices that represent the NAV of shares held by the Plan at year-end. These are classified as Level 1 in the fair value hierarchy.

#### ***Collective investment trusts (CITs):***

Valued at the NAV of units held at year-end as determined by the trustee, which represents the fair value of the underlying assets less liabilities. NAV is used as a practical expedient to estimate fair value. CITs have no unfunded commitments, and redemptions are permitted daily at NAV.

#### ***Insurance company general account:***

Represents a fully benefit-responsive investment contract backed by the general account of an insurance company. The investment is recorded at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair value.

#### ***Pooled Separate Accounts***

Investments in pooled separate accounts are stated at the corresponding unit value of the pooled separate account. The estimated fair value of pooled separate accounts are based on the fair value of the underlying assets owned by the pooled separate account and are generally based on observable inputs.

The valuation method used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan

believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **5. Tax Status**

The Plan adopted the Volume Submitter Defined Contribution Plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014, stating that the prototype plan is in compliance with applicable sections of the IRC. The Company believes the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and tax exempt. Therefore, no provision for federal or state income taxes has been included in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### **6. Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Empower. These transactions qualify as exempt party-in-interest transactions as defined by ERISA. Additionally, notes receivable from participants are considered exempt party-in-interest transactions. Administrative expenses paid by the plan to Empower, and its affiliates, also qualify as party-in-interest transactions.

### **7. Subsequent Events**

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be filed and has determined that, there were no material events requiring recognition or disclosure.
