Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1: Description of the Plan

The following description of the Hi-Tech Interiors, Inc. 401(k) Salary Reduction Plan & Trust (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Hi-Tech Interiors, Inc. and other affiliated employers (the Company). Employees are eligible to begin deferring contributions after attaining age 18 and completion of two months of service. Participants will be automatically enrolled upon eligibility unless they opt not to participate. Employees are eligible for company matching contributions after two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participating employees may elect to contribute a percentage up to the maximum allowed by law of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after tax (Roth) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds to Plan participants.

Employer Contributions

The Company may make a matching contribution equal to a uniform percentage of the employee's salary deferral, which percentage is determined annually at the discretion of the Company's Board of Directors. The Company chose to match 50% of the employee deferral up to a maximum of 5% of the employee's compensation for both the 2024 and 2023 Plan years.

The Company may make a prevailing wage contribution into certain employees' accounts to comply with state regulations. The funds contributed are considered a qualified nonelective contribution and treated like an elective deferral for testing purposes.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make nonelective contributions, as defined in the Plan document. Nonelective contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has elected not to provide a nonelective contribution for the 2024 and 2023 Plan years. Company contributions, both matching and nonelective, are invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary nonelective contribution and Plan earnings. Employer matching contributions are allocated to the participant based on a percentage of the participants' salary deferral contributions. Discretionary nonelective contributions are allocated based on a participant's respective share of eligible compensation to the total eligible compensation. Income is allocated daily based on each participant's share of the account. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their employee contributions and prevailing wage contributions plus actual earnings thereon. That portion of the participant's account attributable to employer matching and nonelective contributions vest at a rate of 20% per year starting with the second year of service. A participant is fully vested after the completion of six years of credited service. Notwithstanding the above, a participant becomes 100% vested in his/her account upon attaining age 59 1/2 during the Plan year, death or disability.

Participant Loans

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest at a rate equaling the prime rate for that given month plus one percentage point. Loans are repaid by payroll deductions over a period no longer than five years unless the loan is used for the purchase of a primary residence. Loans are subject to hardship provisions and only allowed upon the participant providing the appropriate hardship documentation.

For the year ended December 31, 2024 and 2023, no loan balances were deemed to be in default.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum amount or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. If a participant has terminated employment and the participant's account balance is less than \$5,000, the accounts are rolled directly to individual retirement accounts. The Plan also allows for in-service and hardship distributions subject to Plan provisions.

Forfeitures

Forfeitures of company matching funds are used to pay administrative expenses and reduce employer contributions to the Plan for the following Plan year. Amounts forfeited during the years ended December 31, 2024 and 2023 were \$115,515 and \$17,633, respectively. During 2024 and 2023, \$175,683 and \$0 forfeitures were used to reduce employer contributions, respectively. The forfeiture account balance at December 31, 2024 and 2023 was \$13,318 and \$70,352, respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of the participants accounts or distributions are charged directly to the participants account. Other expenses such as administrative fees and investment fees are included in administrative expenses.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by Nationwide Trust Company, FSB (the Custodian) as of the Plan's year end. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

Participant Loans

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions upon a distributable event, as defined in the Plan document.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan or open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Money market funds are a type of mutual fund and share the same valuation process.

Note 4: Investment Contracts

Guaranteed Investment Contracts

Participants in the Plan have the option to invest in the Nationwide Fixed Selection Option. These funds are maintaining the contributions in a general operating account, plus earnings at guaranteed credit rates, less withdrawals and fees. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable time frames.

Guaranteed investment contracts are valued at contract value by the insurance company and are not required to be valued in the fair value measurement hierarchy according to ASU 2015-12, thus are not included in the previous fair value table.

Note 5: Related Parties and Parties in Interest

The Company absorbs a portion of the Plan's administrative fees, the cost of audit fees paid to Varney & Associates, CPAs, LLC related to the Plan, and the cost of fidelity bonds. Also, certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. These transactions qualify as exempt party-in-interest transactions.

Additional party-in-interest transactions administration fees paid to EGPS for third-party administration and investment fees paid to the Custodian. The investment advisor, Gentry Private Wealth Advisors, are also paid through the Plan.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7: Tax Status

The Company adopted a non-standardized prototype plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9: Reconciliation of Financial Statements to Form 5500

The statements of net assets available for benefits and the statements of changes in net assets available for benefits reconciles to Schedule H of Form 5500 for the years ended December 31, 2024 and 2023.

Note 10: Information Prepared and Certified by the Custodian (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.
