### Report on Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Corus Orthodontists LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### 1. General

The Plan is a multiple employer defined contribution plan covering substantially all employees of Corus Orthodontists LLC, and other adopting employers (collectively, the Company) who have one year of service and attained the age of 21. The Plan entry date is the first day of the first month and the seventh month of the Plan year coinciding with the date eligibility is met. As of December 31, 2024, the Plan has 29 adopting employers.

The Plan was amended on January 28, 2021, to change the Plan name from Corus Orthodontics LLC 401(k) Plan to Corus Orthodontists LLC 401(k) Plan. The original Plan was established January 1, 2014, then assumed by the Company in 2021, for the benefit of its employees and the employees of any affiliated employer to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan was amended and restated on January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Corus Orthodontists LLC Retirement Plan Committee (Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan's board of trustees.

#### 2. Contributions

Each year, participants may contribute before-tax and qualified Roth deferrals to the Plan, up to 90% of annual eligible compensation, as defined in the Plan documents. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. All participating employers, according to the adopting employer's plan documents, must make a safe harbor matching contribution based on 100% of the participant's deferred compensation that is not in excess of 3% of the participant's compensation, plus 50% of the amount of the participant's deferred compensation that exceeds 3% of the participant compensation but not in excess of 5% of the participant's compensation. The participating employers may elect to make discretionary nonelective contributions. There were no discretionary nonelective contributions elected for the Plan year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### 3. Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's safe harbor matching contributions and discretionary nonelective contributions, as well as allocations of the Plan's earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**4. Vesting**

Participants are vested immediately in their contributions and the adopting employer's safe harbor contributions plus actual earnings thereon. Vesting in the adopting employer's discretionary nonelective contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**5. Notes Receivable from Participants**

Effective January 1, 2021, the Plan does not permit loans. Any loans transferred in from new participating employers will continue as scheduled until paid in full. The loans are secured by the balance in the participant's account. The loan interest rate will be based on the Prime rate plus 1.00%. Principal and interest is paid ratably through monthly payroll deductions.

**6. Payment of Benefits**

Upon termination of service due to death, a participant will receive a complete distribution of the participant's account made by December 31 of the calendar year containing the fifth anniversary of the participant's death. For termination of service for other reasons or retirement, a participant may elect either a lump sum payment amount equal to the value of the participant's vested interest in his or her account or substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the participant or beneficiary or a distribution under a continuous right of withdrawal pursuant to which the participant may withdraw such amounts at such times as he or she elects. A participant may elect to have the Plan administrator apply his or her vested account toward the purchase of an annuity contract, which shall be distributed to the participant and non-transferable.

**7. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,847 and \$6,377, respectively. These accounts can be used to restore previously forfeited participant accounts, pay future Plan expenses, reduce future employer contribution obligations, or reallocate forfeitures as Company contributions. During 2024, no forfeitures were used to reduce Plan employer contributions.

**8. Transfers to the Plan**

During 2024, certain participating employers transferred their balances from the participating employers' previous plans to the Plan, which totaled \$1,762,495.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified in the Financial Accounting Standards Board's (FASB) *Accounting Standards Codification* (ASC).

**2. Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying the notes. Actual results could materially differ from those estimates.

**3. Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, custodians, and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses on the statement of changes in net assets available for benefits and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

**5. Payment of Benefits**

Benefits are recorded when paid.

**6. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company (the Trustee) and Empower Annuity Insurance Company of America (the Insurance Company).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements* (ASC 820), defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not assumptions specific to the entity.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used in 2024 and 2023 for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed Annuities:* Valued daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

*Self-Directed Brokerage Accounts:* Accounts primarily consist of money market funds, mutual funds, and common stocks. The fair value of the money market funds, and mutual funds, are dependent upon the daily closing price as reported by the fund. Common stock is valued at the closing price reported in the active market in which the individual security is traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as risk of foreign currency fluctuations relative to the U.S. Dollar, interest rate risk, credit risk, issuer going concern risk, and overall market volatility. During the year ended December 31, 2024, net appreciation in fair values of investments approximated \$3.4 million. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Insurance Company and the Trustee and, therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants are considered party-in-interest transactions and are secured by the vested balances in the participants' accounts.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing, rather than direct payment. The Company pays directly any other fees related to the Plan's operations. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

The Company pays certain Plan accounting and administrative fees. The Company incurred \$20,800 for accounting and administrative fees during the year ended December 31, 2024. These fees are not reflected in the accompanying financial statements.

**NOTE 8 - TAX STATUS**

The Plan uses a volume submitter plan document sponsored by Alerus Financial NA (Alerus). Alerus received an opinion letter from the IRS, dated June 30, 2020, which states that volume submitter document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since Alerus received the determination letter, the Plan's management and retirement plan committee believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. Due to administrative errors, contributions from one 2023 payroll was not remitted to, and accepted by, the Plan's trustee until October 2024. Late contributions attributable to the 2023 payroll that was corrected during October 2024 totaled \$12. Employee contributions for this pay period are considered prohibited transactions. The Plan sponsor made an interest payment of \$1 to compensate the Plan for lost investment earnings relating to this prohibited transaction.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.
