INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
The Medical Rehabilitation Centers, LLC 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Medical Rehabilitation Centers, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Medical Rehabilitation Centers, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Medical Rehabilitation Centers, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of a controlled group (the “Company”) who have attained age 21 and completed six months of service. The Company consists of Medical Rehabilitation Centers, LLC d/b/a Exceptional Living Centers, Lexington HealthCare LLC, Exceptional Therapy LLC, Park View Operating Company LLC, Exceptional Care Services LLC, Bluegrass Senior Living Somerset, Century Villa Health Care & Rehabilitation, Best Care Health & Rehabilitation, Bradford Place Care Center, Buchanon Place Health & Rehabilitation, Charlestown Place at New Albany, Dover Care Center, Sienna Woods Care Center, and Smyrna Care Center. In 2024, Clifton Oaks Care Center, Frankfort Rehabilitation & Care, Frederick Health & Rehabilitation, Glasgow Health & Rehabilitation, Green Hill Rehabilitation & Care, Kirtland Rehabilitation & Care, Lyndon Woods Care & Rehabilitation, Morgantown Health & Rehabilitation, Mountain Crest Health Care, Riverside Health & Rehabilitation, Stanford Care & Rehabilitation, and Vanceburg Rehabilitation & Care ceased participation in the Plan. As a result, the Plan experienced a partial Plan termination, and all participants employed by these entities became fully vested in their account balances. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions:

Participants may contribute a percentage of their gross annual compensation, subject to certain limitations. Participants are automatically enrolled at a deferral rate of 3% of compensation, unless an alternative election is made. The automatic deferral percentage increases annually to a maximum of 6% on the first day of the Plan year, beginning with the first Plan year following the date deferrals were first automatically withheld. Participants who have attained age 50 by year-end may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes safe harbor matching contributions equal to 100% of salary deferrals that do not exceed 1% of the participant’s compensation, plus 50% of the participant’s salary deferrals between 1% and 6% of the participant’s compensation. The Company may make additional discretionary matching and nonelective profit sharing contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts:

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, and allocations of Plan earnings, and charged with withdrawals, administrative expenses, and allocations of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is 100% vested in the Company's safe harbor matching contributions after two years of credited service. A participant is 100% vested in the Company's discretionary contributions after three years of credited service. Participants become 100% vested in the Company's contributions upon reaching retirement age, disability or death.

Payment of Benefits:

Upon attainment of age 59½, termination of service, deemed severance, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, a partial distribution, or in various installments. Account balances less than \$5,000 must be paid in the form of a lump-sum distribution. Withdrawals from a participant's rollover contribution account may be made at any time. A participant may also request a distribution in case of hardship as detailed in the Plan provisions.

Forfeited Accounts:

Forfeitures may be used at the employer's discretion. In 2024, forfeitures of \$466,926 were used to reduce employer contributions, and forfeitures of \$14,431 were used to pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,655 and \$315,191, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Administrative expenses are paid by the Plan or the Company as provided in the Plan document. Substantially all administrative expenses are paid from the fees deducted from investment earnings by the investment manager. If the fees deducted from investment earnings exceed the Plan's administrative expenses, the excess amount may be allocated to participants and recorded as other income.

Subsequent Events:

Management has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements. The guidance establishes a fair value hierarchy about the assumptions used to measure fair value and clarifies assumptions about risk and the effect of a restriction on the sale or use of an asset.

ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

Three levels of inputs may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts: Valued at the net asset value ("NAV") of shares held by the Plan, as reported by the investment manager.

NOTE 4 - GROUP ANNUITY CONTRACT

The Plan provides an option to invest in the Fixed Account, which is a group annuity contract with Voya Retirement Insurance and Annuity Company (“Voya”). Voya maintains the contributions in a general account. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan’s ability to transact at contract value with Voya. The Plan administrator believes the occurrence of such events that would limit the Plan’s ability to transact at contract value with Plan participants is not probable.

NOTE 5 - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution. NOTE 6 - RELATED PARTY TRANSACTIONS

The Plan's investments are pooled separate accounts and a group annuity contract managed by Voya. Voya is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 - INCOME TAX STATUS

The Plan uses a pre-approved plan document sponsored by McGregor & Associates, Inc. McGregor & Associates, Inc. received its latest opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. The pre-approved plan document has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - PROHIBITED TRANSACTIONS

During the years ended December 31, 2024 and 2023, there were unintentional delays by the Company in submitting participant contributions of \$117,604 to the Plan. These delinquent contributions constitute prohibited transactions under ERISA. In 2024, the Company contributed to the affected participants' accounts to compensate them for lost earnings due to the delays.
