Independent Auditors' Report

To the Plan Sponsor

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Succession Capital, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Succession Capital, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Succession Capital, Inc., Floor Solutions, LLC, Kitchen Kaboodle II, Inc., United Fastener Inc., HJ Sherman Company, Inc., Left Hand Studios, LLC, Maverick Express, Inc., G&W Commercial Flooring, Inc., North American Shoe Co., Wine Valley Siding Supply, Inc., Intermountain Total Facility Services, LLC, Flooring Solutions Inc., Shehadi Commercial Flooring, Midwest Floor Covering Inc. (effective January 1, 2022), Resource South Florida, Inc. (effective January 1, 2023), Buse Timber & Sales, Inc. (effective February 1, 2023) and Creative Surfaces (effective January 1, 2024) (the “Participating Employer(s)”, collectively (the “Company”) who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The effective date of the Plan is January 1, 2016.

Effective January 1, 2025, Esmay Electric, Inc. will become a participating employer in the Plan. Effective January 1, 2026, The MNM Group, Inc. and MNM Wireless, LLC will become participating employers in the Plan.

The Setting Every Community Up for Retirement Enhancement (“SECURE”) Act 2.0 was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act, which altered the rules around how employees can save and withdraw money from their retirement accounts.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual or after-tax compensation, as defined in the Plan, not to exceed the limit permitted under the Internal Revenue Service (“IRS”) regulations each year. Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants.

Effective January 1, 2022, the Company has elected a Traditional Safe Harbor 401(k) Plan and will make a safe harbor matching contribution equal to 100% of the participants’ elective deferrals that are not in excess of 4% of the participant’s Plan compensation. For those participants electing less than a 4% contribution, the recalculation will be adjusted accordingly. During the year ended December 31, 2024, the Company made matching contributions of \$1,224,556. Contributions are subject to certain IRS limitations.

In addition, non-elective discretionary contributions may be made at the option of the Company. No non-elective contributions were made for 2024.

The SECURE Act 2.0 increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024. In addition, the SECURE Act 2.0 requires that participants whose prior-year wages from their current employer that exceeded \$145,000 make any catch-up contributions as Roth (post-tax) beginning January 1, 2024. The IRS granted a two-year administrative transition period in the provision’s effective date to January 1, 2026.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollovers

Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions. Employees may rollover eligible amounts from other qualified plans to the Plan except for rollovers of certain designated Roth IRA contributions.

Vesting

Participants are 100% vested in their elective contribution, qualified nonelective employer contribution and Roth contribution plus actual earnings thereon at all times. The nonelective employer contribution and matching contribution accounts of a participant shall vest as follows:

The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator, and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be longer). Principal and interest are paid ratably through monthly payroll deductions. A loan that is considered in default is reported as a deemed distribution, which may be a taxable event for the participant.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant (or their beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a periodic basis. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Under the SECURE Act, participants may defer receipt of their required minimum distribution until age 72 from the previous age of 70½. The SECURE Act 2.0 increased the age at which individuals must begin taking required minimum distributions to age 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030.

Payment of Benefits (continued)

For a terminated participant with a balance of \$5,000 or less, the participant will receive the value of the vested interest as a lump-sum distribution. The SECURE Act 2.0 increased that limit to \$7,000 effective for distributions in 2024.

In-service distributions may be made from a participant's account at any time upon or after the occurrence of the following events:

- participant's attainment of age 59½.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Investments held by defined contribution plans are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisor, and Principal Trust Company, the trustee of the Plan ("Principal"). See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of \$162,432 were paid by the Plan for the year ended December 31, 2024. Other expenses of the Plan are paid directly by the Company at the election of the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The Collective Investment funds and Pooled Separate accounts are direct filing entities.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values ("NAV") of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (FBRICs)

The Plan holds an investment in the Principal Fixed Income Guaranteed Option (“PFIGO”), which is a fully benefit-responsive investment contract issued by Principal Life Insurance Company and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less withdrawals.

Guaranteed investment contracts are backed by the general account of the contract issuer. The Plan deposits a lump sum with the issuer and receives a guaranteed crediting rate for a specified period. Interest is accrued on either a simple or fully compounded basis and is paid either periodically or at the end of the contract term. The issuer guarantees that all qualified participant withdrawals will be at contract value (principal plus accrued interest). The contract cannot be terminated before the scheduled maturity date. The Plan’s ability to receive amounts due is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The issuer guarantees that all qualified participant withdrawals will be at contract value and that the credit rate applied will not be less than 1% or greater than 3%. Crediting rates are typically reset quarterly to account for the difference between the contract value and the fair value of the underlying portfolio. The contract had a crediting interest rate of 1.55% for each of the years ended December 31, 2024 and 2023.

The contracts also generally provide for withdrawals associated with certain events which are not in the ordinary course of Plan operations. These withdrawals are paid with a market value adjustment applied to the withdrawal as defined in the investment contract. Each contract issuer specifies the events which may trigger a market value adjustment; however, such events may include, but not be limited to, the following:

- Material amendments to the Plan’s structure or administration;
- Complete or partial termination of the Plan, including a merger with another plan;
- The failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA;

- The redemption of all or a portion of the interests in the Plan at the direction of the Plan sponsor, including withdrawals due to the removal of a specifically identifiable group of employees from coverage under the Plan (such as a group layoff or early retirement incentive program), the closing or sale of a subsidiary, employing unit, or affiliate, the bankruptcy or insolvency of the Plan sponsor, the merger of the Plan with another plan, or the Plan sponsor's establishment of another tax qualified defined contribution plan;
- Any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the Plan;
- Changes to competing investment options;
- The delivery of any communication to Plan participants designated to influence a participant not to invest in the stable value option.

At this time, the occurrence of any such market value adjustment event is not probable.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions.

NOTE 6 – INFORMATION PREPARED AND CERTIFIED BY PRINCIPAL AS COMPLETE AND ACCURATE

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by the Plan's trustee and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information included in the Plan's financial statements.

The Plan's trustee has certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023, and the investment activity included in the financial statements for the year ended December 31, 2024, as summarized below:

NOTE 7 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator (and the Plan's tax counsel) believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments that are shares of mutual funds and common trust funds managed by Principal qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities including mutual funds and pooled separate accounts designated by participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – DELINQUENT EMPLOYEE DEFERRAL REMITTANCES

In accordance with the Department of Labor's Regulation 2510.3102, an employer is required to segregate participants' contributions from its general assets as soon as practical, but in no event more than the 15th business day following the end of the month in which amounts are contributed by participants or withheld from their wages for a pension benefit plan such as the 401(k) Plan. The Company failed to remit participants' contributions withheld during the year ended December 31, 2024. The Company has agreed to absorb any costs incurred by the Plan as a result of the untimely remittance of the participants' accounts.

NOTE 11 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
