We have performed audits of the financial statements of HPC Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), the financial statements which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Description of the Plan

The following brief description of the HPC Savings and Profit Sharing Plan (the Plan) is provided for general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

Humphrey Products Company, Inc. (the Company) established the Plan on January 1, 1985, as a defined contribution plan. The Plan covers substantially all employees of the Company. The Company is the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All eligible employees may participate in the Plan immediately upon hire. To become eligible for discretionary matching and non-elective contributions, a participant must complete three months of service by the end of the Plan year. For the non-elective contributions, a participant must be employed on the last day of the Plan year.

Contributions

Participants may contribute up to the lesser of 100% of their pre-tax annual compensation, as defined by the Plan, or the maximum allowed by Internal Revenue Service (IRS) regulations. These contributions can be made on a pre-tax basis or on an after-tax basis to a Roth account. Participants may also contribute amounts representing rollovers from other qualified plans. The Plan provides an auto-enrollment feature whereby 5% of compensation is automatically withheld upon meeting eligibility requirements, unless a participant elects otherwise.

The Company may elect to make a discretionary matching contribution to the Plan based on the participant's elective deferrals in a percentage set by the Company prior to the end of each Plan year. For the period from January 1, 2024 through September 30, 2024 and the year ended December 31, 2023, the Company approved a matching contribution of 100% of the first 3% of compensation and 50% of the next 4% of compensation. The 2024 first quarter, second quarter and third quarter matching contributions and the 2023 third quarter and fourth quarter matching contributions were remitted to the plan in 2025, and, therefore, has been recorded as contribution receivable in the statement of net assets available for benefits. The Company may also contribute an additional discretionary non-elective contribution allocated in proportion to each participant's compensation. The Company did not make additional discretionary contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses. Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan offers a money market fund, mutual funds, a common collective trust, and self-directed brokerage accounts as investment options for participants. Allocations are based on account balances or compensation, as defined by the Plan Agreement. The benefit to which a participant is entitled is the participant's vested account balance.

Notes to Financial Statements

Vesting

Participants are immediately vested in their contributions and actual earnings and losses thereon. Vesting in the Company's contributions is based on years of continuous service, as defined in the Plan Agreement. Company contributions and earnings thereon vest according to a three-year cliff vesting schedule. Participant accounts are fully vested in the event of death or permanent physical or mental disability while employed by the Company.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or participant's beneficiary in the event of death, receives a lump-sum amount equal to the value of the participant's vested account. In-service withdrawals are allowed upon the attainment of age 59½. Withdrawals of participant deferrals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum note amount is \$1,000. Participants may be granted one loan during any one-year period and may have only one note outstanding at any time. The notes are secured by the balance in the participant's account, and interest rates are based on prevailing interest rates charged by other lenders for similar notes. The interest rate is established at the date the note is made and remains fixed throughout the term of the note. Interest rates on outstanding notes receivable ranged from 4.25% to 11% at December 31, 2024. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence, which may be repaid over a maximum of ten years.

Forfeitures

Forfeitures of non-vested Company matching, and non-elective contributions not used to pay the Plan's administrative expenses or reduce employer contributions may be reallocated to remaining participants as of the last day of the Plan year in which the forfeiture occurred. No forfeitures were used to reduce employer contributions during the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, forfeitures of approximately \$200 and \$100, respectively, were used to pay administrative expenses. There were approximately \$78,700 and \$60,000 in the forfeitures account available to be used at December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Companies consider the principal or most advantageous market in which they would transact and consider the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - This level consists of observable inputs, such as quoted prices in active markets for identical investments that the Companies have the ability to access.

Level 2 - This level consists of inputs that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3 - This level consists of unobservable inputs in which there is little or no market activity for the asset or liability, which require the reporting entity to develop its own estimates and assumptions relating to the pricing of the asset or liability, including assumptions regarding risk.

During the year ended December 31, 2024, there were no transfers between levels.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual Funds - These are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year-end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Money Market Funds - This is valued at the net asset value (NAV) of the shares held by the Plan at year-end and is determined based on the value of the underlying investments of the fund. The money market account seeks to maintain a \$1.00 NAV.

Collective Investment Trust (CIT) - The Plan has a CIT invested in the Advisor Stable Value Fund (the Fund). CITs are public investment vehicles valued using the NAV provided by the trustee on the last day of the Plan's year-end as a practical expedient to estimate fair value. NAV is based on the value of underlying investments, primarily guaranteed investment contracts, synthetic guaranteed investment contracts, short-term securities, and mutual funds, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CIT provides for daily redemptions by the Plan at reported NAV. There is no restriction in place with respect to the daily redemption of the CIT. Unfunded commitments are not applicable to the Plan and the redemption notice period is 12 months.

Self-Directed Brokerage Accounts - Self-directed accounts are underlying investments consisting of mutual funds, money market funds, and common stock; see the valuation methodology for money market and mutual funds above. Common stock is valued at the closing price reported on stock exchanges.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Interest income is recorded in the period earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a distribution is recorded.

Contribution Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary employer contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Payment of Benefits

Benefits are recorded when paid. There were no amounts due to participants who have withdrawn from the Plan but have not been paid as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan sponsor evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 14, 2025, the date the financial statements were available to be used.

4. Information Certified by the Trustee

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the years then

ended, was obtained by management, and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and nonforfeitable.

6. Tax Status

The Plan adopted a pre-approved plan document sponsored by FMR, LLC. FMR, LLC has received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds; money market funds, including a money market fund within the self-directed brokerage accounts; and units of a CIT managed by an affiliate of Fidelity. Fidelity is the current trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid administrative fees of approximately \$2,400 and \$2,500 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

8. Delinquent Participant Contributions

During 2024, the Company failed to remit to Fidelity certain employee contributions totaling \$1,642 within the period prescribed by DOL regulations. The Company calculated and remitted the 2024 related lost earnings to the Plan in February 2025.
