Notes to Financial Statements**

**1. Description of Plan**

**General.** The following description of Pediatric Associates, LLC Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering all full-time employees of Pediatric Associates Holding Company (the “Company”) who have completed three months of continuous service and are age 18 or older. Date of eligible participation occurs on the first day of each month after the requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a profit-sharing plan under Section 401(k) of the Internal Revenue Code.

**Contributions.** Participants may contribute up to 100% of pre-tax annual compensation up to a maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Catch up contributions are permitted for participants age 50 or reaching an age of 50 during each of the plan years. Participants can also rollover amounts representing distributions from other qualified defined contribution plans. The Company, at its own discretion, may make a matching contribution to the Plan. The Company matches 50% of the first 3% of pre-tax annual compensation that non-highly compensated participants contribute to the Plan. The Company contributed employer matching contributions of \$303,924 and \$229,221 during the years ended December 31, 2024 and 2023, respectively. Additionally, profit sharing amounts may be contributed at the option of the Company’s Board of Directors, which are allocated to participants employed at the end of the year. Such allocations are based on a formula, which considers both lengths of service and current earnings. The Company did not contribute profit sharing amounts to the Plan in 2024 and 2023.

**Participant Accounts.** Each participant’s account is credited with the participant’s contribution and allocations of the Plan’s earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in Company contributions based upon the following schedule:

Employee deferral and rollover account balances (balances resulting from transfers of benefits from another qualified plan) and earnings thereon are 100% vested at all times.

**Payment of Benefits.** Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or in installments as designated by the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Investment Options.** Upon enrollment in the Plan, participants may direct their contributions to any of the investment options selected by the Plan administrator.

Participants may change their investment options with the custodian in writing, via the Internet or by telephone. Changes are processed by the following day.

**1. Description of Plan (Cont'd.)**

**Notes Receivable from Participants.** Participants are immediately vested in their own contributions plus actual earnings thereon. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 7.25% to 9.5%, which are commensurate with local prevailing rates as determined periodically by the custodian. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Forfeited Amounts.** At December 31, 2024 and 2023, balance of forfeited non-vested accounts totaled \$126,349 and \$49,511, respectively. During the years ended December 31, 2024 and 2023, forfeited non-vested amounts of \$-0- and \$45,258, respectively, were used to offset fees and employer contributions.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting.** The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Investments in mutual funds are stated at estimated fair values, which have been determined based on the unit values of the mutual fund. Notes receivable from participants are valued at cost which approximates fair values. See Note 4 for discussion of fair value measurements.

Investment transactions are accounted for on a trade date basis. Realized gains or losses on sales of securities are determined on an average-cost basis. The Statement of Changes in Net Assets Available for Plan Benefits includes the net appreciation in fair value of its investments, which consists of the realized gains or losses and the change in unrealized appreciation on those investments.

The Plan is exposed to loss in the event of nonperformance by the investment manager for the funds in which the Trustee invests. However, the Plan does not anticipate nonperformance by the investment manager.

Benefits are recorded when paid.

**Administrative Expenses.** The employer bears most of the administrative expenses of implementing the Plan in accordance with the Plan document. Management fees paid to the Trustee are incurred by the participants.

**Subsequent Events.** The Plan Administrator has evaluated subsequent events through October 6, 2025, the date these financial statements were available to be issued.

**3. Investments**

The Plan offers various investment options in stocks, bonds, fixed income securities, mutual funds and other investment securities. These investment options are exposed to interest rate, market and credit risks. Due to the types of risks associated with these investment options, it is possible that changes in the value of certain of these investment options may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits and the Statement of Changes in Net Assets Available for Plan Benefits.

In the schedule below, as well as included within the Plan's investment assets, as listed on the Supplemental Schedule on page 7, are individual investment options which represent at least 5% of the Plan's net assets at December 31, 2024 and 2023.

**4. Fair Value Measurements**

The applicable guidance provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the applicable guidance are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**4. Fair Value Measurements (Cont'd.)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered Investment Companies:** Valued at fair value of shares held by the Plan at year end and categorized as a Level 1 fair value measurement.

**Insurance Funds (fixed income accounts):** Value reported daily based on the valuation method disclosed in the annuity contract and categorized as Level 2 fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Contract with Insurance Company**

During 2024 and 2023, the Plan offered fixed interest investment options (fixed income accounts) that earn guaranteed interest at specified rates for specific periods. Contributions to these accounts are invested in the general assets of Empower Annuity Insurance Company of America as of December 31, 2024 and 2023. The interest rate on the fixed income accounts was 1.9% and 1.7% for the years ended December 31, 2024 and 2023, respectively.

**7. Related Party Transactions**

During 2024 and 2023, certain Plan investments were shares of registered investment companies and pooled separate accounts and fixed income accounts managed by Empower Annuity Insurance Company of America, the custodian, as defined by the Plan. Fees paid to Empower Annuity Insurance Company of America by the Plan for the years ended December 31, 2024 and 2023 were \$50,323 and \$33,860, respectively.

**8. Income Tax Status**

The Plan adopted the “Prototype Plan,” which has obtained an IRS Favorable opinion letter on March 31, 2014 stating that the Prototype Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. As an adopter of this Prototype Plan, the Plan may rely on this favorable opinion letter with respect to the qualification. The Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes the Plan is operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and is tax-exempt.

The Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. Additionally, the Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will receive a benefit equal to the value of the participant’s vested interest in their account as of the date of the distribution. Participants will have the option of receiving a lump sum distribution or can rollover their distribution into an Individual Retirement Account.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits.
