Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dari-Mart Stores, Inc. and Affiliated Companies Employee Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dari-Mart Stores, Inc. and Affiliated Companies Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Dari-Mart Stores, Inc. and Affiliated Companies Employee Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Plan Description

The following description of Dari-Mart Stores, Inc. and Affiliated Companies Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2021.

General

Dari-Mart Stores, Inc. and Affiliated Companies operate convenience stores, a gas station, a dairy farm, and dairy production and manufacturing plants in the Willamette Valley, Oregon. An affiliated company owns the real estate of the operations described above.

The Plan is a multiple-employer defined contribution plan covering all employees of Dari-Mart Stores, Inc.; Lochmead Farms, Inc.; Lochmead Dairy, Inc.; S&G Investments, Inc.; and Gibson & Gibson, LLC (collectively, the Employers) who are at least 18 years old and have completed one year of service with 1,000 hours. Once eligibility requirements have been met, employees enter the Plan on January 1 or July 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The original effective date of this Plan was March 27, 2000. The trustees of the Plan are responsible for oversight of the Plan and the appropriateness of the Plan's investment offerings and for monitoring investment performance.

Contributions

Each year, participants may contribute pretax annual compensation, as defined in the Plan, not to exceed statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who are enrolled in the Plan and have elected a deferral rate of less than 2 percent or have made an election not to contribute will also have their deferral rate set at 2 percent. The automatic deferral amount increases by 1 percent annually, up to 4 percent, not to exceed the maximum allowable deferral.

The Employers' matching contributions are discretionary and are determined annually. Matching contributions shall not exceed 2 percent of compensation as defined in the Plan. In 2024 and 2023, matching contributions were 50 percent of the first 4 percent of base compensation that a participant contributes to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employers' contributions, earnings and losses on the participant's account balance, and is charged with an allocation of administrative expenses and fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Plan Description, continued

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employers' matching contribution portion of their accounts is based on years of continuous service. If termination is due to death or total and permanent disability, the participant is considered to be 100 percent vested. The Employers' contributions vest as follows:

Payment of Benefits

Upon retirement, disability, death, or termination of employment, a participant (or their designated beneficiary) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. In-service distributions are available at attainment of age 59½. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals are allowed from vested balances.

Participant Loans

Participants are not permitted to borrow from their accounts under the Plan.

Forfeitures

Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and can be used to pay Plan administrative expenses or reduce future Employers' contributions at the discretion of the Employers. For the years ended December 31, 2024 and 2023, the Plan had \$9,213 and \$10,325, respectively, in new forfeited accounts. During the years ended December 31, 2024 and 2023, the Plan used \$7,500 and \$-0- of forfeitures to pay administrative expenses, respectively. During the years ended December 31, 2024 and 2023, the Plan used \$17,860 and \$-0- of forfeitures to reduce employer contributions, respectively. At December 31, 2024 and 2023, available unused forfeited accounts totaled \$9,624 and \$26,624, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Contributions

Participant and employer contributions are recorded in the year in which the participant contributions are withheld or the underlying compensation is paid.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income (loss) is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

General Plan administrative expenses, investment management fees, and other fees are paid from participant accounts. Administrative expenses paid by the Employers are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments or as a reduction from investment income.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited a fixed monthly amount which is used to pay investment advisory expenses. For the years ended December 31, 2024 and 2023, \$17,524 and \$33,110, respectively, was credited to the account and used to pay investment advisory expenses. At December 31, 2024 and 2023, \$29,251 and \$11,413 of revenue sharing credits were available for use.

Corrective Distributions Payable

At December 31, 2024 and 2023, a liability of \$20,779 and \$11,995, respectively, was recorded for amounts refundable by the Plan to participants for deferral contributions deposited in excess of elected or allowable amounts, including as a result of required compliance testing. This amount is included as corrective distributions payable and corrective distributions on the accompanying financial statements.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Financial Life Insurance Company Inc., acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Cash equivalent funds held by the Plan are valued at cost, which approximates fair value. These assets are treated as Level 2 because there is not an active market for them.

Registered investment companies: Valued at the daily closing price as reported by the fund. All mutual funds held by the Plan are open-ended mutual funds held within a group annuity contract that are registered with the Securities and Exchange Commission (SEC) and are deemed to be actively traded.

Unallocated cash, insurance general accounts: Recorded at contract value which approximates fair value of the underlying general account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Spin Off

Effective January 1, 2023, the participating employer Bliss Unlimited, LLC spun off into a separate defined contribution plan. The assets of the employee group of Bliss Unlimited, LLC have been transferred to that plan during the years ended December 31, 2024 and 2023 in the amount of \$1,342 and \$600,799, respectively.

6. Tax Status

The Plan is based on a non-standardized pre-approved profit sharing plan with CODA. Transamerica Retirement Solutions LLC, the sponsor of the pre-approved plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, that the basic plan document satisfies Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party in Interest Transactions

Certain Plan investments are managed by Transamerica Financial Life Insurance Company (TFLIC), the custodian of the Plan, and therefore these transactions qualify as party-in-interest transactions. Administrative fees paid to Transamerica Retirement Solutions, an affiliate of TFLIC, for 2024 and 2023 totaled \$28,448 and \$30,049, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Plan Termination

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employers' contributions.

10. Non-Exempt Transactions

For the years ended December 31, 2024 and 2023, participant contributions totaling \$13,194 and \$6,321, respectively, were not remitted to the Plan within the appropriate time period by the Employers. These transactions constitute prohibited transactions as defined by ERISA. The Employers are taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest, and have further implemented a procedure to ensure that all future remittances are made within the prescribed time period. Of the total delinquent contributions, \$6,321 were fully corrected with lost earnings in 2024, and \$13,194 will be corrected with lost earnings in 2025.
