Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the LeafHome 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of Plan

The following description of the LeafHome 401(k) Plan (the Plan) (formerly known as the LeafFilter North, LLC 401(k) Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is sponsored and administered by LeafFilter North, LLC (the Plan Sponsor or Company). The Plan allows employees from Leaf Home Water Solutions, LLC, Leaf Home Safety Solutions, LLC, and Leaf Home Enhancements, LLC as related employers to participate in the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a defined contribution plan covering all eligible employees of the Company. To be eligible to participate in the Plan, employees must be at least 18 years of age and complete 90 days of service. All employees of the Plan Sponsor on January 1, 2016, the formation date of the Plan, were immediately eligible given they met the age requirement.

The Plan changed its third-party administrator from Transamerica Retirement Solutions to Nova 401(k) Associates effective January 1, 2024. In addition, Transamerica Trust Company replaced Reliance Trust Company as the Plan's custodian on July 1, 2024.

Contributions: Employee contributions shall commence as soon as administratively practical on or after the date on which the participant's election is effective, which is the first day of the month following eligibility. Eligible employees are automatically enrolled in the Plan at a minimum of 6% of compensation for new employees, and all participating employees will be automatically escalated 1% annually until 10% total deferral election is reached. Participants may contribute an amount of eligible pretax or after-tax Roth annual compensation not to exceed limits established by the Internal Revenue Code (IRC), as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other certain qualified plans. The Company may make a matching contribution at its discretion. The Company elected to match 10% of contributions for the years ended December 31, 2024 and 2023.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the employer contributions and Plan earnings and is charged with an allocation for administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their employee contributions, rollover contributions, catch-up contributions and actual earnings or losses thereon. Participants vest in that portion of their accounts attributable to contributions by the employer based on their years of vesting service under the Plan, as defined in the Plan document, as follows:

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested portion of their accounts, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Benefit payments: A participant may withdraw all or part of his/her interest in the Plan attributable to rollover contributions while still employed by the Company. In addition, a participant or elected beneficiary, upon termination, death or retirement, may receive the vested interest in his/her account in the form of a lump-sum payment or a rollover to an individual retirement account or other qualified plan. Hardship withdrawals, as defined by the Plan, are also available to participants.

The Plan allows for automatic payment of the participants vested balance upon termination, provided that the vested balance is less than \$7,000 (\$5,000 prior to January 1, 2024).

Forfeited accounts: The unvested portion of a participant's interest in their account is forfeited upon termination from the Plan. Amounts forfeited are to be held in a separate account and applied to reduce future employer contributions. At December 31, 2024 and 2023, unallocated forfeited accounts and forfeitures applied to the plan expenses during the year were not significant to the financial statements.

Administrative expenses: All expenses of maintaining the Plan are paid by the Plan or the Company, at the discretion of the Company.

Plan termination: Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. In the event of termination of the Plan, participants will become 100% vested in their accounts. The assets then remaining in the Plan will be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) require management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Participant contributions are recognized when earned. Company matching contributions are recognized concurrently with participant contributions.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Benefit payments: Benefits are recorded when paid.

Risks and uncertainties: The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, four and three investments, each greater than 10% individually, accounted for approximately 45% and 33% of total investments, respectively. This represents a concentration of credit risk.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 7, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Reliance Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by the current and former custodians. The Plan Administrator has obtained a certification from the current custodian, Transamerica Trust Company, as of December 31, 2024 and for the period from July 1, 2024 to December 31, 2024, that the information provided to the Plan Administrator is complete and accurate to the best of its knowledge and belief. The Plan Administrator has obtained certifications from the former custodian, Reliance Trust Company, as of December 31, 2023 and for the period from January 1, 2024 to June 30, 2024, that the information provided to the Plan Administrator is complete and accurate to the best of its knowledge and belief.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023:

Mutual funds: Valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of assets within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of assets from one fair value level to another. There were no transfers in or out of Level 3 for the year ended December 31, 2024.

Note 5. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The Plan changed its third-party administrator from Transamerica Retirement Solutions to Nova 401(k) Associates effective January 1, 2024. The current pre-approved plan provider, Nova 401(k) Associates, has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The former pre-approved plan provider, Transamerica Retirement Solutions Corporation, has received an opinion letter dated June 30, 2020 from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letters have been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Party-in-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employers and certain others. Fees paid were \$501,898 for the year ended December 31, 2024, of which an investment advisor that has an indirect ownership interest in the Plan Sponsor was paid approximately \$107,000.
