INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed our audits of the financial statements of 10X Genomics 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

1. Description of Plan

The following description of 10X Genomics 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and/or Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted by 10X Genomics, Inc. (the “Company”) on January 1, 2015, and was most recently amended and restated February 1, 2022 to reflect required legal and statutory changes. The Plan is defined as a contribution retirement plan of the profit-sharing type containing a cash or deferred arrangement described in Internal Revenue Code (“IRC”) Section 401(k). All employees of the Company, except employees covered by a collective bargaining agreement, leased employees and non-resident aliens, who are age 21 or older are eligible to participate in the Plan on the first day of the month following employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC. The Administrative Committee is responsible for oversight of the Plan. The Administrative Committee also determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Effective January 1, 2024, the Plan was amended to exclude restricted stock and stock options from the definition of compensation.

Effective April 8, 2024, the Plan was amended to permit employees to make voluntary non-deductible after tax contributions, not to exceed 75% of their compensation.

Plan Administration

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company was the appointed trustee for the Plan for the years ended December 31, 2024 and 2023, and acted at the direction of the Plan’s administrator.

Contributions

Participants are permitted to make pre-tax salary deferrals, Roth and after-tax contributions in percentage increments up to 75% of their eligible annual compensation, as defined by the Plan. Participants that have reached the age of 50 may also elect to withhold additional catch-up contributions under the IRC. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to IRC regulations. Participants are automatically enrolled into the Plan at an initial pre-tax deferral contribution rate of 5% of their eligible annual compensation, as defined by the Plan, unless the participant affirmatively elects otherwise. The automatic enrollment deferral rate will escalate by 1% annually up to 10% of a participant’s eligible annual compensation. The automatic enrollment feature will default to invest the participants’ contributions into the Vanguard Target Retirement funds offered by the Plan, based on the participant’s age, unless the participants affirmatively direct the investment of their contributions into various other investment options offered by the Plan. Participants may adjust their deferral rate or discontinue their contributions at any time.

The Company provides a discretionary matching contribution to each participant who is eligible to share in discretionary matching contributions for the Plan year. For the year ended December 31, 2024, the discretionary employer matching contributions were calculated as 100% of employee deferrals up to 3% of eligible compensation on a per pay period basis, with an annual cap of \$2,000 and an annual “true-up.” The Company made discretionary matching contributions of \$1,960,062 for the year ended December 31, 2024.

1. Description of Plan, continued

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions, rollovers, and discretionary Company matching contributions, and net earnings on these contributions, are fully vested when made or earned.

Notes Receivable from Participants

Participants are allowed up to one note receivable at any time and may borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their account balance, or \$50,000, whichever is less. Note receivable terms range from one to five years, except for notes receivable used to purchase a primary residence, which have a maximum term of 30 years. The notes receivable are secured by no more than 50% of the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the note receivable originates. Interest rates on notes receivable from participants ranged from 5.25% to 10.50% per annum as of December 31, 2024. Principal and interest are paid in equal installments through payroll deductions.

Payments of Benefits

When participants leave the Company, upon retirement or for any other reason, those participants (or their beneficiaries) may receive the vested value of their account in a single lump-sum payment. The Plan also allows for in-service withdrawals upon a participant attaining the age of 59½, or having a hardship. In-service withdrawals may be taken from the pre-tax and Roth 401(k) elective deferral account, discretionary Company matching contributions, and rollover accounts, as long as they are vested. In addition, the Plan allows for withdrawals of any rollover contributions at any time.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. Mandatory distributions of account balances under \$7,000 will be made as soon as possible. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan's administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan's administrator.

Investment Options

Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments or fixed dollar amounts into a series of mutual funds and a money market fund offered by the Plan. Participants automatically enrolled into the Plan will have the investment of their contributions defaulted to the Vanguard Target Retirement funds based on their age, unless the participants affirmatively direct the investment of their contributions into various other investment options offered by the Plan. Participants may change their investment options at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities, and changes in net assets available for benefits. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant fails to make a loan repayment and does not cure the default by the end of the following calendar quarter, the note receivable from participant is treated as a deemed distribution, with a corresponding reduction to notes receivable from participants and recognition of a benefit payment. Notes receivable from participants become due and payable upon the termination of employment (see Note 9).

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Information Certified by the Trustee

Fidelity Management Trust Company has prepared and certified as complete and accurate the Plan's schedule of investment assets and transactions, notes receivable from participants, interest on notes receivable from participants, net realized and unrealized gains and losses on investments, and interest and dividend income, which was used to prepare the accompanying financial statements and supplemental schedule of assets (held at end of year).

SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. These changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

3. Fair Value Measurements

Accounting standards for fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Cash equivalent – money market fund: Valued based on redemption values on the last business day of the Plan year. Securities held by stable net asset value (“NAV”) money funds operating pursuant to Rule 2a-7 under the Investment Company Act of 1940, are valued at amortized cost, which approximates current fair value, and are considered to be valued using Level 2 inputs.

3. Fair Value Measurements, continued

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments in mutual funds are or were managed by Fidelity Management Trust Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Notes receivable from participants and interest income on notes receivable from participants are also considered party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

6. Tax Status

The Plan uses a prototype plan document sponsored by FMR LLC, which received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Company does not believe the Plan has any uncertain tax positions. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, distributions will be made to participants as described in the Plan agreement and participants will remain fully vested in their accounts.

8. Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and a money market fund offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As of December 31, 2024, approximately, 65% of net assets available for benefits were held in five mutual fund investments offered by the Plan. As of December 31, 2023, approximately 53% of net assets available for benefits were held in four mutual fund investments offered by the Plan.

9. Subsequent Events

In accordance with accounting standards affecting disclosures of subsequent events, the Plan evaluated subsequent events for recognition and disclosure through October 13, 2025, the date which these financial statements were available to be issued. Management concluded that, other than noted below, no additional material subsequent events have occurred since December 31, 2024 that require recognition or disclosure in these accompanying financial statements.

Effective January 1, 2025, the Plan implemented all required provisions of SECURE Act 2.0 that became mandatory for Plan year 2025.

Effective February 1, 2025, the Plan was amended to exclude fringe benefits, moving expenses, deferred compensation and welfare benefits from the definition of compensation.

On June 3, 2025, the IRS issued a Voluntary Compliance Program compliance statement to the Plan and Company, approving the retroactive amendment of the Plan to correct a failure by excluding stock-based earnings from the definition of compensation. Pursuant to this approval, the Plan was retroactively amended and restated to exclude the value of restricted stock and non-qualified stock options granted to employees from the definition of eligible compensation on July 28, 2025.

Also on July 28, 2025, the Plan was amended to revise the treatment of notes receivable from participants. Under the amended provision, the outstanding principal and accrued interest on such notes will not become immediately due and payable upon termination of employment, but will instead continue to be payable in accordance with the original repayment schedule. Additionally, the amendment clarified certain provisions related to automatic enrollment, including: (i) participants will be automatically enrolled into the Plan 35 days after becoming eligible; (ii) the automatic escalation feature will only apply to participants with a deferral rate greater than 0% who were automatically enrolled; and (iii) the escalation will occur annually in March, except that it will not apply within the first six months following automatic enrollment.

Effective September 15, 2025, the Plan was amended to include Scale Biosciences, Inc. as a participating employer.
