## Note A - Description of Plan

The following description of the Franchise Management 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all non-union employees of Franchise Management, LLC (the "Company") who have completed one year of service and attained the age of 21. The entry date of the Plan is quarterly on the first day of each quarter of the Plan year. Employees of Franchise Management, LLC and related entities are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Please refer to the Company's Plan document for more information.

### Contributions

Each year, participants may contribute up to the maximum allowed by law of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with Internal Revenue Code Section 414(v). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make matching or additional contributions on a discretionary basis equal to a uniform percentage as determined by management. For the year ended December 31, 2024, the employer elected to make a matching contribution of \$472,436. Contributions are subject to certain limits.

### Participant Accounts

Each participant's account is credited with the participant's own contribution, an allocation of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the remainder of their account plus earnings thereon is based on years of credited service. A participant becomes 20% vested after two years of service, 40% after 3 years of service, 60% after 4 years of service, 80% after 5 years of service and fully vested after 6 years of service.

### Payment of Benefits

On termination of service due to death, disability, retirement, or due to other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows required minimum distributions to be paid in installments only if the participant is required to receive lifetime required minimum distributions.

### Hardship Withdrawal

A participant can withdraw from the Plan, part, or all the participant's contributions for a financial hardship. The Plan Management shall determine what portion of such account balance is necessary to alleviate the hardship. A financial hardship must be one of the reasons specified in the Plan document.

### Forfeitures

Forfeitures of terminated participants' non-vested account balances may first be used to offset plan expenses. Any remaining forfeitures may be used to reduce the employer's matching contribution. As of December 31, 2024 and 2023 there were \$25,383 and \$6,196 in forfeitures, respectively. During 2024 \$0 in forfeitures was used against employer contributions.

### Investment Options

Participants may direct investments of their account into a range of investment options under the terms of the Plan. Participants can change the investment of their funds on a daily basis.

## Note B - Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Participant Contributions Receivable

Participant contributions receivable represent participant deferrals withheld prior to December 31, 2024 and 2023. The balance is based on actual collections subsequent to year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial. Participant contributions receivable were \$0 and \$85 as of December 31, 2024 and 2023, respectively.

### Employer Contributions Receivable

Employer contributions receivable represent employer matching contributions related to participants deferrals withheld prior to December 31, 2024 and 2023. The balance is based on actual collections subsequent to year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial. Employer contributions receivable were \$125 and \$86 as of December 31, 2024 and 2023, respectively.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

## Note C - Information Prepared and Certified by the Custodians

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included on the related statements of changes in net assets available for benefits for the years then ended, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the custodians in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's cash and investments were held in custodial accounts maintained by Mid Atlantic Trust Company for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, the certified cash amount is \$44,021 and \$33,447 and certified investments are \$4,709,454 and \$2,790,059, respectively. Total investment income amounted to \$430,450 for the year ended December 31, 2024.

Plan management obtained certifications from Mid Atlantic Trust Company for the years ended December 31, 2024 and 2023. The Plan's independent certified public accountants did not perform audit procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

## Note D - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of value hierarchy under FASB ASC Topic 820 are described as follows:

### Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are delivered principally from or corroborated by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable measurements.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price reported on an actively traded exchange and are reported at level 1.

The preceding method described may produce fair value calculations that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

## Note E - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of plan termination, participants will become 100% vested in their employer contributions.

## Note F - Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

## **Note G - Risks and Uncertainties**

### **Investments**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Concentration of Cash**

Cash consists of monies held in noninterest bearing accounts. The Plan places its cash with a financial institution deemed to be creditworthy.

## **Note H - Party-in-Interest Transactions**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Plan transactions with parties-in-interest include administrative fees paid to the Plan's third-party administrators, North American KTRADE Alliance, LLC., Latitude Service Company, Inc., and Cetera Advisors, LLC as well as custodian, Mid Atlantic Trust Company.

## **Note I - Subsequent Events**

Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued.
