Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Logix Employment Services, Inc. Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Logix Employment Services, Inc. Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 – Description of Plan

The following brief description of the Logix Employment Services, Inc. Employee Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all salaried employees not employed under a collective bargaining agreement of Logix Employment Services, Inc. (LESI or the Plan Sponsor), a wholly owned subsidiary of Logix Federal Credit Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). State Street Bank and Trust Company ("State Street" or the "Trustee") is the Plan Trustee and custodian. Transamerica Retirement Solutions LLC (TRS) provides administrative and record-keeping services to the Plan. All employees are eligible to participate on the first day of the payroll period or on the date requirements are met.

Eligibility and contributions – The Plan allows participants to contribute up to a maximum of 100% of their compensation, as defined in the Plan, up to statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Employees who have met eligibility criteria are subject to automatic deferral provisions. The automatic deferral provisions require an initial deferral rate of 3% for each payroll period. After an employee completes one year of service, the initial automatic deferral amount shall increase 1% each successive year until the deferred rate reaches 10% or until the participant makes an election for a different deferral rate.

Employees who have completed one year of service are eligible to participate in the matching contribution features of the Plan. The Plan Sponsor contributes a matching amount of 60% of the first 8% contributed by the participant, subject to certain limitations. A non-bargaining unit participant who was hired before January 1, 2007, and is under age 40 with less than five years of service as of December 31, 2006, and any participant who transfers into the non-bargaining unit plan or is hired or rehired after December 31, 2006, is eligible to participate in a discretionary profit sharing contribution, which may be made at the option of the Plan Sponsor's board of directors. A participant must also complete 500 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible for the discretionary profit sharing contribution. Contributions are subject to certain limitations. For the year ended December 31, 2024, total employer contributions consist of matching contributions totaling \$2,843,300, of which \$139,635 was applied from forfeitures, and profit sharing contributions totaling \$3,845,801.

Participant accounts – Each participant's account is credited with the participant's contribution and allocation of the Plan Sponsor's matching and profit sharing contributions. Plan earnings and losses on investments are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's contributions portion of their accounts, plus earnings thereon, is based on years of continuous service. Vesting credit is 0% until the third year is reached, at which time their vesting credit becomes 100%.

Payment of benefits – Upon termination of service due to death, disability, retirement, or other reasons from the Plan Sponsor, participants may elect to receive the vested interest of their account in the form of a lump-sum distribution, partial payments, or installments. The Plan will also make involuntary cash-outs of account balances of terminated vested participants of \$1,000 or less. In addition, eligible rollover distributions of account balances greater than \$1,000 but not greater than \$7,000 will be subject to the automatic rollover requirements.

Forfeitures – Forfeitures will be used to offset Plan expenses and reduce employer contributions. For the year ended December 31, 2024, \$139,635 of forfeitures were applied to reduce employer contributions and \$59,795 were used to offset Plan expenses. At December 31, 2024 and 2023, unallocated forfeitures totaled \$3 and \$1,388, respectively.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is commensurate with local prevailing rates. Loan terms may range from one to five years, or longer if used to purchase the primary residence of the participant. As of December 31, 2024, the outstanding loans have various maturities through November 2038. Principal and interest are paid ratably through payroll deductions. In the event the scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due, the loan is considered to be in default and considered a deemed distribution.

Note 2 – Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment valuation – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value measurements and income recognition – Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. LESI's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and State Street, the Trustee. See Note 4 for a discussion of fair value measurements. The authoritative guidance describes a fair value hierarchy based on three levels of inputs, of which the first two are considered observable and the last unobservable, that may be used to measure fair value:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation methodologies used for assets at fair value – Mutual funds are valued at the net asset value of shares held by the Plan at year end based on quoted market prices. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Income recognition – Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses on the purchases and sales of investments during the year and unrealized appreciation or depreciation of investments held during the year. Purchases and sales of securities are recorded on a trade-date basis.

Contributions – Contributions from the Plan participants are recorded in the year in which participant contributions are withheld from amounts paid, or earned and not yet paid. Employer-matching contributions are recorded in the year in which the contributions are withheld or earned on a per-pay-period basis from amounts paid. Discretionary contributions, if any, are recognized upon the authorization of the Plan Sponsor's board of directors. All participant and employer contributions are participant-directed.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – The Plan incurs record-keeping and administrative expenses. Specific participant transaction expenses are deducted from participant accounts directly. Plan expenses that cannot be directly charged to a specific participant transaction may be paid, in whole or in part, from revenue-sharing payments that the Plan receives from certain participating funds. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events – The Plan has evaluated for disclosure subsequent events occurring through October 14, 2025, the date the financial statements were available to be issued.

Note 3 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends on investments, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 5 – Investment Contract with Insurance Company

The investment in the Stable Value Fund is a contractual account with New York Life. New York Life maintains the Plan's contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer, New York Life, is contractually obligated to repay the principal and use a specified interest rate, subject to change daily, which is guaranteed to the Plan, and this crediting rate may not fall below 0%.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. As such, the statements of net assets available for benefits present the New York Life Stable Value Fund at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events would limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) total or partial Plan termination; (2) changes to the Plan's prohibition on competing investment options; (3) mergers; (4) spinoffs; (5) layoffs; (6) early retirement incentive programs; (7) sales or closings of all or part of a participating plan sponsor's operations; (8) bankruptcy; (9) receivership; and (10) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exception under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; and (4) a material amendment to the agreements without the consent of the issuer.

Note 6 – Related-Party Transactions and Administrative Expenses

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan assets are maintained by State Street. State Street is the Trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Fees received from the Plan investments, in the form of 12b-1 fees, sub-transfer agency fees, and administrative servicing fees, are paid into an "Expense Budget Account" within the Plan. Contractual fees for record-keeping services and other allowable Plan administrative expenses are paid from this account or may be allocated to participants at the direction of the employer. Revenue-sharing income is reflected in net appreciation in fair value of investments and expenses paid from revenue-sharing funds are recorded in administrative expenses.

Certain administrative functions are performed by employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses for participants are paid directly by the Plan Sponsor.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any portion of their accounts not already 100% vested.

Note 8 – Tax Status

The Plan adopted a volume submitter 401(k) profit sharing plan that has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the qualified status of the volume submitter plan document. The advisory letter has been relied upon by the Plan. The Plan has been amended since the initial adoption of the volume submitter plan document. The Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
