INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Bunzl USA, LLC Deferred Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Bunzl USA, LLC Deferred Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan was adopted under the provisions of Section 401(a) of the Internal Revenue Code (the Code) with cash or deferred arrangement qualified under Section 401(k) of the Code. Bunzl USA, LLC (the Company) serves as plan administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Vanguard Fiduciary Trust Company (Vanguard) serves as the Plan's custodian, trustee and recordkeeper.

The Plan is governed by the Company's Retirement Plan Committee (Committee), which consists of members of management of the Company. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2024, the Plan was amended to provide for the merger of the Tingley Employee Savings, Profit Sharing & Retirement Plan and the Shelby Group Employees Profit Sharing 401(k) Plan. Plan assets of \$44,362,429 were transferred into the Plan from the mergers. In addition, the Plan was amended to permit Roth contributions, Roth catch-up contributions, and participant loans for all participants.

Effective July 19, 2024, the Plan was amended to provide for the merger of the Stx, Inc. 401(k) Profit Sharing Plan. Plan assets of \$59,629 were transferred into the Plan from the merger.

In December 2024, the Plan was amended to provide for the merger of the McCue Corporation 401(k) Profit Sharing Plan (McCue Plan). Effective December 31, 2024, Plan assets of \$7,783,775 were transferred from the McCue Plan and received by the Plan on January 2, 2025. In addition, the Plan was amended to add a disaster recovery distribution option to the Plan.

Participant Contributions

An eligible employee who participates in the Plan may make basic pre-tax, Roth, and Roth catch-up contributions to the Plan through payroll deductions of any percentage between 2% and 50% (16% for highly compensated employees, as defined) of their earnings. New participants hired are required to contact Vanguard Participant Services within one month from the date of hire otherwise the participant will be enrolled in the Plan at 6% with contributions beginning on the first eligible pay date following one calendar month of employment. The contribution will automatically increase 1% per year each January up to a maximum of 10%, unless the participant opts out of the automatic increase.

The maximum pre-tax contribution a participant could make was \$23,000 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

Company Contributions

Matching contributions are made by the Company in an amount equal to 75% of each participant's basic pre-tax contribution, not to exceed 6% of their eligible earnings. In addition, the Company may make Retirement Savings Benefit (RSB) contributions for certain eligible employees as defined in the Plan document. Contributions are subject to certain Code limitations.

Investment Options

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

Participant Accounts

Each participant's account is credited with the participant's contribution, the appropriate amount of the Company's contributions and Plan earnings, net of expenses, on those contributions. Allocations are based on participant earnings or account balances, as defined. Participants pay a participant fee of \$36 annually after the first year of employment. This fee is automatically deducted from the participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$358,620 and \$372,032, respectively. These accounts will be used to reduce future employer contributions. Also, for the year ended December 31, 2024, employer contributions were reduced by \$2,390,025 from forfeited nonvested accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions and the income thereon are vested according to the following schedule, as defined in the Plan document:

0 – 2	0%
2 – 3	20%
3 – 4	40%
4 – 5	60%
5 – 6	80%
Greater than 6 years	100%

Employees who were hired before 2003, and certain employees who were participants in plans which merged into the Plan, may have different vesting schedules as defined in the Plan Document. The Company contributions and the income thereon vest immediately in the event of death, permanent disability, normal retirement or the attainment of age 65, whichever is the earliest.

Notes Receivable From Participants

Active participants may borrow from the Plan up to 50% of their employee contributions up to a maximum of \$50,000 subject to certain provisions outlined in the Plan Document. All loans are secured by the participant's vested account and are repayable in installments through payroll deductions over a maximum of five years for a general loan or nine years for the purchase of a principal residence. Interest accrues at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions.

Withdrawals

During employment, a participant may make withdrawals of amounts applicable to their participant contributions, including rollovers, and income thereon, subject to certain restrictions as defined in the Plan document. A participant cannot withdraw Company contributions while employed until attainment of age 65. In addition, the Plan permits hardship withdrawals limited to only employee contributed funds.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant will receive a lump-sum distribution equal to the participant's vested account balance if the participant's vested account balance is \$1,000 or less. If the participant's account balance exceeds \$1,000, and the participant has not attained the normal retirement age, the participant and/or their representative must consent before any portion of such account may be distributed.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses, except certain expenses paid by the Company, are paid by the Plan and included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund, which is quoted net asset value (NAV) of shares.

Common/collective trusts: Valued at the NAV of units of the fund, which is based on the estimated market value of the underlying investments less its liabilities. The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value.

The Plan may redeem units of the stable value fund for the purpose of funding a bona fide benefit payment, making a participant loan, honoring an employee-directed transfer of the employee's interest in the plan to another investment election that is a noncompeting investment, or paying trustee fees. The Plan may make withdrawals from the fund for other purposes generally only upon 12 months' advance written notice to the trustee.

NOTE 4 — CERTIFIED INVESTMENTS

Information regarding investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Vanguard.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and units in common/collective trusts managed by Vanguard. Vanguard is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$1,123,341 for the year ended December 31, 2024, which was not covered by revenue sharing. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. The Company pays directly any other fees related to the Plan's operations.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 — TAX STATUS

The IRS has determined and informed the Company by letter dated November 29, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan is subject to examination by the IRS for the statutory period.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
