We have performed audits of the accompanying financial statements of Garage Isla Verde Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Garage Isla Verde Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF THE PLAN

The following description of Garage Isla Verde, LLC Retirement Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Garage Isla Verde, LLC (hereinafter referred to as the Sponsor) who have worked 1,000 hours in a calendar year following 12 months of service and are age twenty-one or older. Employees may enter the Plan the first day of the following quarter after they have met the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants can make pre-tax contributions up to the limitations prescribed under applicable law (\$15,000 in 2024 and 2023), as defined in the Plan.

Each Plan year, the sponsor shall contribute (a) the amount of the total salary deduction of all participants, which amount shall be deemed as the employee deferral contribution and (b) a matching contribution made at the sole discretion of the employer of eligible compensation for each eligible participant, which amount shall be deemed as the employer match contribution. In addition, there may be a discretionary employer contribution based on Plan Sponsor's earnings determined each year by the employer, which amount shall be deemed as the employer profit sharing contribution.

Participants' accounts

A separate account is maintained for each participant in the Plan, reflecting contributions, investments, realized and unrealized investments gains and losses, loans and interest, withdrawals, rollovers, and investment fees. The net value of each participant account is established at the close of each business day through the valuation of each fund's asset at fair value.

Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's contribution, if eligible, (b) and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested according to the following schedule:

20%	after two years of service
40%	after three years of service
60%	after four years of service
80%	after five years of service
100%	after six years of service

Investment option

Upon enrollment in the Plan, a participant directs the investment of his or her contributions into Mutual Funds.

Participants may change their investment options at any time through accessing the accounts via internet.

Distribution of benefits

Distribution of benefits to participants shall be made in a single lump sum payment.

The Plan permits distributions attributable to Sponsor contributions only upon the occurrence of one of the following events:

- a. retirement of the participant.
- b. separation from service (for any reason, including death).
- c. permanent disability of the employee.
- d. termination of the Plan.
- e. hardship distributions (if vested).

Distribution of a participant's vested interest upon termination of employment for any reason or upon attaining normal or early retirement age shall commence, unless the participant elects otherwise, be within a reasonable time, in which the latest of the following occurs:

- a. the participant attains age of 60 (or normal retirement age, if earlier).
- b. the fifth anniversary of the year in which the participant commenced participation in the Plan.
- c. the participant terminates service with the Sponsor.

Plan termination

In the event the Plan terminates, the assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

Forfeited accounts

Forfeitures of matching contributions are used to pay administrative expenses and/or to reduce employer's contributions as determined by the employer for any plan year.

Participants' loans

Participants currently employed may borrow from their funds a minimum of \$1,000 up to a maximum of \$50,000 limited to 50% of their vested account balance. The terms of loans for general purpose generally range from 1 to 5 years and loans for purchase of primary residence is 30 years. The loans are secured by the balance in the participant's account. The loans bear interest at 1% over prime rate. Principal and interest are paid through payroll deductions. Participants may have only one loan outstanding at any time.

NOTE B - ORGANIZATION, BASIS OF PRESENTATION, AND ACCOUNTING POLICIES

Organization

The Plan was organized and became effective on January 1, 1993.

Basis of presentation

The financial statements of the Plan are presented in the accrual method of accounting. The Plan sponsor and Plan administrator is Garage Isla Verde, LLC. The trustee of the Plan is Carlos M. Quiñones. Empower Retirement is the trust and recordkeeper of the Plan.

Reclassifications

Certain accounts in the 2023 statement of changes in net assets available for benefits have been reclassified for comparative purposes to conform with the presentation in the 2024 financial statement.

Accounting policies:

Investments valuation and income recognition

The Plan's investments are participant-directed and are stated at fair value. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income, including interest on loans to participants, is recorded on an accrual basis. Dividends are recorded on the dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement accounting literature (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value and describes inputs as either observable or unobservable. Observable inputs reflect market data obtained from independent sources while unobservable inputs reflect the Plan's view of market assumptions in the absence of observable market information. ASC 820 requires that the observable inputs be used wherever possible, resulting in the classification of the hierarchy.

The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. In determining fair value, the Plan uses various methods including market, income, and cost approaches.

The Plan categorizes its fair value measurements into a three-level hierarchy based on the priority of the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure fair value fall within different levels of the hierarchy, the category level is based on the lowest priority level input that is significant to the fair value measurement of the instrument in its entirety.

Fair value measurements – continued

The Plan categorizes assets and liabilities carried at fair value in the accompanying statement of assets available for benefits as follows:

- Level 1 - Unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date and mutual funds where the value per share (unit) is determined and published daily and is the basis for current transactions. Level 1 inputs are considered “observable” inputs.
- Level 2 - Unadjusted quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means. Primary inputs to this valuation technique may include comparative trades, bid/asks, interest rate movements, U.S. Treasury rates, Secured Overnight Financing Rate (“SOFR”), prime rates, cash flows, maturity dates, call ability, estimated prepayments, and/or underlying collateral values.
- Level 3 - Prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management’s best estimate about the assumptions market participants would use at the measurement date in pricing the asset or liability. Consideration is given to the risk inherent in both the method of valuation and the valuation inputs. Primary inputs to this valuation technique include broker quotes and comparative trades.

Changes in observability of significant valuation inputs identified during these reviews may trigger reclassifications. Reclassifications are reported as transfers at the beginning of the period in which the change occurs.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

NOTE D - FAIR VALUE MEASUREMENTS

Mutual Funds

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The market approach is used to measure fair value. Share Prices/Net Asset Values (NAV's) reported on the Plan Summary Reports for NAV mutual funds are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source.

Fixed annuities

The Plan measures fair value using Level 2 inputs because the reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

Collective Trust Funds

The net asset value is used as a practical expedient, as defined in ASC 820. This practical expedient is not applied when it is determined to be probable that this fund will sell the investment for an amount different to the reported net asset value. These investments are valued daily based on share prices/NAVs reported which are generally obtained directly from the fund house or the investment provider. The internal pricing analyst and management will review the overall movement of market indices and will apply judgement in determining whether any further research with investment providers will be pursued for share price variances from the prior day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INVESTMENTS CONTRACT WITH INSURANCE COMPANY

The Plan has a group annuity investments contract with Empower Retirement (Empower). Empower maintains the contributions in allocated contract assets. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses made by Empower. The contract is included in the statement of net assets available for benefits as fixed annuities at fair value, which represent contributions made under the contract, plus appreciation in value and earnings, less plan withdrawals and administrative expenses. The fair value of the investments contract at December 31, 2024 and 2023 was \$1,801,311 and \$673,377, respectively.

NOTE F - TRANSACTIONS WITH PARTIES-IN-INTEREST

The trustee, recordkeeping, contract administrator and the auditor of the Plan are considered parties-in-interest to the Plan. The Plan's administration and audit fees are paid by the Sponsor. Fees paid to parties-in-interest amounted to approximately \$54,000 in 2024 and \$47,000 in 2023. Fees paid to the trustee and auditor fees appear to be reasonable for the years ended December 31, 2024, and 2023.

NOTE G - INCOME TAX STATUS

The Department of the Treasury of the Commonwealth of Puerto Rico has ruled that the Plan qualifies under Section 1081.01 (e) of the Income Tax Act of 2011 (the Act), and is, therefore, not subject to income tax under the present income tax law. The Plan is required to operate in conformity with the Act to maintain its qualification. The Plan's Retirement Committee is not aware of any course of action or series of events that have occurred that might affect the Plan's qualified status.

The Plan obtained its latest determination letter on April 30, 2018, in which the Puerto Rico Treasury Department stated that the Plan, as then designed, was in compliance with the applicable requirements of the Puerto Rico Treasury Department. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Puerto Rico Treasury Department and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE H - FINANCIAL INSTRUMENTS, RISK, UNCERTAINTIES AND CONCENTRATION

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of assets available for benefits.

NOTE I - NONDISCRIMINATION TEST CORRECTIVE ACTIONS (SUBSEQUENT EVENT)

The Plan did not satisfy the Actual Deferral Percentage ("ADP") test for the plan year ended December 31, 2024. To correct the failure and maintain its qualified status, the Plan made a Qualified Non-Elective Contribution (QNEC) of \$525.98 to certain non-highly compensated participants on July 2, 2025.
