Independent Auditor's Report

To the Plan Administrator

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Instant Brands Retirement Income Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

*Opinion on the Financial Statements*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion on the Financial Statements*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Emphasis of Matter – Merging Plan*

As further discussed in Note 1 to the financial statements, the Plan merged with the Anchor Hocking 401K Plan effective January 1, 2025. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### Note 1 - Description of the Plan

The following brief description of the Instant Brands Retirement Income Plan (the "Plan"), sponsored by Instant Brands Holdings, Inc. (the "Company"), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a tax qualified defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Effective January 1, 2014, the Plan document was restated to incorporate all prior amendments, to comply with changes required by the Internal Revenue Service's ("IRS") 2012 Cumulative List of Changes in Plan Qualification Requirements and as required for a Cycle C submission for a determination letter, to further amend the Plan to make certain Plan design changes and to add or modify certain administrative provisions.

Effective January 1, 2025, the Plan merged with the Anchor Hocking 401k Plan. All assets were transferred to the new plan in January 2025.

##### Eligibility

All U.S. nonunion and union employees are immediately eligible to contribute to the Plan, provided they are a regular employee 18 years of age or older. Nonunion employees not normally expected to work more than 1,000 hours in a year are eligible to participate upon the earlier of the completion of 1,000 hours within the first 12 months of employment or upon completing 1,000 hours in any Plan year following.

##### Vesting

Participants are fully vested in their account for funds attributable to their own contributions, rollover accounts, and accounts transferred from other plans, plus actual earnings thereon.

Union participants at the Greencastle facility, Corning facility and union participants at the Charleroi facility are vested in their employer contribution account as follows:

All participants are 100% vested in their employer contribution accounts, regardless of years of vesting service if any of the following events occur while they are actively employed by the Company: attainment of normal retirement age, death, permanent disability, or termination of the Plan.

#### **Forfeitures**

Nonvested amounts are forfeited as of the earlier of the date of distribution of the participant's vested account or after the last day of the Plan year in which the participant incurs a five-year break in service. Forfeitures are used to reduce Company contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$121,492, respectively. During 2024, the amount of forfeitures used to reduce Company contributions was \$551,724.

#### **Participant accounts**

Individual accounts are maintained for each Plan participant. Each participant account is credited with the participant's contribution, required Company contributions, qualified rollover monies, and allocation of the Plan earnings and losses. Participant accounts are charged with an allocation of administration expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. In the event a participant fails to make an investment election with respect to all or any portion of his account subject to his investment direction, the trustee shall invest all or such portion of his account in the investment fund to be designated by the Plan administrator.

#### Payment of benefits

Upon retirement, death, total and permanent disability (as defined by the Plan), or termination of employment, the participant's benefit is generally paid in a lump-sum or in two or more partial payments of at least \$1,000; provided, however, that the final such payment may consist of the participant's entire remaining account balance, if less than \$1,000. A small group of participants are eligible for a group annuity option form of distributions. Under certain circumstances, a participant may withdraw a portion of the account balance during employment with the Company.

#### Hardship withdrawals

In the case of a financial hardship, a participant may receive a distribution not to exceed the lesser of the vested value of their account or the amount necessary to satisfy the financial hardship.

#### Notes receivable from participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest equal to the "Prime Rate" (as reported in *The Wall Street Journal* on the date the loan is initiated). Participant loans shall be treated as segregated investments, and interest repayments shall be credited only to the participant's account.

#### Contributions

Eligible union participants are automatically enrolled to contribute 5% of eligible compensation per payroll period if an affirmative contribution election was not made in the time prescribed by the Plan Administrator. Greencastle Union employees are automatically enrolled to contribute 7%. Eligible nonunion participants are automatically enrolled to contribute 6% of eligible compensation per payroll period if an affirmative contribution election was not made in the time prescribed by the Plan Administrator. Employees may contribute up to 50% of eligible compensation on a combined pre- and post-tax basis, subject to IRS limits. Participants may elect to invest their contributions or exchange funds among alternative investment options.

The Company is required to make various contributions based upon collective bargaining agreements and/or Plan eligibility for such contributions. Company contributions may include:

#### Employer matching contributions

Equal to a percentage of elective deferrals made by certain eligible union and nonunion employees during the Plan year. The amount of matching contribution varies by union and nonunion status.

#### Employer performance contributions

Based upon the Company meeting certain financial goals, performance contributions are discretionary for nonunion participants and certain union participants. The Company made performance contributions of \$293,604 for the year ended December 31, 2024.

#### Note 2 - Significant accounting policies

The following are the significant accounting policies followed by the Plan.

##### **Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results could differ from those estimates.

##### **Valuation of investments**

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### **Notes receivable from participants**

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### **Payment of benefits**

Benefit payments to participants are recorded upon distribution.

##### **Administrative expenses**

The Plan stipulates that administrative expenses may be paid by either the Plan or the Company. Forfeitures may also be used to cover administrative expenses.

##### **Subsequent events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and, other than disclosed in the accompanying notes, no material subsequent events have occurred.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued using the NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the funds, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no participant redemption restrictions for these investments, the redemption period is applicable only to the Plan.

#### Note 5 - Certified investments

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Trust Company, the trustee of the Plan.

#### Note 6 - Benefit-responsive investment contracts

The Plan holds a traditional investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. As of December 31, 2024 and 2023, the investment contract at contract value was \$28,189,455 and \$34,938,156, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be the lesser of 3% or a rate that is not less than 1% determined by using the six-month average of the five-year Constant Maturity Treasury Rate minus 1.25%. The crediting rate is reviewed every six months for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the "IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; and
5. Bankruptcy of the Plan sponsor and other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and

4. A material amendment to the agreements without the consent of the issuer.

#### **Note 7 - Federal income tax status**

The IRS has determined and informed the Company by a letter dated July 22, 2014 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and uncertainties**

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Related party transactions**

The Plan reimburses certain administrative expenses to the Company. During 2024, the Plan paid \$153,736 of administrative expenses to an affiliate of John Hancock Trust Company LLC.

#### **Note 10 - Service credit account**

The Plan has a service agreement with John Hancock Trust Company LLC to pay for administrative fees incurred by the Plan. Through this agreement, John Hancock Trust Company LLC earns fees through the Plan's investments in various funds. If the total fees earned by John Hancock Trust Company LLC through the various funds exceed a stated dollar amount, the excess is deposited into a Service Credit Account maintained by the Plan. The funds in the account may be utilized to pay for qualified plan expenses, reduce employer contributions or may be allocated to participant accounts on a pro-rata basis. During 2024, deposits to the service credit account totaled \$50,352. As of December 31, 2024 and 2023, there were no funds in the Service Credit Account.
