## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Employee Benefit Plan of Paradise Oaks Youth Services  
Citrus Heights, California

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Employee Benefit Plan of Paradise Oaks Youth Services, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Employee Benefit Plan of Paradise Oaks Youth Services' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United State of America.

### **Responsibilities of Management for the Financial Statements**



### NOTE 1 DESCRIPTION OF PLAN

The following description of the Employee Benefit Plan of Paradise Oaks Youth Services provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all full-time employees of Paradise Oaks Youth Services, Inc. (Company) who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan not to exceed certain IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 24 investment options through Voya Retirement Insurance and Annuity Company (Voya). The Plan does not provide for a safe harbor match of employee contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Plan earnings and charged with an allocation of certain administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting and Forfeitures

Participants are immediately vested in their contributions plus actual earnings thereon. Total forfeitures allocated to participant accounts during the year ended December 31, 2024 was \$0.

#### Participant Loans

Participant loans are not permitted from the Plan.

#### Payment of Benefits

On termination of service, a participant may elect to receive a distribution equal to the vested portion of their account balance at the date of termination. The elections available are a lump sum distribution or an installment distribution. Terminated participants' whose account balance is less than \$1,000 receive an involuntary cash out distribution. Distributions are paid as soon as administratively practicable after the participant terminates. In the event of a participants' death, his or her designated beneficiary will be paid in accordance with the terms of the beneficiary designation form. Hardship withdrawals are permitted from this Plan.

### NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Payment of Benefits

Benefits are recorded when paid.

#### Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Administrative Expenses

Certain expenses to maintain the plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### Date of Managements Review

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

### Tax Status

On March 31, 2014, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan is amended to comply with recent legislation as necessary, the Plan administrator believes that the Plan as designed is being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. There is no effect on the financial statements based on this evaluation. The Plan administrator believes the Plan is subject to examination for the preceding three (3) years.

### NOTE 3 INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company (voya) as and for the year ended December 31, 2024.

### NOTE 4 PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya. Voya is the custodian and recordkeeper for the Plan, and therefore, these transactions qualify as party in interest transactions.

### NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### NOTE 6 UNALLOCATED INSURANCE CONTRACTS

Unallocated insurance contracts are traditional investment contracts which are guaranteed and are stated at contract value. The contracts are invested in Voya's general account and are invested in accordance with Voya's general account investment policy. Voya is obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is declared prior to the beginning of a calendar year and is applicable to all contributions received in that year. In no event shall the crediting interest rate be less than 1.0%.

### NOTE 7 FAIR VALUE MEASUREMENTS

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or by other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan's investment consists of a variable annuity contract with a fixed option investment or a variable investment option. The annuity contract is considered a level 2 asset.

Under the fixed option investment, funds are placed in Voya's general account where they are invested in accordance with Voya's general account investment policy. The objective of that investment policy is to maximize long-term, risk-adjusted returns. The fixed option investment value is equal to the principal invested plus accrued interest earned. An interest rate is declared prior to the beginning of each calendar year and is applicable for that year until the new rate is set for the next calendar year. As the inputs are observable, the fixed option investment is considered a level 2 asset.

Amounts allocated to a variable investment account are credited to a participant's account. The value of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares of the underlying investment. Each investment account is invested by Voya exclusively in shares of a specific mutual fund as directed by the participant. As the inputs are observable, the variable investment option is considered a level 2 asset.
