Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Legacy Healthcare Services, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Legacy Healthcare Services, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Legacy Healthcare Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants in the Plan should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on July 1, 1988 as a discretionary corporate profit sharing and trustee 401(k) salary reduction plan. The Plan covers all non-union, resident employees of Legacy Healthcare Services, Inc. who have reached age 18 and have 30 days of employment. Effective January 1, 2024, the Plan was amended to remove the age and service requirements from plan entry. Effective March 1, 2023, the Plan added an adopting employer, Legacy Healthcare Services Massachusetts, LLC. In accordance with Internal Revenue Code ("IRC") Section 414(b), Legacy Healthcare Services, Inc. and Legacy Healthcare Services Massachusetts, LLC (collectively, the "Company") are a controlled group of corporations whereby all employees of each company shall be treated as employed by a single employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may elect to defer up to 80% of their pretax compensation into the Plan, up to the maximum percent allowed by the Internal Revenue Service ("IRS"). Effective January 1, 2024, the Plan was amended to allow participants to elect after-tax ("Roth") contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan permits rollover contributions from other qualifying retirement plans. Participants may direct the investment of their contributions into various investment options offered by the Plan. The Company may elect to contribute a discretionary amount determined each year by the Company. For the year ended December 31, 2024, the Company elected to contribute 100% of the first 2% of an employee's eligible compensation that a participant contributed to the Plan, paid subsequent to year end.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of plan earnings and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective contributions to the Plan. Vesting in the Company's match and discretionary contributions is based on years of credited service. Participants are fully vested after completing five years of credited service.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$164,531. These accounts, at the discretion of the plan sponsor, may be used to pay future contributions of employer match by the Company or to pay administrative expenses. The Plan used forfeited accounts subsequent to year end to reduce the employer matching contribution.

1. Description of Plan (Continued)

Payment of Benefits

Generally, the participant becomes eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. For retirement, death or disability, the participant may choose to receive all of their account balance in a lump sum or in an annuity contract. Early retirement is permitted for participants who have attained age 55 and have five years of credited service. Participants who terminate their employment will receive their vested account balance in a lump sum payment. Active employees are permitted to receive in-service payments as long as the employee is 59 ½ years of age or older.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their elective contributions for immediate and severe financial need. In accordance with IRS regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of 50% of their vested account balances, reduced by any outstanding loan balance, or \$50,000, reduced by the highest outstanding loan balance during the previous 12 months. A participant can only have two loans outstanding at a time. The loans are secured by the balance in the participants' accounts and bear interest at a fixed rate set at the Prime Rate plus 2% (9.50% at December 31, 2024) as of the date of the newly issued loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants were \$287,652 and \$200,969 at December 31, 2024 and 2023, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are comprised of pooled separate accounts, mutual funds, collective investment trust funds (“CIT”), and a fully benefit-responsive investment contract (“FBRIC”). The Plan’s investments are reported at fair value except for the FBRIC which is reported at contract value (see Note 8). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in pooled separate accounts and CITs are valued using the Net Asset Value (“NAV”) as a practical expedient. See Notes 6 and 7 for additional discussion of fair value measurements of these investments.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in value of investments are allocated to participant accounts based on participant holdings in each fund.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain plan expenses are paid by the Company as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant’s account.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

3. Federal Income Taxes

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. Plan management believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

3. Federal Income Taxes (Continued)

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by Principal Financial Group ("Principal"), the custodian of the Plan, and was not subject to audit for the years ended December 31:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

6. Fair Value Measurements (Continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There were no Level 2 or 3 investments in the Plan.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

7. Collective Investment Trust Funds

The CITs are maintained by Principal Global Investors Trust Company (“Principal Global Investors”) and seek a total return consisting of long-term growth of capital and current income. Investment transactions are accounted for and recorded on a trade-date basis and dividend income is recorded on the ex-dividend date. The funds’ interest in affiliated collective trusts and separate accounts may be redeemed as of any valuation date. Principal Global Investors may elect withdrawals in cash, ratably in-kind, a combination of cash and ratably in-kind, or in any other manner determined to be appropriate. Unitholders may redeem units, but the units may not otherwise be transferred without the consent of Principal Global Investors. There were no unfunded commitments.

8. Investment Contract with Insurance Company

The Principal Fixed Income Guaranteed Option is a guaranteed general account backed group annuity contract (“GAC”) that has been issued by Principal Life Insurance Company (“Principal Life”). The contract provides a fixed rate of interest which was 1.55% at December 31, 2024. Benefit payments are made at book value (i.e. no termination or surrender charge adjustments) for plan benefit events and investment transfers initiated by plan participants. Thus, this contract is considered benefit-responsive. The contract is included in the financial statements at contract value as reported to the Plan by Principal Life. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

8. Investment Contract with Insurance Company (Continued)

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

9. Party-in-Interest Transactions

Plan investments are managed by Principal. Principal is the custodian as defined by the Plan. These transactions qualify as party-in-interest transactions. Fees paid to Principal and other parties-in-interest for contract administration, advisory and professional services amounted to \$149,091 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 25, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective starting at and various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
